Resolution No. 384: Amending The 2021 Ulster County Budget To Use American Rescue Plan Act (ARPA) For COVID-19 Related Expenses – Emergency Management

Resolution Summary: This resolution amends the 2021 Budget to allocate \$407,761 in American Rescue Plan funding to the Emergency Management/Emergency Communications Department to offset COVID-19 related expenses.

Deputy Executive Milgrim stated that the items in the Resolution before the committee are not eligible for FEMA reimbursement; medical supplies and personnel costs. Chairwoman Walter asked if that was intentional and if there are other items that are FEMA reimbursable to be applied for in the future. Deputy Executive Milgrim responded that there were many other items which met the FEMA criteria. He added that the FEMA reimbursement timeline is significantly longer than the ARP process. Chairwoman Walter asked if a list of ARP and FEMA qualified items could be supplied to the Ways & Means Committee. Director Erichsen stated that the FEMA application is broken down into categories. Deputy Executive Milgrim stated that they had summaries of ARP allowable expenses.

Resolution Summary: This resolution establishes a policy to identify county positions that work directly with crime victims and persons accused of crimes, including, but not limited to: all job titles, including vacant positions, in the county with responsibilities relating to the administration of criminal justice services, and positions that work directly with crime victims and persons accused of crimes, in the County Departments of Probation, Public Defender and Conflict Administrator, and in the Elected Offices of the District Attorney, and Ulster County Sheriff

She stated that 423 then request the Executive to offer Restorative Justice trainings to those individuals.

She advised the members that the Department heads and elected officials referenced support the policy. She added that the training is already offered by Family of Woodstock, so there shouldn't be any added cost.

Resolution No. 424: Establishing A Policy Requiring An Ulster County Crisis Stabilization Center, And Requesting The Initiation Of The Procurement Process To Secure Services For Individuals Experiencing Mental Health And/Or Substance Use Crisis

Resolution Summary: This resolution establishes a policy to have a Crisis Stabilization Center which operates 24 hours/day, 7 days per week, with sufficient staffing including: administrative staff, credentialed alcohol and substance abuse counselors (CASAC), social workers and/or otherwise licensed counselor, case managers, and certified recovery peer advocates (CPRA); with priority given to individualized with personal lived recovery experience for mental health illness or substance abuse.

Resolution No. 425: Establishing A Policy Requiring Respite Houses In Ulster County, And Requesting The Initiation Of The Procurement Process To Secure Services For Individuals Seeking Mental Health And/Or Substance Use Recovery Assistance

Resolution Summary: This resolution establishes a policy to have 7-10 day Respite Houses in Ulster County, geographically spread out across the county, providing a minimum of eight beds overall, available to any resident of Ulster County ages 18 years old and over, with staffing for each home to include: administrative staff, crisis specialists, case managers, and administrative support.

Resolution No. 426: Amending The 2021 Ulster County Budget To Create A Professional Standards Supervisor Position – Sheriff's Office

Resolution Summary: This resolution creates a full time Professional Standards Supervisor position in the office of the Sheriff at an estimated annual salary of \$85,838 to: oversee audits, quality assurance, and policy for that office and its members, conduct team inspections, uphold the Sheriff's Office Code of Conduct and investigate and claims of violation.

Resolution No. 427: Amending The 2021 Ulster County Budget To Create A Crisis Intervention Team Manager Position – Sheriff's Office

Resolution Summary: This resolution creates a full-time Crisis Intervention Team manager position in the office of the Sheriff at an estimated annual salary of \$50,865 to: oversee crisis intervention trainings, including de-escalation and peer-to-peer mental health support trainings, evaluate and recommend potential revisions in law enforcement policy, create, implement, and regularly evaluate a triage diversion plan for individuals presenting with a mental health crisis to law enforcement.

Legislator Fabiano asked what the duties of the professional standards position would be. Sheriff Figueroa responded that the responsibilities are currently collateral duties of a Lieutenant. He advised the members that the person would be responsible for internal affairs, equal employment opportunity compliance with new laws, reviewing FOIL files, conducting audits. He added that the person will not be affiliated with any unions and will be independent. He stated that he feels strongly that the person who does internal affairs should not a member of the union and that the work should not be a collateral duty.

Resolution No. 428: Amending The 2021 Ulster County Budget To Create A Criminal Justice Discrimination Support Referral Specialist – Human Rights Commission

Resolution Summary: This resolution creates a part-time Criminal Justice Discrimination Support Initiative Referral Specialist position in the Human Rights Commission Budget at an estimated annual salary of \$23,894 to provide a support and referral system for community members who feel they have been discriminated against in our criminal justice system.

Chairwoman Walter stated that she had the same intention as the previous resolutions to take no action and reevaluate once it is known whether the position was included in the 2022 budget. Legislator Haynes asked what was seen that would warrant the creation of an additional position. Chairwoman Walter responded that the Human Rights Commissioner advised the CJRTF that he receives many calls from people who feel they have wronged in some way but is not related to a human right violation. She added that the HR Commission is not a referral unit but is spending a lot of time directing people on hoe to handle their issue. She added that the other part was a concern that people don't know what to do when they have a concern with the Sheriff's Office vs. the District Attorney vs. a judge, etc.

Legislator Haynes stated that she answers numerous calls of a similar nature at her full-time job and asked how many calls they have been receiving. Chairwoman Walter stated that the person would be well trained on the different processes for filing complaints against the different facets of the criminal justice system. Sheriff Figueroa stated that there was someone who wanted to file a complain against the Sheriff's Office, but was uncomfortable going to the Sheriff's Office because they were afraid of law enforcement. He added that a person like that would benefit from an intermediary.

Chairwoman Walter advised the members that the Task Force also recognized that the position could direct individuals to community restorative Justice services as well. She asked if there were any further questions.

Resolution No. 431: Requesting The Initiation Of The Procurement Process To Secure Re-Entry Services For Individuals Serving Time In The Ulster County Jail

Resolution Summary: This requests the County Executive, in consultation with the Ulster County Sheriff, develop and initiate the request for proposals (RFP) procurement process to contract for the implementation and provision of re-entry services to Ulster County jail inmates including creating discharge plans that connect incarcerated people to housing, mental health treatment, and jobs prior to release; and increasing job training programs to upskill incarcerated people and connect them to jobs upon release.

Chairwoman Walter asked if the Sheriff would like to speak to the initiative. Sheriff Figueroa stated that the current reentry services are limited to when an inmate leaves but does not follow them after. He added that this initiative can help to reduce recidivism, which is an important component in investing in people. Chairwoman Walter stated her hope that the Sheriff would be included in the discussions and development of the RFP.

She advised the members that Family of Woodstock applied to NIH for a grant to offer these services but added that the grant is super competitive and may take months before they hear about the award. Legislator Haynes asked if there were pilots in other areas that were successful that could be duplicated. Chairwoman Walter stated that this type of reentry program currently exists in the state prison system. Sheriff Figueroa said they try to work with inmates while they are in the jail, but once the person leaves, there is no follow up. Legislator Haynes stated she supported the idea.

The members briefly discussed possibilities if Family did receive the NIH grant and the differences between inmates in county jails vs state prisons. The members agreed that any time spent in county jail is a red flag that an individual is in need of some sort of help or service.

Hearing none she advised the members that Legislator Parete sent an email apologizing for missing the meeting and stating that he had a commitment from the NYS Crime Commission to participate in the round table discussion, and he would have a draft letter and list of invitees for the next meeting.

Chairwoman Walter advised the members that the resolution previous discussed for introduction for the initiative to identify individuals at risk of committing violent acts would not be introduced as the Sheriff and Executive recently announced the AVERT program which seeks to do just that. She asked if that was going to be part of the 2022 budget. Sheriff Figueroa stated that he had gotten together with the Executive and City of Kingston Police Department to start the program. Legislator Fabiano stated his support or the program and asked if the program would be started in 2022. Sheriff Figueroa responded that parts of the program are already being worked on/in place.

Chairwoman Walter stated that the second resolution previously discussed for introduction was funding for the Ulster Prevention Council for community level responses to violence in Saugerties, Ellenville and New Paltz. She advised the members that she had reached out o Cheryl DePaolo at Ulster Prevention to ask for her input on how the plan would work, how much it would cost, what UC Prevention would need, etc. and she had not heard back from her yet. She said she would follow up, adding that it likely would not materialize until 2022.

She asked the members if there was any other business, and hearing none;
