Ulster County Probation Department Program/Division Descriptions

Probation

Probation is designed to provide juveniles and adults in the community with guidance and services to assist them in leading productive and crime-free lives. Supervision may include the collection of court-ordered restitution and payment to victims of crime, participation in cognitive behavioral interventions, engagement in employment readiness training and the use of incentives for program completion and graduated sanctions in response to non-compliant behaviors. We provide investigations and reports for the criminal, Family and Youth Part courts within the county; supervise persons sentenced or placed on probation; collect restitution; conduct intake of Family Court matters (such as Juvenile Delinquency and Persons in Need of Supervision); provide adjustment and diversion services, voluntary supervision and case planning; and monitor Ignition Interlock Device compliance for those on probation supervision.

Ulster County Probation utilizes NYS Division of Criminal Justice Services GIVE funding to support a portion of two Probation Officers who have specialized Domestic Violence caseloads. All intimate partner domestic violence cases sentenced to probation countywide and some placed on pretrial release are assigned to these experienced Officers. We are a member of the team implementing the Intimate Partner Violence Intervention program with the District Attorney's Office. This program began with the City of Kingston and is expanding to Saugerties in July 2020. When we received this funding, we were able to go from one specialized caseload to two caseloads with reduced numbers allowing for more effective supervision and rehabilitation efforts.

We have other specialized caseloads and services for persons on probation for sexual offense convictions.

We have offices in Kingston, Saugerties, Ellenville and New Paltz.

Probation is different than Parole. Probation is a county department that provides interventions early on to reduce recidivism, assist juveniles and adults receive help to prevent further engagement in the problematic behavior. It is often offered prior to or in lieu of incarceration or detention/placement. Parole is part of the state agency, DOCCS, and occurs after a prison sentence or more than 1 year.

Pretrial

The Pretrial Release Program was created to save the cost of housing someone in the jail prior to conviction. Over the years and with bail reform it has become a way to release a defendant, rather than setting bail, to be monitored in the community while their case is pending. The program is available to the local courts and Ulster County Court to provide supervision including electronic monitoring when ordered by the court. In addition to receiving cases directly from court, Pretrial staff screen all persons who are admitted to the jail, interview those who are candidates for pretrial release and provide release recommendations to the court. When someone is released to pretrial by the court, the pretrial unit provides supervision, which may include referrals to appropriate service agencies and notifies the defendant of all court dates to increase the likelihood that the person appears in court. They update the court on progress and maintain supervision until disposition of the case or when the person is released from supervision for some other reason.

CVAP: Crime Victims Assistance Program

CVAP provides help to victims of crime, including domestic violence, rape, sexual assault, homicide, assaults and other violent crime. We are the Department of Health approved Rape Crisis Program for the county. CVAP responds to all sexual assault cases at Kingston Hospital and assists the Sexual Assault Nurse Examiner with

this process. CVAP maintains a 24-hour crisis hotline and runs a volunteer program to assist our unit with coverage of this hotline. We maintain a legal services grant to provide free civil legal services to crime victims including Family Court and immigration assistance. We have recently started overseeing the Safe Harbour Program and have been working to expand services to trafficking victims. We have 11 Counselors, an Assistant and a Supervisor in that unit which is located in a separate building from the Probation Offices.

All services of the CVAP program are free and confidential. We assist victims whether or not charges are filed. We provide crisis intervention, emotional support and short-term counseling, accompaniment to hospitals, SANE exams, police and courts, advocacy with police, courts and District Attorney, information and follow-up on case status in Criminal and Family Courts, help with arrangements for Domestic Violence shelters, assistance in filing a claim with the NY State Office of Victims Services for reimbursement of medical and counseling costs, lost wages, moving expenses and funeral expenses, referral to other agencies, facilitation of support groups, Victim Impact Statement writing assistance, working with IPVI program to assist DV victims and offering immediate outreach.

Our **Sexual Assault Crisis and Prevention Program** connects school aged adolescents, adults and community members with counselors to learn about sexual violence, cyber abuse, the rights survivors of sexual violence have, how to support someone who has experienced sexual violence and to serve as a platform to raise awareness of our program. Adolescents learn about gender roles, clearly defining who is responsible for sexual violence (the perpetrator) and what their rights are around accessing medical care after experiencing sexual violence. This is a vital program in changing the narrative about sexual violence and changing our history so that we can put an end to boy/men, girls/women, and children having to raise their voice to say "Me Too." We provide a Bystanders intervention program (UCBASA), Cyber Safety 101, Sexual Assault Support Groups and Trauma-informed yoga - free to the community.

"Enough is Enough" legislation was signed into NYS law in 2015 to put an end to sexual assault on college and university campuses. This action mandated all colleges and universities across New York State to adopt a set of comprehensive procedures and guidelines, a uniform definition of affirmative consent, a statewide amnesty policy, and expanded access to law enforcement. With this law, the goal is to ensure that all colleges and universities fulfill their obligations to protect students from sexual assault, dating violence, intimate partner violence and stalking, along with taking every measure to properly investigate allegations of sexual assault on campus. NYS funded our program to provide assistance to the college campuses with prevention and direct service to victims. CVAP's Enough is Enough Program currently supports SUNY New Paltz and SUNY Ulster by providing on-campus, trauma informed, confidential response resources. This includes: 24-Hour crisis hotline, short-term counseling, accompaniment to sexual assault forensic exam, advocacy for victims in Conduct and Judicial Process, information on Office of Victim Services (OVS) Reimbursement, referrals for other services, and support groups. We work with the colleges to administer comprehensive student on-boarding and ongoing education campaigns regarding the institution's prohibition on sexual and interpersonal violence, relevant definitions, the role of the Title IX Coordinator/University Police/Campus Security, awareness of violence and its impact on survivors, evidence-based bystander intervention materials, and explanation of consequences/sanctions for individuals who commit sexual or interpersonal violence.

STOP DWI

The STOP-DWI Program (Special Traffic Options Program for DWI) seeks to reduce the incidence of drunk and/or drugged driving deaths and personal injury crashes. The program is funded with fines paid within Ulster County by those convicted of Driving While Intoxicated, Driving While Ability Impaired and Driving While Ability Impaired by Drugs.

The program funds prevention efforts such as public service announcements, presentations at school health fairs, prom and graduation events, law enforcement task force patrols, prosecution, community supervision and administrative staff. The program monitors Ignition Interlock Device (IID) compliance for those who receive a Conditional Discharge with IID conditions.

Raise the Age

The New York State Fiscal Year 2017-18 Budget included legislation to "Raise the Age" (RTA) of criminal responsibility to 18 years of age. The law change was effective 10/1/2018 for 16-year-olds and 10/1/2019 for 17-year-olds. Counties were tasked with creating a comprehensive plan to add staffing and programming to reduce reliance on detention and out of home placements; increase the rates of probation adjustment (diversion); reduce the need for Family Court adjudication; arrange for community-based services to improve outcomes for youth; reduce the rate of probation violations and reduce long term recidivism rates.

Ulster County's plan included the creation of the **Restorative Justice and Community Empowerment Center (RJCEC)**, the addition of a Youth and Family Engagement Coordinator and Assistant, a Probation Supervisor, and four Probation Officers. An RFP process resulted in programming to be offered at the RJCEC. Staff provide case planning and individualized services to meet the needs of clients. Much work went into creating a system in which youth and families can access staff and resources to meet their needs. The Coordinator also provides programming to at risk youth and develops programming and events to be held at the RJCEC. She meets regularly with our provider of Restorative Justice services, reviews these referrals and the progress. She is also assisting County agencies in getting trained about Restorative Justice.

Community Service Program

The Community Service program provides courts with a community-based alternative to incarceration that reduces unnecessary reliance on incarceration. We screen and identify individuals appropriate for completing community service. Staff transport and oversee clients performing community service. The program works to ensure that individuals ordered by the court to complete the prescribed hours of community service do so and report the completion of community service to the court. Clients, staff and the community benefit from the service that is provided to nonprofits and municipalities. Service sites range from rail trail beautification to painting and assistance at food pantries.



- Obtain information by listening to the responsible parties' account of what happened in order to understand underlying reasons for the act as well as an opportunity to ask clarifying questions

- Be recognized and participate as secondary victims - attention to their feelings as concerned community members
- Be empowered to be part of the decision-making process regarding what will happen next and how to deal with the aftermath of the incident
- Build community responsibility by providing opportunities to (re)build a sense of community and mutual accountability

From Shirth

The Vendor's Regional Manager responsible for services under this Agreement shall have no less than six (6) year's Correctional Food Service experience.

- b. The Vendor's Food Service Director shall possess a minimum of three (3) years' experience, or a combination of formal training and experience equivalent to three (3) years' experience, in the use of materials, methods and equipment used in preparing food for an operation like that of the Jail.
- c. Should a vacancy or absence occur the Vendor shall provide temporary staff or overtime to cover the vacancy or absence. In the event of a vacancy the Vendor shall permanently fill the vacancy with an employee possessing the same qualifications within two weeks. The Vendor shall reimburse the County at the rate of two times the hourly rate for vacancies or absences not covered by temporary staff or overtime. The Vendor shall provide work schedules with each invoice identifying shifts worked, shifts covered by other employees due to vacancies/absences and unfilled shifts. Notwithstanding the foregoing, Vendor shall not be required to reimburse the County for staff vacancy so long as the position is covered by overtime or a qualified temporary worker.
- . The County employs one (1) full time cook for the Officers Dining Room. The Vendor shall utilize the County's cook in providing services. Payroll for the County's cook shall be the responsibility of the County. The Vendor shall supervise the County's cook. The Vendor shall be responsible to cover the County cook's time off, i.e. vacations, sick days, etc. with the Vendor's paid employees. Upon retirement of the County's Cook, the Vendor shall provide an additional cook, at their sole expense. The Vendor may request a per meal increase should the County's cook retire during the term of this Agreement adequate documentation of the Vendor's increased cost shall be provided to the County.
- 4. The Vendor may utilize up to fourteen inmates per shift for food preparation, to serve/tray line meals and perform sanitation and cleaning of the kitchen and equipment. The Vendor shall submit a list of the staffing positions, detailing labor descriptions and requested times to the Sheriff. All inmate labor shall be subject to the approval of the Sheriff. The Vendor may at its discretion assign or reject any or all inmates on any given shift, at any time. The Sheriff will require the Vendor to use the Sheriff's administrative procedures for the discipline of or removal of inmates from any kitchen. Kitchen inmates will not be permitted to ride in any Contractor's Vehicle at any time.

The Sheriff shall be entitled to remove any or all inmate(s) at any time from kitchen or food service assignment if, in his discretion, the inmate(s) presence poses or creates a security risk. The Vendor shall indemnify and hold harmless, Ulster County, its officials, officers, employees and agents from and against all liability for loss, costs, damages, injuries and claims which may result from the Vendor's use of inmates in the food service operation at the Jail when such liability is attributable to any act of negligence or omission by the Vendor, its officers, employees, agents, consultants, subcontractors, owners, or shareholders.

B. Compliance and Staff Training

- The Vendor at its own expense shall require its employees to submit to annual health examinations in accordance with all federal, state and local laws, rules and regulations and as mandated by American Correctional Association (A.C.A.) Standards. The Vendor shall make all records evidencing the Vendor's compliance with these requirements available to the County upon request.
- 2. One week prior to starting work the Vendor shall submit completed criminal history and background information forms to the Sheriff's Department for all employees and subcontractors providing services related to this Agreement. All Vendor's personnel authorized to work under this Agreement are subject to photographing, fingerprinting and a criminal security check performed by the County. The Sheriff reserves the right to deny the Vendor's employees access to the Jail at any time for any reason. Should an employee be denied access by the Sheriff, the Vendor shall replace them immediately. Persons not previously screened for admittance shall not be admitted to the Jail without proper notification by the vendor and authorization from the Sheriff.
- 3. The Sheriff reserves the right to require visible tattoos to be covered while in the Jail.
