Resolutions for the April 16, 2019 Session of the Legislature

Deputy Chair Roberts advised the members that he would be taking Late Resolution No. 172 out of order as Department of Social Services Commissioner Iapoce was in attendance to answer any questions.

LATE Resolution No. 172: Authorizing The Chair Of The Ulster County Legislature To Execute Intermunicipal Agreements With The Town Of Saugerties And The Village of Ellenville To Provide The Services Of Domestic Violence Investigators To The Ulster County Family And Child Advocacy Center And Amending The 2019 Budget – Department Of Social Services

Resolution Summary: This resolution authorizes the Chair to execute intermunicipal agreements with the Town of Saugerties and Village of Ellenville to provide Domestic Violence Investigators to the County Family and Child Advocacy Center.

Discussion:

Deputy Chair Roberts recognized Commissioner Iapoce and asked him to speak about the Resolution. Commissioner Iapoce thanked the members for the opportunity to address the committee. He explained that the Resolution addresses staffing issues that have been encountered at the Family and Children Advocacy Center (FCAC). He informed the members that there was a shift from recruiting law enforcement personnel from the municipal police departments, because of a reduction in OCFS funding, to hiring retired law enforcement personnel through the District Attorney's Office. He stated that they have been operating under this model since 2014, but added that the retirees are being presented with other opportunities, many times in schools, and are no longer available. As a result, they have returned to the model of recruiting officers from municipal police departments. The agreement presented requires DSS to pay for a portion of the officer's salary with the rest made up by the local department. He informed the members that Saugerties and Ellenville have agreed to partner with DSS.

Legislator Ronk commented that the agreement is a great opportunity to partner with FCAC, adding that the officers receive valuable specialized training. He advised the members that the facility is set up to allow officers to interview child victims and/or witnesses in a non-traditional, less threatening setting. Commissioner Iapoce stated that Ulster's facility was one of the first established in the state and involves a multi-discipline approach.

Legislator Joseph Maloney asked if the law enforcement officer would be working full time for the FCAC. Commissioner Iapoce responded that they would be assigned to FCAC. He added that they had been spending on average \$75k per officer through the District Attorney's Office, and included that same amount in the current agreements. Saugerties and Ellenville have agreed to make up the differences to compensate the officers at their current salary and benefits. Deputy Chair Roberts asked if there were any other questions, hearing none he thanked Commissioner Iapoce for his time.

Resolution No. 481 of 2018: Establishing A Policy To Prohibit The Use Of Public Funds To Place The Likeness Or Name Of Elected Officials On All Ulster County Board Of Elections Material

Resolution Summary: This resolution establishes a policy to prohibit County elected officials from appearing by likeness, picture, or be named, or otherwise be identified or referenced on any Ulster County Board of Elections material, including but not limited to, signage, publications, mailings and the Board of Elections website.

Deputy Chair Roberts advised the members that some concerns were raised pertaining to language in the policy that may prohibit names of elected officials from appearing on ballots and asked for a motion to amend the policy to exclude being named on a ballot as a candidate for elected office.

Discussion:

Legislator Joseph Maloney advised the members that he has spoken with Deputy County Executive Rider a few times about the policy. He added that he estimated the cost for the Board of Elections to have an independently administered website could cost up to \$10k. He stated that he felt a policy would be more cost effective and will ensure compliance with state rules regarding publication of elected official's names. Deputy Chair Roberts advised the members that Commissioner Turco relayed that the Board of Elections is meeting with the Information Services Department the following Wednesday and would keep the members apprised.

Chairwoman Bartels stated that she supported moving forward with the policy the previous month, adding that the delay allowed them time to amend the policy to exempt certain election materials, such as sample ballots. The members discussed possible amendments and asked Counselors Pascale and Gordon for their recommendation for more comprehensive language. Legislator Nolan commented that the amendment language may require more time and consideration outside of the committee. She added that she did not support spending \$10k to fix a glitch. Deputy Chair Roberts stated that the resolution does not require the expenditure of \$10k or the use of an independent website. Chairwoman Bartels commented that she felt it was important to codify the policy.

Discussion:

Legislator Ronk stated that he was asked by the members at the previous meeting to put together a schedule of how the various terms would line up with Presidential, Gubernatorial and Local Elections. He stated that he would prefer a 2 year term if the choice was between 2 or 3 years, adding that a 2 or 4 year term should be what the committee debates. Legislator Nolan commented that she supported a 3 year term. Legislator Rodriguez stated that any movement from a 2 year term will create issues with post-census redistricting. He added that Greene County has 3 year terms and asked Legislative Staff to find out how long that has been in effect. Legislator Ronk stated that including local elections with national elections clouds the local nature of the work of the County Legislature. Legislator Rodriguez stated that he was not as concerned with local elections lining up with national elections. Legislator Joseph Maloney commented that in Ulster County district lines would not shift drastically during a post-census redistricting. He added that he supports a 4 year term. Legislator Ronk expressed his concerns with Legislators representing people that did not elect him or her if district lines are changed in the middle of a term.

Chairwoman Bartels asked if Legislative Staff could research how and when the Orange County Legislature became a 4 year term. She added that she supports a 4 year term, especially if term limits is enacted. Legislator Heppner stated that he supports the Public Hearing, adding that he is hesitant to support a 4 year term. He commented that Ulster County Voters should have the ability to change their government every 2 years. Legislator Ronk stated that he would like to move forward with the Public Hearing.

Discussion:

Legislator Ronk advised the members that he and Chairwoman Bartels had been discussing concerns raised with the term of office and how it would be calculated. The members discussed a number of concerns including failing to consider a hiatus between terms. Chairwoman Bartels stated that she favored the Dutchess County language "shall serve no more than three four year terms." Legislator Ronk stated that the original langue referenced full terms, but was amended to include the phrase "calculated."

Legislator Rodriguez stated that he was not sure all of the scenarios could be addressed at the meeting and suggested postponing the resolution a month. Legislator Ronk stated that he believed he had some suggestions to remedy the issues. He suggested replacing consecutive with complete or full terms. He advised the members there will be an issue in instances where an individual is elected to fill a vacancy in an office. Discussion ensued on the inclusion or exclusion of years served during an unexpired term in the 12 year limit. Legislator Joseph Maloney stated that he was not opposed to excluding that time.

Legislator Ronk suggested the following language to remedy the issue, "No person shall serve as ... for more than 3 full terms. The filling of an unexpired term shall not apply as a full term pursuant to this Local Law." Chairwoman Bartels stated her preference for the language in the Dutchess County Law and her support for passing the measure as a Local Law. She added that she supports asking the public for their thoughts at a Public Hearing. The members discussed whether the issue should or could be submitted as a permissive referendum. Legislator Rodriguez suggested holding off for a month to consider the changes. Legislator Heppner supported postponing the Resolution for a month to fully brief and discuss the changes to the law with their caucuses. Chairwoman Bartels agreed that the extra time would be helpful.

Legislator Joseph Maloney asked to be added as a main sponsor of the law. The members discussed enactment of term limits through a local law versus referendum and whether a referendum is legally allowable or possible. The members agreed that years served during an unexpired term should not be included in the 12 year limit. The members agreed that postponement would allow time to update the caucuses and allow Counsel to draft amendment language.
