Resolutions for the June 18, 2019 Session of the Legislature

**Resolution No. 281 of 2018**: Establishing A Policy To Prohibit The Use Of Public Funds To Place The Likeness Or Name Of Elected Officials On All Promotional And Informational Signage On County Owned Property

**Resolution Summary:** This resolution establishes a policy that no County elected official shall appear by likeness, picture, or be named, or otherwise be identified or referenced on any promotional and informational signage on County owned property, where same is paid for or produced in whole or in part with public funds of any kind including grant funds.

#### Discussion:

Chairman Donaldson reminded the members that the legislation is a policy not a law and is therefore more easily amended. Legislator Joseph Maloney stated that a member of the new County Executive's staff reached out to him to discuss three scenarios, none of which would have been effected by the policy. He added that the conversation supported his position that the policy would not greatly affect the county's ability to functionally distribute information. He stated that he also spoke with the Chairwoman and Clerk of the Legislature about concerns surrounding the County Directory and felt that the Resolution addresses those worries. Chairwoman Bartels suggested, and the members discussed, a few friendly amendments to the policy.

RESOLVED, that it is the policy of Ulster County that on and after the effective date hereof, no **currently serving** County elected official shall appear by likeness, picture, or be named, or otherwise be identified or referenced on any promotional and informational signage on County owned property, where same is paid for or produced in whole or in part with public funds of any kind including grant funds; and, be it further

RESOLVED, that this policy shall not apply to the appearance of an elected official's name and/or likeness on his or her office or his or her official web page, or in

any county directory, or to any promotional and informational signage on County owned property which is in existence prior to the effective date of this policy, and this policy shall not apply to appearances during a declared state of emergency or to appearances

otherwise required or permitted by law; and, be it further

#### Discussion:

Legislator Ronk informed the members that he and Chairwoman Bartels had met and reviewed the Proposed Law. He advised the members that a copy of the Law marked up by Chairwoman Bartels with comments from Counselor Pascale used during their review meeting was provided in the meeting materials. He stated that they identified a number of items that could be agreed on, some that should be discussed in committee and some that needed more time for additional investigation. The members reviewed the law page by page. The members agreed to a number of amendments and identified multiple areas that should be revisited.

Some discussion points included: the definition of gift, unemancipated child, editing the law throughout for gender neutrality, effective date and terms of new board members, service on the Board of Ethics by local elected officials/members of other boards, methods to make Board findings public and notification to supervisors/department heads, publication of unfounded accusations, recusal requirements, appearance of elected officials before county agencies or departments, exempted gifts, bidding on county owned real property acquired by tax sale, voting on collective bargaining agreements, amount of fines, and budget amendment for outside counsel.

Chairman Donaldson requested that Legislative Staff mark up the proposed law to reflect the agreed upon changes and highlight the areas to be revisited. He asked that Legislative Staff send the marked up version to the members for review in advance of the next meeting.

Resolution No. 267: Amending The Rules Of Order To Prohibit Personal Attacks

**Resolution Summary:** This resolution amends the Rules of the Legislature to require that any Legislature who engages in personal attacks or inflammatory comments directed at or about any named individual must yield the floor at the Chair's order.

Motion No. 8: Resolution No. 267 MOVED FOR DISCUSSION

## Discussion:

Legislator Ronk stated that the Rules currently protect Legislators from attacks on the floor of the Legislator, but not other elected officials or anyone else. He added that he felt the same protections afforded Legislators should either be extended to everyone who works in county government, or eliminated. He advised the members of a proposed amendment to make the language more consistent with current language. Legislator Joseph Maloney commented that the proposed Rules change was directed at him and comments he has made on the floor and stated that he did not believe his comments were personal attacks. The members debated First Amendment infringements versus decorum and respect, and the ambiguity of the proposed terms "attack" and "inflammatory."

Legislator Woltman stated that claims of criminal activity are consistently considered inflammatory in professional circles. Legislator Joseph Maloney said that he makes statements of fact on the floor and does not concede that stating facts should be considered an attack or inflammatory. Legislator Ronk stated that Legislator Joseph Maloney was not the reason, but maybe the impetus, for the introduction of the Rules change. He added that Legislative Chairs have, in the past, called for more respect and decorum on the floor during instances when persons other than Legislators have been named. He added that after the May Legislative Session the Rules were reviewed and as a result he and Legislator Woltman decided to introduce the change.
