Chairman Roberts recognized Legislator Rodriguez, sponsor of the Proposed Law. Legislator Rodriguez advised the members that he has proposed amending the fee section of the law to mirror the City of Kingston's fee schedule. He informed the members that research was conducted at the request of Legislator James Maloney regarding the cost to administer similar licensing laws in other jurisdictions. Legislator James Maloney advised the members that he supported proper and legal building, but felt that there was still a lot of questions as to the actual cost and logistics of administering the law in Ulster County. Legislator Rodriguez responded that at a certain point those details are considered operations and would be determined by the County Executive's Office. He added that the law establishes the policy and the licensing board and leaves budgeting and administration to the Executive. Legislator James Maloney responded that he would not feel comfortable moving forward with the law until a plan and an estimated budget is provided.

Resolution No. 337: Establishing A Policy To Prohibit The Use Of Recording Devices By Elected Officials And Personnel Of The County Of Ulster Without All-Party Consent

Resolution Summary: This Resolution establishes a policy prohibiting Ulster County Elected Officials and personnel from recording private communication transmitted by telephone, telegraph, radio or other device between two or more individuals by any County owned device, electronic, cellular or otherwise, designed to record and/or transmit said communication, unless the consent of all the participants in the communication is first obtained

Discussion:

Legislator Donaldson stated that New York State Law allows one party consent to make recordings which protects whistleblowers and individuals who are subjected to harassment in the workplace. He added that he was concerned the policy removes that protection from those vulnerable individuals. Legislator Rodriguez stated that the policy was specific to the use of county recording equipment and did not prohibit the use of personal recording devices. Legislator Donaldson responded that there may be occasions when an employee only has access to county equipment.

Chairman Roberts recognized Legislator Haynes for an amendment. Legislator Haynes recommended amending the second Whereas and first Resolved to add cellular to the list of covered devices. Resolution Sponsor Rodriguez considered the suggestion a friendly amendment and consented to the change. Legislator Nolan commented that the policy does not prohibit the use of county equipment if both parties are advised that they are being recorded.

Chairman Roberts informed the members that Counselors Barnett and Ragucci suggested amending the second Resolved to include the County District Attorney and his or her staff as exempted from the policy if recordings are required during the performance of their duties. Legislator Donaldson questioned whether the Public Defender should also be exempted. The members and counselors discussed whether including the Public Defender's Office is necessary. Legislator Rodriguez considered the suggestions to be friendly amendments and consented to the changes.

Amending The Rules Of Order To Permit Memorializing Resolutions

Legislator David B. Donaldson and Legislator Maloney (Joseph) offer the following:

WHEREAS, pursuant to Resolution No. 91 dated April 18, 2017, the Rules of Order of the Ulster County Legislature were amended to prohibit Memorializing Resolutions; and

WHEREAS, there is value to the Legislature, the County and the Ulster County residents in allowing the vetting of Memorializing Resolutions; now therefore be it

RESOLVED, that Rule 3. Resolutions, Local Laws, Rules For Procedure for Presentation and Consideration, Section C. Procedure for the submission and consideration of Resolutions in Committee, subsection (c) Memorializing Resolutions, is hereby amended as follows:

(c). Memorializing Resolutions. Any resolution which memorializes the New York State Legislature, Congress of the United States, or any other body to take an action which will not require a home rule message, shall be prohibited sponsored by at least one member from each caucus OR one Legislator less than the number of Legislators required to successfully execute a Petition to Discharge as required in Section 3. E. b. of these Rules of Order;

RESOLVED, that pursuant to Rule 2, entitled "AMENDMENT OF RULES," of the Rules of Order of the Ulster County Legislature, this resolution and the amendment proposed herein shall be read at two consecutive meetings of the Ulster County Legislature, and, be it further

RESOLVED, that this rule change shall take effect upon an affirmative vote of this body subsequent to two consecutive readings,

Establishing A Policy To Prohibit The Use Of Recording Devices By Elected Officials And Personnel Of The County Of Ulster Without All-Party Consent

Referred to: The Laws and Rules, Governmental Services Committee (Chairman Roberts and Legislators Donaldson, Haynes, Heppner, and James Maloney)

Minority Leader Hector S. Rodriguez offers the following:

WHEREAS, pursuant to 18 United States Code § 2511(2)(d) and New York Penal Law § 250.05 telephonic and in-person communications may be recorded provided at least one participant in the communication consents to the recording; and

WHEREAS, except as otherwise governed by New York Open Meetings Law, the Ulster County Legislature hereby determines that the public benefit is better served if notice and consent of the use of recording devices by Ulster County Elected Officials and personnel is given to all parties when County recording devices of any kind are being used in any communication, including but not limited to telephonic, online, cellular, and in-person communication to telephonic and inperson communication; now, therefore be it

RESOLVED, that Elected Officials and personnel of the County of Ulster are hereby prohibited from recording private communication transmitted by telephone, telegraph, radio or other device between two or more individuals by any **County owned** device, electronic, **cellular** or otherwise, designed to record and/or transmit said communication, unless the consent of all the participants in the communication is first obtained; and, be it further

RESOLVED, notwithstanding any other section herein, this policy shall not apply to recordings by law enforcement officials, the District Attorney and personnel of said office, and the Public Defender and personnel of said office during the course of their official duties; and, be it further

RESOLVED, notwithstanding any other section herein, communications or conversations of an emergency nature, such as reporting of a fire, medical emergency, crime or disaster may be recorded with the consent of one party to the conversation; and, be it further

RESOLVED, notwithstanding any other section herein, all public meetings and events conducted by Ulster County Elected Officials and personnel shall be presumed to be open to recording and shall be exempt from specific notification requirements; and, be it further
