Resolutions for the July 20, 2021 Session of the Legislature

**Resolution No. 283:** Setting A Public Hearing On Proposed Local Law No. 3 Of 2021, A Local Law Amending Local Law No. 7 of 2014, A Local Law Respecting the Outdoor Restraint of Companion Animals, To Be Held On Tuesday, July 13, 2021 At 6:00 PM

**Resolution Summary:** This resolution sets a Public Hearing to provide the public the opportunity to offer comments on Proposed Local Law No. 3 of 2021 on Tuesday, July 13<sup>th</sup> at 6:00 PM.

#### Discussion:

Chairwoman Bartels advised the members that the RFB for asbestos abatement at Enterprise West that was requested at the previous special meetings was received and circulated. She added that she was told that the abatement was for occupied areas, but supporting documentation, including a site plan/map showed that at least some abatement would be occurring throughout a large portion of the building, with the most significant abatement occurring in the tenant area.

Legislator Heppner thanked the Chair for organizing the special meetings and facilitating the ore in depth discussions on the Board of Elections as well as county space/facility needs. Chairwoman Bartels advised the members that changes to the lease that were approved by the Legislature at the June Session was not included in the lease presented. She asked if Legislative Counsel Ragucci could speak to the omission. Counselor Ragucci stated that he was not sure why the language was omitted and offered to reach out to the County Attorney. Chairwoman Bartels asked the members for their feeling on re-inserting the language. Legislator Roberts asked Deputy Executive Milgrim whether he knew if the omission was an oversight.

The members discussed whether the previously approved amendment would need to be withdrawn. Chairwoman Bartels advised the members that the lease before them contained additional changes and suggested re-inserting the previously approved language. Counselor Ragucci stated that he saw no legal impediment to re-inserting the language. Chairwoman Bartels mentioned that the language in the Resolution mirrors the proposed lease amendment language. She asked Counselor Ragucci to reach out to the County Attorney for his support.

Legislator Gavaris stated that he did not fully support the language because he felt it may encourage an extended stay at the new facility rather than continuing to search for a county-owned location for the Board of Elections. Chairwoman Bartels agreed and thanked the Comptroller for the space study she recently shared. She added that she hopes the lease is not renewed, and that the county pursue a full space study.

Motion No. 3: Motion to AMEND LEASE to reinsert language in Article 1: Premises,

Term & Rents, Section 1.03, previously adopted at the June Legislative Session "The lease may be renewed by the Ulster County Legislature, at its sole discretion, with written notice to the lessor, for one or two terms not exceeding five years each with annualized payment escalators tied to

an agreed upon and commercially recognized pricing index."
