**Resolution No. 7:** Setting A Public Hearing On Proposed Local Law No. 2 Of 2023, A Local Law Designating **Affordable** Housing As An Ulster County **Public** Purpose, To Be Held On Tuesday, March 14, 2023 At 7:15 PM

## **Discussion**:

Legislator Ronk stated that he believes housing is a local zoning and planning issue, adding that subsidized housing is not the only answer to the county's housing problem. He added that many towns have gone to large acre zoning which discourages housing development, among other town action that makes multiple dwelling structures difficult. Legislator Uchitelle stated that he felt the law aligns well with the concerns expressed by Legislator Ronk. He commented that the law sets up the county to provide a carrot to the towns to encourage them to make changes to zoning and other laws to provide for housing development.

Legislator Ronk stated that he had concerns that the law only refers to affordable housing, adding that young new professionals will not qualify. Legislator Uchitelle responded that he would have taken the reference out but was advised by the Planning Director that the inclusion was necessary to align with state housing laws. Legislator Gavaris echoed Legislator Ronk's concerns adding that the law was a public sector solution to a problem created by the private sector. He added that local zoning is the biggest challenge, noting that Wawarsing has 5 acre zoning, which has precluded developers from creating multi dwelling housing units. Legislator Uchitelle responded that he was excited to work together rto use the legislation to motivate the towns to change zoning laws. He added that if the local municipalities were responsible for providing temporary housing as is the DSS responsibility, he believed zoning laws would be changed immediately.

Legislator Gavaris stated that he felt the county has the ability currently to withhold county funding from municipalities. Legislator Uchitelle stated that doing so without the enactment of the law may be illegal. Legislator Erner stated that the private sector is displacing people and stated that the law may provide greater ability to combat it. Legislator Ronk stated he would support the Public Hearing.

Chair Heppner advised the members that there are amendments requested by the sponsor presented before them.

**Resolution No. 73** – Establishing A Policy To Prohibit Appointees Of Ulster County Elected Officials And Board Of Elections From Holding Any Elective Public Office Of Any City, Town or Village Within Ulster County

**Resolution Summary:** This resolution prohibits the following from holding any elective public office of any City, Town or Village within Ulster County: appointed members of the County Executive's staff, including Deputy County Executives, Department Heads, and all other assistants, officers, and employees; the Commissioners of the Board of Elections and all employees of the Board of Elections; the Clerk of the Legislature and all employees of the Office of the Clerk of the Legislature, and any appointees of the

Comptroller, County Clerk, District Attorney, and Sheriff. The elected offices of Town or Village Judge, and Fire, School and Library Districts are not included.

## **Discussion**:

Legislator Ronk advised the members that he had introduced the measure a couple of years prior and was accused of targeting one individual. He stated that individual was no longer employed by the county, and he believes the discussion is important. He added that he is open to changes, but believes financial decisions and other county priorities can be swayed by individuals who work for the county but are elected to represent a specific constituency.

Chair Heppner stated that the Democratic Caucus had a productive discussion on the policy but are united in their opposition to the current form. He added that there was willingness to have further discussions and recommended postponing the resolution. Legislator Gavaris commented that the positions are too broad in the current version. The members briefly discussed the positions that are exempted from the policy. Legislator Ronk commented that he has received recommendations from the Executive's Office and others that he is considering. He stated that the Chief Diversity Officer, which is the Executive's Office primary concern would not have been an issue if the position remained under Personnel.

Chair Heppner asked if there was any further discussion and hearing none called for a vote in favor of postponement.
