LATE Resolution No. 376: Authorizing The Chair Of The Ulster County Legislature To Execute An Agreement With The New York State Board Of Elections For Expenses Related To The Purchase Of Equipment And Services Necessary For Early Voting In Ulster County And Amending The 2019 Ulster County Budget – Ulster County Board Of Elections

Resolution Summary: This resolution authorizes the Chair to execute an agreement with the NYS Board of Elections for the period beginning April 12, 2019 and ending December 31, 2020 in the amount of \$223,991.00 for costs associated with the implementation of the Early Voting Act.

Deputy Commissioner Quigley explained that the company will provide the licenses and training for the poll pads which were purchased through and OGS contract with Verizon. Mr. Quigley responded that there are three vendors who provide the service, but KNOWiNK is the only one currently approved by the State Board of Elections. He added that Dutchess County is using them, and Orange County is leaning towards using them. Legislator Ronk recommended purchasing more than the minimum number of required software licenses to allow for breakdowns, etc. Mr. Quigley stated that the Board of Elections was maximizing poll pad purchases. He briefly explained the early voting process and stated that the Board expected to learn a lot over the next year.

Legislator Rodriguez explained that the members had technical amendments before them which clarified sections in the adopted law. He added that additional amendments were drafted earlier in the day and suggested the members postpone the Resolution to provide adequate time to review the

amendments. Chairwoman Bartels asked if the proposed amendments could be incorporated into the current law so the members could more easily see how the existing law would be changed. Legislator Rodriguez responded that he would have the current law marked up. Chairwoman Bartels expressed her concern that the proposed new definitions could require that cable and telephone installers might be required to become licensed electricians. She also commented that solar system installers are not required to be electricians and the law as written may contradict that. Legislator Ronk asked that suggestions on changes be directed to Legislator Rodriguez, adding that further amendments to fees and reciprocity were also being considered. Legislator Greene echoed concerns about requirements for solar system installers and questioned if IBEW was consulted. Legislator Rodriguez responded that Mr. Fratto from IBEW has been consulted throughout the development of the existing law as well as the proposed amendments.

Legislator Ronk informed the members that the draft law before them contains all changes discussed during the previous months. He stated that there were only a couple of outstanding discussion points, including collective bargaining agreements and fines. Legislator Ronk stated that the Orange County Law is equally written in regards to collective bargaining. Chairman Donaldson stated that he did not feel there would be a conflict to vote on a contract that was negotiated on behalf of a group of employees and said there would also be a conflict with voting on the budget. Legislator Ronk stated that there is court precedent on the absence of conflict when voting on omnibus budget bills.

The members discussed fines for violations of the law. They agreed that language should be developed which will prevent the levying of multiple fines for an action on the same topic/item

repeated in more than one instance, ie: a vote on the same Resolution in more than one legislative meeting. The members agreed to reinstate the County Executive's ability to remove members for cause as well as provide the Legislature with the ability to recommend members for removal. Legislator Ronk commented that he believed that the change would allay the argument that a referendum would be required. Lastly, the members agreed that the effective date of the law should be January 1, 2020.

He added that the County Attorney's Office, and others were still discussing the question of whether the state has preempted the field on this issue. Legislative Counsel Gordon briefly spoke to the issue of field preemption.

Resolution Summary: This resolution establishes a policy prohibiting the holding of any elective public office of any City, Town or Village within Ulster County by any appointed members of the County Executive's staff, including Deputy County Executives, Department Heads, and all other assistants, officers, and employees of the County Executive's office; the Commissioners of the Board of Elections and all employees of the Board of Elections; and any appointees of the Comptroller, County Clerk, District Attorney, Sheriff and Ulster County Legislature.

He added that he agreed that the policy should apply to Board of Elections employees, but possibly not to individuals at the Department of Public Works. Legislator Ronk stated that the policy is intended to target policy makers and those who advise policy makers. He added that he has agreed to work with the County Executive on language which is why he was asking for postponement. Legislator Nolan recommended prohibiting an elected official from making an appointment rather than prohibiting an individual from running for office, adding concerns with infringements on free speech. Legislator Rodriguez responded that the Legislature has put limitations on offices in the past and disagreed that the prohibition was an infringement on free speech.
