Chair Heppner asked Commissioner Dittus to give the members an update on the new BOE offices while they waited for Commissioner Quigley to arrive. Commissioner Dittus invited the members to visit the new site and stated that the consolidation of the voting systems, and equipment into the same locations as the administrative operations has saved time and improved efficiencies. She added that training inspectors in the same location allowed Commissioners the ability to conduct the classes and sign off on absentee ballot applications.

Chair Heppner asked how the recent mock election went. Commissioner Dittus responded that there were  $\sim 40$  participants who were happy with the process. She added that the experience of the voter is largely unchanged, but the new system significantly improves the back of the house reporting and features. Commissioner Quigley added that there would be at least two more open houses with additional vendors. He added that the goal was to introduce the new system in 2023, adding that they did not want to rollout the new system in a Presidential Election year. Commissioner Dittus added that the state's certification process is causing some delays. Commissioner Quigley added there are also cost increases associated with the delay.

Legislator Roberts asked for clarification on the new rules that does not allow an absentee voter to cast a ballot on Election Day if they had received one previously. Commissioner Dittus explained that reason is because absentee ballots are now opened and counted before Election Day. Commissioners Dittus and Quigley further explained the new absentee application and voting rules.

Legislator Levine asked if the BOE included messages on the new rules on or with absentee ballot applications or ballots. The Commissioners responded that they may be able to add a note to the envelope, adding that the website has information on how to request and return an absentee ballot.

Chair Heppner asked if there were any other questions fo the Commissioners. Hearing none he moved on to the BOE related Resolutions.

**Resolution No. 531:** Authorizing The Chair Of The Ulster County Legislature To Enter Into A Funding Agreement For Absentee Ballot Pre-Paid Postage With The NYS Board Of Elections – Ulster County Board Of Elections
