## Discussion:

Chairman Donaldson advised the members that members of the public were in attendance to speak on the law. He stated that there have been numerous discussions on the topic, adding that many Legislators feel the issue needs to be addressed. He thanked Legislator Petit for introducing the proposed law and explained that there are a number of questions about whether the staffed office requirement is necessary. He added that New Paltz and the City of Kingston have requirements that a responsible local individual must be available 24/7.

Legislator Petit stated that the impetus behind the introduction of the law was in response to the recent influx of large developers coming into the county and taking ownership of numerous large rental complexes. She added that serious maintenance and safety issues have occurred at these complexes which have gone unanswered. She informed the members that she was made aware of a fatal legal flaw in the law that needs to be corrected. Ms. Rashida Tyler of the Kingston Tenants Union and Citizens Action, shared instances of landlord abuses and expressed her support for the law. Legislator Nolan stated that she did not have complexes with more than 20 units in her district, but that there were still issues. She suggested adding levels of requirements based on the number of units.

Chairman Donaldson stated his support for requiring a responsible local person be available 24/7. Legislator Roberts expressed his support for requiring an on-call person. He expressed concerns that an office requirement might end up hurting tenants by passing along the costs of the space and staffing. New Paltz resident Amanda Sisenstein, expressed her support for the law and commented that in the Village of New Paltz, tenants often act as the on-call person in exchange for a reduction in rent.

Legislator Petit clarified that the law does not require an office in the complex or in the building, rather requires that an office be located within Ulster County. Legislator Donaldson questioned what assistance an office provides when issues arise after office hours. Legislator Roberts questioned how effective an office located 30 miles away from a complex would be. Legislator Heppner commented that Woodstock Commons, a large rental complex in his district managed by RUPCO, has management office on site. He added that he was unsure what the protocol was for afterhours issues.

Legislator Ronk stated that the subject of preemption should be addressed by counsel. when reviewing the law. Ms. Tyler encouraged expediency in adopting the law 2020. Legislator Ronk stated that, while he appreciated the call for expediency, the law is legally insufficient and would be open to challenge. Chairman Donaldson informed those present that another Public Hearing on the law would be required because of the extent of the changes necessary. He added that Towns should be encouraged to act locally as they have the additional ability to enforce requirements through code enforcement mechanisms, which the county does not. He advised those present that the earliest a Public Hearing could be scheduled would be March 2020. He asked Deputy County Executives Rider and Milgrim if the Executive has any thoughts on the law and asked for feedback from the County Attorney's Office. Deputy County Executive Milgrim responded that the County Attorney's Office had said there were some issues in regard to prohibitions. Legislators Ronk and Petit requested that the County Attorney's Office forward comments on the law sooner rather than later.

She explained that the draft before the members did not include an accountability portion and encouraged the members to forward feedback.
