Resolutions for the July 18, 2023 Session of the Legislature

Chair Heppner advised the members that Board of Elections Commissioners and Deputy Commissioner were in attendance to answer any questions on Resolution No. 418, so he would be moving it to the top of the agenda.

Resolution No. 418: Approving The Execution Of A Contract For \$1,798,088.00 Entered Into By The County – Hart InterCivic, Inc. – Board Of Elections

Discussion:

Chair Heppner acknowledged Board of Elections Commissioners Torres and Quigley and Deputy Commissioners and asked if they would like to speak to the resolution. Commissioner Torres stated that they were excited to roll out the new systems and were pleased that the voting systems will be in hand in time for the 2023 elections. She added that the Board of Elections pushed for the 2023 rollout as opposed to 2024 with a Presidential Election turnout. The Commissioners briefly discussed the state and federal voting system certification process and timeline and expected improvements to election night reporting and other back end systems. The Board advised the members that the county's purchasing department was able to negotiate a \$200,000 reduction in price, and would also be getting a Technology Investment Grant to help with costs.

Legislator Levine thanked the Commissioners for their work and the seamlessness of the transition. He asked what the expected lifecycle of the machines was and what the plan was for the old systems. Commissioner Quigley responded that the warranty was for 5 years, but that he expected to get about 15 years of useful life out of the systems. He advised the members that they were actively working on the plan to dispose of the current systems, citing federal requirements for destruction of motherboards and likely an auction for the metal casing and some election supply bags.

Legislator Gavaris asked if there was an annual operating cost for the systems. Commissioners Quigley responded that beyond the first 5 years there would be an annual operating cost in the \$40,000 - \$60,000 range.

Legislator Erner asked how the paper trial process and electric in the event of a power failure differ than the current systems. The Commissioners responded that there was essentially no change adding that any pen can be used to mark a ballot as opposed to the specific type required previously, and improvements to the area the voter marks and the type of acceptable mark. They stated that the battery life is 10 hours.

Chair Heppner asked if there was any further discussion and hearing none called for a vote in favor of the Resolution.

Legislator Roberts stated that he would like a vote on the resolution. Chair Heppner stated that he spoke to the sponsor and although he does not support the resolution, would honor the request and would not move for postponement. Legislator Gavaris asked why the Chair supported the change. Chair Heppner responded that a number of offices would remain in odd years including Sheriff, DA, judges per the NYS Constitution. He added that in other states where elections are held similarly, voter turnout has increased significantly, adding that they should be encouraging the greatest amount of participation in all elections as possible.

Legislator stated that fire districts are 3 year terms, adding that if the state was serious about voter participation, they would move state elections to odd years. The members briefly discussed the potential large size of the ballot and whether voting systems would be able to accommodate it, as well as how odd year terms would be addressed.

Chair Heppner asked if there were any other questions or discussion and hearing none called for a vote in favor of the Resolution.
