Resolutions for the August 15, 2023 Session of the Legislature

Deputy Chair Roberts advised the members that the candidate for confirmation as the Human Rights Commissioner, Joe McDonald was in attendance and that he would be taking Resolution No. 461 out of order out of deference for his time.

Discussion:

Deputy Chair Roberts recognized Mr. McDonald and asked him to introduce himself to the members. Mr. McDonald thanked the members for having him and expressed his excitement to serve as the county's Commissioner of Human Rights. He shared his background with NYS offices and work in juvenile and daycare services. He added that he worked on a number of diversity, equity, inclusion and accessibility committees in Albany and was excited to return to work in Kingston.

Legislator Petit asked if Mr. McDonald had any experience in mediation or conflict resolution. Mr. McDonald responded that his management experience has provided him with years of complaint investigation and resolution, working closely with HR and legal departments.

Deputy Chair Roberts thanks Mr. McDonald for his time and asked if there was any further discussion or questions; hearing none called for a vote in favor of the Resolution.

Legislator Erner stated that a number of amendments were made in the Energy, Environment and Sustainability committee, but one change was not included. He requested that the members make an additional amendment to paragraph J to add the words "to head of tide."

Discussion:

Deputy Chair Roberts asked for an explanation of the language. Legislative Counsel Gordon explained that it refers to sea level. Legislator Ronk stated that he supported moving the law forward for public hearing

but did not support the law. He added that it was his understanding that Legislator Erner was going to be requesting postponement. Legislator Erner stated that he was okay with postponement if that was the will of the committee. Legislator Ronk stated that he struggled with enforceability of giving inanimate objects tights.

Deputy Chair Roberts asked if there was any further discussion on the amendment specifically. Hearing none called for a vote in favor of adopting the amendment.

Discussion:

Legislator Gavaris stated he also had questions about enforceability and question whether the law would impact the boating industry. Counselor Gordon responded that in short, yes. The members continued discussing the possibility of boaters be held liable and subject to penalty under the law. Legislator Petit stated that the spirit of the law was to address significant environmental impacts, rather than individual boating, such as spills and digging damaging channels.

Legislator Ronk stated that he felt the legislation was more memorializing in nature but agreed with Legislator Gavaris that the law set people up for brining causes of action against recreational users, whether or not the action would prove to be successful. The members continued discussing enforceability of the legislation and its legal implications.

Deputy County Executive Contreras stated that the Executive's Office believes there is language on the law that implies the Executive has certain responsibilities and requested postponement to provide more time to understand those implications. Chair Bartels stated that it was reasonable to provide the County Executive's office to understand the implications and be a part of the process. She added that there was language in the law that made it clear to her that it was not memorializing. She asked if there were other examples of similar legislation. Counselor Gordon responded that Kingston passed a similar law and that there is a global push for right of nature laws.

Planning Director Doyle advised the members that his office looked at the law at the Executive's request because the Planning Board was included in the statute. He stated that the law refers to and calls for actions that the county has no regulatory authority to do. He added that as far as legal action is concerned, the county can be sued for inaction as well as action. The members continued to discuss legal implications of the law.

The members discussed obligating action by the Executive and Legislature and authority over action by other counties.

Legislator Ronk stated that he supported the idea. He added that many of the Legislator who will serve beyond him have expressed opposition to the idea citing logistic problems. Chair Bartels added her concerns with the logistics. She added that it is more difficult than one would think to find locations throughout the county have adequate space for 23 legislators and staff as well as members of the public. Additionally, the location would need to meet electric and internet requirements for livestreaming, and other needs to accommodate Ways and means meetings, caucuses and Session. She added that she appreciates the intent but could not support the resolution.

Legislator Ronk suggested moving at least one meeting per year to a location other than Kingston. Chair Bartels responded that the Riles of the legislature already provide for that ability at the call of the Chair. Legislator Levine stated that he appreciated the intent of the resolution but felt requiring 23 out of 24 meeting of the Legislature during a two year term was a bridge too far.

Legislator Erner thanked the members for their consideration and feedback. He explained that the rationale behind this resolution, as well as the previous and a number of proposals he has before the Public Works, Capital Projects and Transportation Committee, is an attempt to bring government to the people and making it as accessible as possible. Deputy Chair Roberts briefly mentioned the added difficulty of implementing the requirement if the state adopts the election change requiring most elections to be held in even number years, temporarily effecting the terms of county legislators.

He added that requiring political party participation in filling a vacancy would not be possible in instances when a person was elected on an independent party line, such as the Clen Sweep line in Ellenville. Deputy Chair Roberts offered that in such a case the party with which the member caucuses would probably be the logical default.
