Legislator Rodriguez advised the members that the subcommittee met and the amendments proposed were in the copy of the law before them and were as follows:

<u>Page 10</u>. Section 4. A (i) for the office of County Executive, County Clerk, District Attorney, County Sheriff, or County Comptroller shall exceed five thousand dollars (\$5,000.00) four thousand (\$4,000.00) dollars per election cycle, or

<u>Page 14.</u> Section 6. B. (ii) or a member of the County Legislature one thousand dollars (\$1,000.00) **Two thousand five hundred (\$2,500.00) dollars**.

Page 22. Section 9. D. strike subsections 2, 3 and 4

Page 24. Section 10.

- (iii) The County Executive shall, no later January 1, 2018, select a third member for the Commission, who will serve as its chairman.
- (iv) The Commission shall select a member to serve as Chair

C.

- (i) the member appointed by the minority leader shall serve for one (1) two (2) years;

#### **Discussion:**

Chairman Ronk stated that he felt the amendments made sense and supported the increase in matching funds for legislative candidates. He said he still had issues with the contribution limits for legislative candidates. Legislator Rodriguez stated that he supported the decrease because of the increase in matching funds.

Chairman Ronk had a large concern with the removal of portions of section 9 that he felt promoted due diligence on the part of the Commissioner of Finance. Legislator Donaldson stated that he would like to see the contribution limit for county wide office in section 4 reduced to \$2,500. He added that he and other legislators were already working on a previously introduced campaign finance law and took issue with the fact that this law was introduced without the input of those legislators despite having a conversation with the Executive about their interest in public financing. He added that the prior law put responsibility on a candidate for contributions which exceeded limits and addressed contributions from employees to eliminate pressure to donate to their employers.

Legislator Loughran commented that civil service employees do not have to contribute and are already protected. Chairman Roberts stated that the pressure to contribute primarily effected appointed employees such as Deputy County Executives and other management level employees.

Legislator Rodriguez stated that the elimination of portions of Section 9 was being proposed to protect funding which he felt would be the first thing to be eliminated during times of fiscal stress. Chairman Ronk responded that the current health of the county can be directly attributed to the current level of fiscal responsibility. He added that he takes issue with the idea of taxpayer funded elections in general.

Legislator Belfiglio stated his support for restoring subsections 2, 3 and 4 to Section 9 D. Legislator Rodriguez stated that the Local Law can be amended if it turns out the elimination of the subsections become a problem. He added that the law creates a Commission of Public Finance who will be able to advise the Legislature on the health of the fund.

Chairman Roberts asked Legislative Counsel if there was a trigger date for the Commissioner of Finance's decision regarding contributions to the fund. Counselor Pascale responded that there is no deadline built into the law for the Commissioner's decision. He added that he expected the Commissioner would make his determination within the established county budget timeline.

Chairman Roberts expressed his support for eliminating Legislators from eligibility for public financing altogether. Chairman Ronk advised the members that he does not support the law overall. He added that he takes issue with the argument that public financing promotes cleaner election and commented that some of the most corrupt campaigns in the entire state take place in New York City which has publicly financed elections.

Legislator R. Parete expressed his support for the concept of the law and stated that he felt money in elections was out of control. He suggested adding a provision requiring that any county matching funds must be spent in Ulster County on, for example, lawn signs or advertising.

The members discussed how the funds are divided up. Chairman Roberts asked when the money is allotted. Legislator R. Parete asked if an unopposed candidate can qualify for the money. According to the law they do not. Chairman Ronk took issue with that provision stating that any candidate could be challenged through a write in campaign.

Legislator Belfiglio expressed his concern with the amount of matching funds that would be necessary during years when county legislators run. He added that the expense to run increases every year. Chairman Roberts called the question on the amendments as presented.

Legislator Donaldson stated his concern with the process and stated that the commission should not have less than five members. The members discussed the makeup of the Commission.

Chairman Ronk advised the members that he does not support taxpayer funded political campaigns. He stated that he would support including an option on county tax bills to voluntarily contribute to publicly financed elections. Legislator Rodriguez stated that he disagreed and mentioned that there are other states that have public financing which has resulted in younger and more diverse candidates running for office. Chairman Roberts asked for statistics on diversity of candidates in states with public financing.

Legislator Loughran commented that matching funds provide opportunities for individuals with limited disposable income to run for office. Legislator Donaldson agreed with Legislator Loughran that matching funds could encourage more people to run.

Legislator R. Parete stated that he would support moving the Local Law forward to a public hearing. The members discussed whether the law limits contributions from party committee and whether those contributions count towards matching funds.

He recognized that people wanted the law adopted by the end of the year, but was not comfortable with the law yet. The members discussed postponing the law versus voting on sending it to a public hearing before a new legislative body takes office in January.

### **Discussion**:

Legislator Belfiglio advised the members that he attended a seminar on Airbnbs at the recent NYSAC conference in Syracuse. He stated that representatives of Airbnb were there and reported that they had voluntary tax collection agreements with at least seventeen counties in New York. He informed the members that although he wanted the proceeds of the tax to go to the townships, the law only allows the occupancy tax to be used for tourism and promotion. The members discussed that the County Comptroller had previously introduced the law. Chairman Roberts stated that he would like more time to review the amendment.

Chairman Ronk asked Legislative Counsel to review the sample voluntary collection agreement and asked if there was anything in the law that was inconsistent with counsel's prior opinion on the legality of the law. Counselor Pascale responded that the prior opinion of counsel held. He reminded the

members that the opinion of Legislative counsel as well as Minority Counsel was that the county only has the authority to collect tax from an establishment's operator, not a third party.

Legislator Donaldson stated that sometimes passing a local law can be an effective way to change state regulations. Legislator Belfiglio stated that the county law leaves the allocation of the tourism dollars collected from the occupancy tax up to the legislature. He commented that the Legislature could allocate the money to the promotion of individual towns as opposed to the county generally. He added that currently a few towns receive a disproportionate amount of promotion. Legislator Rodriguez asked Minority Counsel if he concurred with Legislative counsel. He responded that he did, but would like more time to consider the proposed amendment before issuing a formal opinion.

Chairman Ronk stated that the majority of Bed and Breakfast operators in the county were remitting the occupancy tax. Legislator Belfiglio disagreed.
