Chairman Donaldson how much time are you going to allow each speaker?

Okay, our first speaker tonight is Janet Knott. Remember to hit star six to unmute. Janet, if you can hit star six and unmute.

Okay can you hear me?

#### **Chairman Donaldson**

## Janet Knott

Yes.

Thank you, Chairman Donaldson, for listening to me and all the legislators. My name is Janet Knot I'm a licensed clinical social worker. I was employed by the Ulster County Department of Mental Health for 30 plus years before I retired in December of last year.

As a mental health professional and Clinical Risk Manager. I'm elated to hear that Ulster County is planning to commit substantial amounts of money towards mental health and substance use services.

I was employed at the time the county privatize mental health and substance use services outpatient clinics beginning in 2011 and ending in 2013. As you may recall, the golden Hill nursing home was also privatized. At the same time.

I witnessed changes in the delivery of mental health services. When the OMH state comprehensive outpatient program subsidies also known as cops gradually went away. All outpatient clinics that bill became revenue driven.

The changes brought a significant increase to clinician's caseload, increasing productivity standards. And then there was a greater demand for billable services only, leaving no time for other significant, important nonbillable activities to occur.

As a result, mental health services in this county have become extremely watered down.

The following licensed mental health clinics that operate in Ulster County or the ACC team, run by the Mental Health Association, the pros clinic at Gateway industries, Family Services Incorporated which receives or to receive a significant county contribution. The Institute for Family Health they run both article 28 and 31. Clinics, the Pinegrove clinic which is state operated, and then the children's clinics Aster clinic for children, and coordinated Children's Services at DSS However, they do not bill for services.

All the clinics who currently bill for services are not able to recruit and maintain qualified staff and are struggling.

I believe our clinic operating costs back in 2013 was around \$5.5 million.

As you may know or not, there is no state aid for outpatient licensed mental health clinics in New York state. So, although I am excited to learn about the monies to be spent for mental health and substance use services, I see that most of the money is to come from the American rescue plan. I question how these services will continue to operate once this money is spent.

How will these new services continue to operate and be sustained long term? It would be extremely devastating to spend large sums of money of one time money on mental health and substance use services only to see them to be dismantled, when there are no ongoing funding streams to maintain them. I hope that you will consider what I've said look into it as you

look into the budget and passing of the budget. And I totally appreciate your time to speak to you tonight. Thank you so much.

The next speaker is supervisor Mike Baden.

#### Mike Baden

Good evening, Chairman Donaldson and members of the legislature. I'm speaking tonight in support of capital project plan number 602. This is to utilize the American Rescue Plan funding for the O & W rail trail. This is a project that is very important to the town of Rochester. It will allow recreational usecontinued recreational use of a very well utilized trail right now. So, I hope you will consider keeping that in the capital project plan. Also, I'd like to speak on behalf of the broadband plan. I apologize I don't have the number in front of me. Broadband to some communities is well served but in places rural areas like Rochester, we have only about 70% coverage and the assistance of the county will help the municipalities not have to use all of their funding to try to solve these problems. And finally, I'd like to ask that the legislature consider in some small way funding can be allocated to study EMS in Ulster County. As many of you know, it is a bit of a hodgepodge of services and left to the municipalities to resolve with local either privatize or with local volunteers. And I think it's time that EMS needs to be considered similar to the way fire districts are considered. And I would hope that potentially there could be some added funding in the budget to at least initiate a study of how to better manage and better serve the residents. Thank you very much appreciate your time.
