#### Clerk Fabella

We do. We currently have four speakers signed up. The first speaker signed up is Tamara Murray.

#### Clerk Fabella

Tamara, can you hear us?

#### Tamara Murray

Yes, I can. Thank you. Thank you so much for allowing me the time to speak some. My name is Tamara Murray. I'm the Marketing and Sales Director for the Emerson Resort and Spa. And I'm also the co-chair of Ulster County Lodging Coalition. The Lodging Coalition has fiercely fought against entering into a voluntary collection agreement with Airbnb for approximately eight years. I want to be very clear our stand has nothing to do with the threat of competition. The short-term rental market has been here for quite a while and there's room for all tourism businesses. We also understand the short-term rental market isn't going anywhere in the future. Rather, what we have petitioned the County in New York State for is a level playing field that requires and enforces the collection of occupancy tax and requires a minimum standard for short-term rental operators to provide health and safety protocols. We support the current system and Ulster County of using Bear Cloud Systems to identify short-term rental operators across all platforms, not just Airbnb alone, and contacting the operators to register for the payment of occupancy tax, which has been described as a model for the state by Mark Door who's the president in New York State Hospitality and Tourism Association. We believe the next step in rounding out the system that we already have in place, and ensuring the collection of correct and actual occupancy tax from the host, as well as regulating short term rentals and Ulster County is simply enforcement.

# Tamara Murray

Lodging properties are required to register with the county and prove the number of room rentals that they have in each period, guaranteeing the county receives the correct amount of occupancy tax. Airbnb seems to promise that as long as you sign an agreement with them, they will be transparent and provide the county with hostnames and give you a check. However, there are numerous legal issues and other New York State counties, as well as other states, that charge Airbnb with not requiring hosts to meet zoning, health, and safety regulations. Prohibiting the collection of back taxes, creating obstacles and stalling techniques, where the particular county does not receive the actual tax due. And prohibiting agencies from identifying and regulating operators that list on their site. With a system of enforcement in place, Ulster County could avoid the majority of short-term rental owners failing to register, collect the correct tax, and work with the towns to establish and require health and safety protocols. I understand the county is facing historical shortfalls due to the COVID pandemic. However, now it's the time when it is more important than ever to make careful decisions. A revenue stream issue as important as this should not be signed over to a third party with a history of lawsuits, closed door deals, refusal to allow true audits, and refusal to disclose host information. Thank you.

#### Clerk Fabella

The next speaker we have signed up is Mike Baden from the Town of Rochester. Can you hear us Supervisor Baden?

#### Mike Baden

I can. Thank you very much. So, good evening, Legislators. I am here tonight representing the Ulster County Association of Town Supervisors and Mayor's. Chair Harris was unable to speak tonight and has asked me to convey our message. We are in opposition to Resolution 285. Our reasons are that we think this duplicates services that have already been put in place. We think it could be disruptive to ongoing negotiations. And we think it could potentially inhibit local oversight. I would like to echo my own concerns, many of which the previous speaker just stated to you. So, I won't say them all. But I do have concerns of accountability. I think in negotiating these contracts with these host agencies, the audit power, the ability to audit, to make sure the data is accurate, that the collection is accurate, will potentially go away. And I think the county is much better off dealing directly with the hosts themselves as opposed to the hosting agency. So, for those reasons, I asked you to reconsider Resolution 285 this evening. And it has great potential, but I think it needs a little bit of further work before adoption. Thank you very much.

#### Clerk Fabella

The next speaker we have signed up is Ellen DiFalco.

#### Ellen DiFalco

Yes, thank you. Can you hear me?

#### Chairman Donaldson

Yes.

#### Ellen DiFalco

Hello?

#### Legislator Ronk

Yes.

#### Ellen DiFalco

Okay. All right. Thank you for the opportunity this evening to address this legislative body regarding Resolution 274. I am opposed to the sale and or transfer of the former Ulster County Jail and the lands owned by Ulster County located at Golden Hill to a local development corporation for affordable mixed income housing development for the following reasons. First, it is in disingenuous to move on this property transfer. Now, during the pandemic when residents and stakeholders are not able to attend meetings to have open dialogues in person. It is difficult for many of us to participate in virtual meetings.

#### Ellen DiFalco

I believe that there are other surplus properties in the county that fit the criteria for affordable mixed income workforce or low income housing. One of the first undertakings of the newly formed housing advisory committee should be to inventory surplus county owned properties which would be suitable for affordable housing outside in this City of Kingston. Your Resolution Number 179 of May 19th indicated that an inventory of such properties would be forthcoming. When the City of Kingston is already saturated with subsidized housing while we have only 13% of the county's population, it doesn't seem fair that this parcel should be the first site chosen for housing development.

The five developers have not been revealed so that our nearby residents and stakeholders can weigh in on the development of this property. We're still in the dark. A local housing development corporation, who will choose the developer, with the best plan for the property, has not been chosen yet. The sale of this property would

generate much needed revenue to balance your budget, but it becomes very obvious that a plan is already in place to hurry the project along to meet certain timelines that have already been established to complete this project. I will, on a final note, continue to advocate that the former Ulster County Jail property, is not the best fit for affordable housing, and not suitable as a solution to meet the housing shortfall, when there are other sites outside the City of Kingston that should be considered. Thank you, and have a great evening.

#### Chairman Donaldson

Next speaker.

#### Clerk Fabella

The last speaker signed up for tonight is Justin Orashan. Can you hear us Justin?

#### Justin Orashan

I can. Thank you very much. Hi, good counsel folks, thanks for allowing me to talk. I'm glad to be here with you tonight. I'm also expressing comment on Resolution 274 with regard to the Golden Hill property. And I am expressing support for moving forward with utilizing that for affordable housing and putting it over to surplus County Land. I speak on this with the acute realization that currently we're the sixth most unaffordable county in New York State, according to the housing affordability report, 2019. Some of you might have seen the most recent articles that 17.5% increase in housing sales price since this time in 2019. And we're in the to top 10 cities of folks moving, and we're top 10 cities in the country of folks moving to a city and, you know, with the exodus of folks from New York City, the folks who cannot afford housing, and who are housing insecure right now, are only being more impacted. And it's an it's an urgent matter that requires a level of urgent response. Unfortunately, we haven't done enough to prepare for this. And we are in a place now, where the folks who already couldn't afford housing here are in even more dire circumstances. I list off those statistics and figures from a broader perspective. But I want to get down to a human level. Over the past month, two months, I have been working with some local folks who are homeless and housing insecure through the Kingston Mutual Aid Project. I don't say this as some sort of savior complex, but I say it from a place of, I hadn't done that before. And it's only now that I realized, at a very personalized level, just how dire the circumstances are. To the previous caller's point, and what I've heard others argue, that the... our Ulster County is saturated with subsidized housing. I think that those folks that are urgently seeking housing, and many of whom, most of whom can't find it right now, would disagree.

#### Justin Orashan

And the reality is with Ulster... with Kingston being the epicenter of the county, and with it being where most of our county services are located, to ask people to go out beyond Kingston is very challenging. It's absolutely imperative that folks be connected closely to the resources that support them most. And try to find locations beyond the City of Kingston. While that might be a great endeavor, in addition to, this location here in Kingston, we need it here in Kingston. We needed it years ago, we needed to build today but the reality is, this is one among other options that we can take to help the folks that are really in dire circumstances. Because the landscape... the ground is shifting beneath us. And we really need to... for any of you, or any of us, who are housing secure, who own housing, we really need to take it upon ourselves to ask ourselves are we willing to stretch ourselves to help those most in need? Who right now are calling out for it. So, that is all I have to say. Thank you, all. Again, I would urge you to support the resolution to move forward with the [inaudible] Golden Hills surplus county land and utilizing it for affordable housing. Thank you.

#### Clerk Fabella

We actually had two more speakers come online with us. The next speaker is Rashida Tyler. Rashida, can you hear us?

#### Rashida Tyler

Hi. Yes, I can. Can you hear me?

#### Clerk Fabella

We can. You're all set.

# Rashida Tyler

Awesome. So, I'm speaking tonight in support of the resolution to transfer the properties at Golden Hill to a Corporate Development Corporation that can actually help to create affordable housing. We are past the point of there being a housing crisis in Ulster County; we are in a housing emergency. Actually, about half an hour before this phone call. I spoke with a gentleman who was working two jobs. Two very good jobs, who in ordinary economic times, should be able to support a family, yet he's sleeping in a van. His family is homeless. They're looking for a two-bedroom apartment, and they can't find one. The day before that I spoke with a couple who had to break up in order for the family, and his wife and children, to be able to have a roof over their head. I have, you know, I'm witnessing the toll that the housing emergency is taking on our county. And when I hear arguments and hesitations of well, you know, that you have too much affordable housing. These are positions that are given from a

position of privilege, a position of home ownership, a position of people who don't have to worry about where they're going to lay their heads down at night.

#### Rashida Tyler

In Ulster County, we have over 1,600 people who have experienced, or at risk of homelessness between October 2018 and September 2019. 31%, or 21,319, residents are renters. And we had needed, from 2009, to be building about 6000, over 6000 affordable housing units, to be created by 2020. We have built less than half of that. And we cannot, and we have not addressed the affordability gap. So, I'm asking the legislature tonight to support and vote in support of this resolution so that we can begin to support those who are in our community and have helped make it the community that it is. Keep Kingston affordable. And these properties are abandoned. They're underutilized. Please do the right thing and vote "Yes." Thank you.

#### Clerk Fabella

The last speaker we have signed up is Susan Reif. Susan, can you hear us?

#### Susan Reif

I can hear you. Good evening. Can you hear me?

#### Clerk Fabella

We can hear you.

#### Susan Reif

Very good. Thank you for giving me this opportunity tonight to share with you again that I strongly oppose the jail development into low income housing. I think that Kingston is oversaturated. With all these low-income housings, we certainly have enough of them. I think that it would be more beneficial if you did something else with that property, knowing that it borders my property. And yes, I feel sorry for all these people that are homeless and need affordable housing, but maybe they could reach out to a different community, a different area, other than Kingston. Because Kingston is highly saturated with low income housing. And I'm sorry that they've come here, and they bus them here from areas to Kingston. It just doesn't seem fair to our community. We should try to have to absorb that by making everybody that worked so hard for their homes, and their houses, and where they live, that they should have to compensate, to have their taxes go down and be lowered. Because all of these people that are coming into the area. You know, I strongly oppose, I just strongly oppose it. And I think it'll being used as a as another thing that's going to happen a little... a little cover up of the whole jail thing that happened when they built the other jail. I think that we should take some time. And we should think about what we need do with that

property other than low income housing. The property is a beautiful piece of land that could be beneficial and have a nice value to it. Something else there other than low income housing. It's you know, it seems like low income housing is getting spread throughout Kingston so thick, it's diminishing our community. Thank you for listening. I would be open to come to a meeting to discuss it if it wasn't for Coronavirus.

### Chairman Donaldson

Is that the end of the speakers?

#### Clerk Fabella

Yes. Yep, that's all of them.

#### Chairman Donaldson

Alrighty. Let's get into the resolutions. We'll start with a Consent Agenda. Is there any additions or subtractions to the Consent Agenda?

### Legislator Heppner

Yes, Chairman Donaldson, I would like to move that we move Resolutions 267, 272, 276, 286, 293, 296 and 297 from Non-Consent to Consent. And move Resolution 278 from Consent to Non-Consent.

#### Legislator Ronk

The Republican caucus consents to those additions and subtractions, Chairman.

#### Chairman Donaldson

All righty, thank you. I'll entertain a motion for those new consent agenda.

#### Legislator Heppner

Actually, excuse me Chairman Donaldson. I might have skipped, I believe I skipped... I'll also move to add Resolution 272 from Non-Consent to Consent. I believe I skipped that.

#### Chairman Donaldson

All righty. Do you concur with that, Legislator Ronk.

#### Legislator Ronk

I do. Yes.

#### Chairman Donaldson

Okay. On the Consent Agenda, as amended.

# Legislator Heppner

We are a short yes with one abstention, Resolution 274, Legislator Gavaris, for the purpose of employment.

# Legislator Ronk

And we are a short yes.

#### Clerk Fabella

The resolutions are adopted twenty-three to zero, with the exception of Resolution 274, which is adopted twenty-two to zero, with one abstention, Legislator Gavaris.

#### Chairman Donaldson

Very good. Now to begin the Non-Consent Agenda.

# Clerk Fabella

The first resolution in tonight's Non-Consent is 191. Establishing A Policy For Funding Non-County Organizations – Ulster County Legislature.

#### Chairman Donaldson

On the resolution, Legislator Ronk.

#### Legislator Ronk

Thank you, Mr. Chairman. I would like to make a motion to amend this resolution with the copy that's been provided to every legislator after Ways and Means. There were several changes that were made. Both, you know, in today's Ways and Means Committee meeting, as well as in previous Ways and Means Committee meetings. Everyone has a copy of the redline version that was emailed around.

#### Legislator Heppner

I'll second it.

#### Chairman Donaldson

All right, on the amendments to the resolution?

#### Legislator Heppner

On the amendments, I believe I can say we're short yes.

#### Chairman Donaldson

I am a yes on that. But I'm concerned with the resolution being rushed. That's okay, I'll still be a yes.

#### Clerk Fabella

The amendments are adopted twenty-three to zero.

#### Chairman Donaldson

On the resolution.

# Legislator Heppner

On the resolution, again, I wasn't able to get in touch with absolutely everybody in between Ways and Means and Session, but I believe I can say we're short yes, unless anyone is a no, please interrupt me.

#### Chairman Donaldson

I'll be a no on it.

#### Legislator Heppner

Okay, so we are short yes, with one no, Legislator Donaldson. And I believe Legislator Criswell has his hand raised Chairman.

#### Chairman Donaldson

Legislator Criswell.

#### Legislator Criswell

I'm going to be a yes. I just want to say that I'm hoping in the future we can include broader language on legal structures such as blended structures that are social good corporations, social benefit corporations, such as LC3s, B-corps, flexible benefit corporations. None of that language was included in this, and I'm going to be a yes, but I just hope that moving forward, we can understand that corporate structure has changed, and that we should consider that when we're making these types of resolutions.

#### Chairman Donaldson

Legislator Ronk.

#### Legislator Ronk

Thank you, Mr. Chairman. I just want to thank Legislator Walter, Bartels, Gavaris, you know, and everybody on Ways and Means. I just wanted to mention those three because I know that they had brought up a lot of, you know, concerns to the legislature, you know, to the committee. We've been asking for them for several months. This has been going on for several months. I also want to thank Legislator Petit, my co-sponsor on the resolution. I think that this addresses a really deep concern with how we've been funding, not for profits and other organizations through our budget. And, you know, as Legislator, Criswell said, I definitely am open to changes moving forward. I definitely think this is a good first step. And I just wanted to say thank you for all the collaboration and working together.

#### Chairman Donaldson

I might add, Legislator Criswell, if you could send us a copy that you think the changes should be made, send that to Ways and Means Committee and I think they'll make those changes if... Okay?

### **Legislator Criswell**

I'd be happy to do that, thank you.

#### Chairman Donaldson

All right. Did you vote on this Legislator Ronk?

#### Legislator Ronk

I wasn't sure if anybody else wanted to speak. We, the Republican caucus is a short yes.

#### Chairman Donaldson

I'll change my vote to a yes then even though I feel it should have been put off for the month.

#### Legislator Heppner

On the resolution than, the Democratic caucus is a short yes.

#### Clerk Fabella

The resolution is adopted as amended twenty-three to zero.

# Clerk Fabella

Resolution 285. Adopting Proposed Local Law No. 7 Of 2020, A Local Law Amending The Code Of The County Of Ulster In Relation To Local Law No. 5 Of 1991 (A Local Law Adopting A Hotel And Motel Room Occupancy Tax) To Clarify The Tax Law's Application To Short-Term And Vacation Rentals.

#### Chairman Donaldson

Legislator Walters, Walter rather, I always...

#### Legislator Walter

Thank you, no problem.

#### Legislator Walter

So, for many years, this Legislature has tried to pass this law in one form or another. And while I'm new I learned pretty quickly that the assumptions and misinformation and misdirected emotion that has fueled the opposition to this law, and interestingly, these don't align with each other except for unification against the law.

# Legislator Walter

So, I've heard the laws illegal. This is an opinion of some legal counsel and not the opinion of the Legislative Council or the County Council, and the Legislative and County councils in over 20 counties in New York that have had this contract. Lawyers are risk adverse. Our County Attorney would not be currently engaging in this very contractual negotiation if they felt that it would attract a lawsuit from the State.

### Legislator Walter

I've also heard argument that the Legislature, if we had this law, the Executive cannot successfully negotiate a contract. This is fueled by unfounded assumptions. This presents a scenario of Airbnb, or another platform, forcing the county into a bad contract. If we continue this scenario, we would have to assume that the preposterous idea that if an agreement was rejected by us, that Airbnb would somehow sue us, with claims that we had to accept anything they gave us. We are lawmakers, we make an adapt laws.

# Legislator Walter

I've also heard that town supervisors are against this. And this is misinformation on two levels. First, not all supervisors are against this. And second, those who are only against it for the reasons stated above. They were told by the Executive that this resolution would only hurt his ability to negotiate.

#### Legislator Walter

I've also we've heard that hotels and motels are against this. This is fueled by emotion as Airbnb has been damaging to these companies as businesses. This is also fueled by anecdotes of counties with poor contracts that they're bound to, this assumes our county would accept these conditions when we would not.

#### Legislator Walter

You may have heard that this law proposes new taxes and assessed harmful to our existing B&Bs, inns and hotels, and this is fueled by misinformation. This law's adapting the existing occupancy tax law. Our small B&Bs, inns, hotels and motels must already charge this tax. Their occupants are short-term renters must already pay this, and these businesses must remit this revenue to the county. These businesses have been paying this occupancy tax since at least 1991 when this local law was created. For stays obtained through platforms such as Airbnb hosts have not been charging this tax, occupants have not been paying, and these hosts have only been sparsely remitting this revenue to the county. So, this is not a new tax. This is a process to secure the

revenue that we are owed by occupants who rent through short term platforms like Airbnb. And the resolution clearly states this.

# Legislator Walter

This is to level the playing fields for our hotels, motels, inns, and B&B's who must pay this tax. And importantly, our failure to pass this over so many years has resulted in millions of dollars of lost revenue. Revenue, we need now more than ever, revenue that could save programs and that are cut, and jobs that are going to be lost.

### Legislator Walter

That said, the Executive is moving forward with this contract. And I really applaud that office for seeing the light and really seeing the importance of this. But given that so much misinformation has fed, and it has overridden the job that we have as legislators to do the right thing, I'm going to be withdrawing this. Thank you.

# Legislator Ronk

You're muted Dave.

#### Chairman Donaldson

[Inaudible] about that. She is drawing the resolution, right? So, Legislator Ronk, do you want to speak on the withdrawn resolution?

#### Legislator Ronk

Yeah. I just feel like I need to say something. Because...

#### Legislator Heppner

Point of order, Chairman Donaldson, wasn't the resolution withdrawn?

#### Chairman Donaldson

Yes, it was.

#### Legislator Ronk

Then I'd like to, you know, put further point of order, you know, Majority Leader Heppner. You know, it's not been the past practice of this body to allow a Legislator to go on a multi-minute long diatribe about misinformation and, you know, pretty much appropriating what is the right thing to do, and what is not, and not allowing the other side to be heard. So, if that's what the Chairman would like to do, I'm not going to bother trying to override his ruling, but I feel felt like the other side of the issue might be entitled to a few seconds since the sponsor, you know, went on a very long debate on the resolution, and then withdrew it.

#### Chairman Donaldson

Well, she went through it because my understanding is the Executive is in the process of bringing forth an agreement. So, it... I mean I'll give you some leeway, Legislator Ronk.

#### Legislator Ronk

I just, you know, a lot of what Legislator Walter just said, I believe is an opinion and not necessarily a fact. You know, calling things misinformation, just because it's information that you don't agree with, isn't necessarily misinformation. Just because it's... you believe is the right thing to do doesn't mean that something is the right thing to do. You know, that's just not the way this works. I mean, you know, in this in this age of, you know, social media, in this age of instant gratification, in the age that we live in today, everybody's opinion is automatically deemed by them to be fact, when unfortunately, it is not.

# Legislator Ronk

There are many town supervisors that are against this law. There are many, you know, brick and mortar businesses, you know, resorts and hotels that are against this law. They're not just against this law because Airbnb is hurting them. Because Airbnb is not going anywhere. They're looking for a level playing field. They're looking for the ability to have the same kind of, the same kind of inspections, the same kind of health and safety requirements. And this... that... I've never said and, nor I don't believe has anybody else, that all of the town supervisors are against it. But the Town Supervisor's Association, a quorum being present, did vote to oppose this and the Vice Chair of the Supervisor's Association came tonight to speak to us.

#### Chairman Donaldson
