My name is Caylin Sanders and I have lived along the Esopus Creek for the last 5 years. I would like to thank Legislator Phil Erner and others who worked on Local Law #12 and I am in enthusiastic support of it.

Between the muddy releases from the Ashokan and regular storm run-off, the creek's health is going downhill rapidly and a lot of us have seen massive erosion and loss of wildlife.

Add to that, our septic is over 20 years old, as are many other creekside residents who border the Esopus, and when I inquired about septic replacement assistance, like some who live upstate receive, I was told the Esopus Creek was not on the list of impaired bodies of water. Given the turbidity empties into the Hudson River where many towns get their drinking water, I would argue that residents deserve "impaired" status and the funding to stave off multiple septic failures.

I also represent about 50 people that live around the border of the new Central Hudson Training Facility on 9W. Our neighborhood has been completely decimated with them flattening 50 acres of forest for what essentially is a corporate park with no sustainable landscaping plans or design. We've lost wildlife and our dark sky and our quality of life as the center is being constructed.

This project was fast-tracked and greenlit without being properly vetted despite being adjacent to a wetland, which was not disclosed on their original application. As a result, Central Hudson was issued a DEC warning violation in 2021 for dumping construction waste into the site pond feeding the Esopus.

I bring this up, because how many countless other commercial sites and big businesses are doing the same in the County without any regulation or consequences or regard for the residents who swim, recreate or live in the Lower Esopus or along the Hudson River?

The Esopus Creek and the Hudson River are why I moved here and I have since become an accidental activist trying to save them. It's time we start protecting our watershed and restoring it and most of all, saying "no" to those who would abuse it for their short-term profit maximization.

Testimony of Daniel Krupa, Legal Intern, Riverkeeper, Inc.

on The Hudson River / Mahicannituck Restoration and Protection Law

July 18, 2023

Thank you, Chairperson Bartels, members of the Ulster County Legislature, and community members who brought this idea forward for your leadership in addressing the health of the Hudson River and for the opportunity to testify today. Riverkeeper is especially grateful for your willingness to take a leading role in protecting and restoring the Hudson River and fighting for the rights of Ulster County residents through the proposed Hudson River / Mahicannituck Restoration and Protection Law.

I am Daniel Krupa, a Legal Intern for Riverkeeper. Riverkeeper is a member-supported watchdog organization dedicated to protecting and restoring the Hudson River from source to sea and safeguarding drinking water supplies through advocacy rooted in community partnerships, science, and law.

We appreciate the Ulster County Legislature's acknowledgment of the benefits that stem from the Hudson River and the importance of protecting and restoring it. We commend your commitment to doing your part as one of many counties that border the Hudson River and taking a proactive role as a steward of its environment.

I. Riverkeeper strongly supports the Hudson River / Mahicannituck Restoration and Protection Law, which will place accountability on a county level to help protect and restore the water body.

The proposed law sets forth clear policy goals for the county to "protect and, to the extent practicable, restore the health, cleanliness, and productivity of the Hudson River for the benefit of its residents and visitors as well as the River's natural components and ecosystems." By passing this proposed law, it would increase protection efforts and remedial oversight on a county level by adopting and enforcing state law, such as the antidegradation policy. Greater oversight will help raise public awareness of the current conditions of the Hudson River, increase the number of entities working to solve the same environmental issues, and provide localized solutions to prevent unlawful and detrimental actions from occurring within the county borders. Additionally, the proposed law may incentivize neighboring counties to pass similar laws emphasizing local awareness and accountability to collaborate in reaching a common objective.

While the proposed law before the Ulster County Legislature is thorough, I want to mention four recommendations that Riverkeeper believes will increase the strength of the law if passed.

II. The law should be amended to cover additional waters, especially the Black, Esopus and Rondout Creeks.

The proposed law addresses the Hudson River generally and emphasizes restoring and protecting shallow habitats. However, to align better with paragraphs A and H in the Legislative Intent and Findings section and acknowledgment that "the River is a deeply interconnected ecological resource," the Ulster County Legislature should expand the language to encompass additional waters. Although the county may already implicitly protect additional waters, it should explicitly include other geographic features such as tributaries, shorelines, adjacent wetlands, and intertidal areas with reasoning showcasing the importance of their protection. For example, tributaries, such as Black Creek. Esopus Creek and Rondout Creek, provide significant benefits for Ulster County residents and the health of the Hudson River. Particularly, the tidal portions of each of these creeks are considered part of the Hudson River Estuary, and state-designated Significant Coastal Fish and Wildlife Habitats include the entirety of the tidal reaches of the Black, Esopus, and Rondout Creeks. (Note that Ulster County includes several other Hudson River Significant Coastal Fish and Wildlife Habitats, including Esopus Meadows, Kingston-Poughkeepsie Deepwater, and The Flats.) If the Ulster County Legislature expands the language, it will broaden the geographical scope of the law and align better with the findings in the DEC Hudson River Estuary Habitat Restoration Plan. Also note that, since publication of the DEC Hudson River Estuary Habitat Restoration Plan, several other related and similar plans have been published, including the Hudson River Comprehensive Restoration Plan, which includes specific targets for restoring various ecosystem types.²

III. The law should expand on and detail the implementation of the Antidegradation Policy.

We are thankful to the Ulster County Legislature for adopting the New York State antidegradation policy specifically to protect the Hudson River, regardless of how it is currently implemented by DEC. The county's adoption of a state level policy introduces the potential to closely monitor activities within the county to control sources of water pollution. However, the Ulster County Legislature should expand the antidegradation section to include additional language outlining implementation measures. The Legislature should clarify how the county will ensure that the water quality of the Hudson River will not diminish and what actions the county will adopt to carry out its goal. More specifically, the language could reflect what requirements

the policy will place on existing sources of pollution and further specify how the county will evaluate new potential sources that may impact water quality.

IV. The law should clarify potentially ambiguous terms.

The Ulster County Legislature removed the definition section from a previous version of the proposed law, which may introduce concerns regarding vagueness. We urge the Legislature to include an updated definitions section that helps the public understand ambiguous terms such as "clean," "healthy," "productive," and the like. Similar to paragraphs E and F under Section 4, which briefly describes specific terms, including a definitions section could help the public to better understand what conduct may violate the provisions by having clear standards for each word mentioned above. This could be beneficial in conjunction with the implementation section, which states, "The County, upon resolution of the legislature, or any County resident acting on their own behalf or that of the River, may bring an action to enforce the provisions of this local law in Supreme Court in any appropriate venue or in any other court of competent jurisdiction." If the county or a resident brings a claim to enforce the provisions of the law, it is best practice to have explicit language to support that a violation occurred.

V. The law could address current threats and priorities.

The law names PCB remediation and habitat restoration as explicit goals the county should support, and Riverkeeper shares these goals and supports their inclusion. Several other issues could similarly be named, including recreational water quality, drinking water quality, invasive species, and climate change impacts to species, habitats, water quality and shoreline communities.

Ulster County Legislators (c/o Chelsea Vilalba, with thanks):

I am one of a handful of people who first introduced Sponsor Phil Erner to a legal template for what came to be known as Ulster County Local Law 12. Yet I will not be supporting it.

To explain:

All of our core group of organizers bringing Mr. Erner the template for a new law are from a NY State recognized disadvantaged community (as of 3/2023 a designation that the CLCPA, was designed to "ensure that frontline and otherwise underserved communities benefit from the state's historic transition to cleaner, greener sources of energy, reduced pollution and cleaner air." Because our water source is the Hudson River (Port Ewen water district) many of us felt an unmet need to be heard and protected by action from our Representatives and people in

power. But, importantly, we realized too that our health was the same as the River's health, as sure as the River was our relation.

There were many people who organized and spent many hours, weekends and evenings thinking and talking about the first version of the Local Law. Like us, many of those supporters were from NY State-designated disadvantaged communities burdened with pollution and most especially water degradation.

We were are and are interested in a public and democratic conversation not **just** about human entitlements to healthy water and waterways, as the Legislature has now framed it, but also about the so-called Hudson River as a living being, an idea that the Energy, Environment and Sustainability Committee, where the Law was first introduced, ultimately refused to entertain. We wanted those who we elected to represent our County to think deeply about a paradigm shift that would first and foremost honor rights of community to serious consideration of the legal, cultural and philosophical idea we brought to Mr. Erner. Instead what we got was an unelected County Counsel writing the law to fit in with existing western frameworks that have resulted in the devastation of rivers and ultimately their regulatory capture as "productive" entities. Local Law 12 as rewritten by the EES Committee with David Gordon's assistance, seems to frame the crisis of water as a crisis of the productivity, human entitlement, and commerce. It is in keeping with looking at water as a resource to be managed, instead of liberated to be and support life. Mr. Gordon seems to have privileged Green Amendment enforcement rights, an legal idea begun decades ago in PA, but that NY only recently passed and which, according to the March 2023 NY Law Journal, has pretty dismal prospects.

The River is in fact an assembly of many living beings in relation **with** us, including all the more than human organisms known and unknown within it. What arrogance on the part of Ulster County Legislative attorney Mr. Gordon to presume to list even a fraction. One paragraph can't contain them.

We wanted the Legislature to begin to look more globally at our predicament. We wanted the Legislature to see the River beyond colonial county boundaries, to understand the ways energy infrastructure projects such as the Blackstone's Champlain Hudson Power Express, the Hydro-Quebec ratepayer subsidized partner project, and Holtec International decommissioning of Indian Point connect us globally, as surely as water connects all life, to ecocidal and genocidal projects of big hydropower and toxic nuclear power for the profit of the few. These are urgent crises for our community and for those to whom we are connected. Specifically, we must acknowledge how hydropower projects on Indigenous land in Canada and accelerating methane that come with rivers being contained and managed, and how the existential rights of the Hudson River are the existential rights of all.

Yet corporations have the rights of personhood the living persons do not. We wanted to give our Legislators a chance to act where our state and federal government has failed, as so many localities have begun to do in desperate response to crisis. I personally did not feel that the Hudson 7 Intermunicipal Drinking Water Council, nor any major Hudson River NGOs were responding adequately to our sick River relation.

We learned: We didn't stand a chance. The words of one Energy, Environment and Sustainability Committee ring and reverberate in my head, from when the Law was introduced in concept and I attended a Winter EES Committee meeting "Can we get to real business now?" This process has certainly helped me understand how entwined democratic crisis is with environmental crisis. The County Attorney "had a better way," we were told by Mr. Erner.

The new Local Law 12 enshrines organized abandonment of our community and of the River.

The recognition of existential rights of personhood for the River would have been a powerful platform to enable us to form community to act on our responsibilities of repair, to become next friends of the River and act for justice, and regenerative ecological community. This Local Law 12 is not that.

I will not be supporting Ulster County Local Law 12. Incrementalism and failed precedents are not enough.

Article 6 of the U.S. Constitution states that all the treaties with the native nations here are required to be followed as the law of the land.

I mention these points to say that protecting our waters including the Hudson River shouldn't even have to be restated here, but because of the repeated failure of NYS to protect our waters our county must move to pass proposed local law #12 of 2022. (i.e. if someone dumps something upriver or down river that pollutes Ulster county's river they are held liable to clean it up and for damages) I'm often thinking of the Wallkill river. I am aware of industry in Orange County that discharges into the walkill and flows down to gardiner where I live and of course onward to new Paltz. Algae blooms, pollutants etc. And of course the proposed discharge from the decommissioned Indian Point nuclear facility into the Hudson. But there is no recourse to the companies that have permits to do what they do.

Additionally, I think we could declare the river to have rights, just like a corporation. What if we make the river a corporation? The idea to give nature rights has been batted around before. I can send you information about that if you're interested. Thank you.

Topic: Purchase of the Hart Verity Scan and Verity Touch Writer with Access devices for voting use in Ulster County.

Good evening everyone. My name is Elizabeth Lee, Chair of the Election Reform Committee of Ulster Activists, and I live and vote in New Paltz. I have attended the 3 public demonstrations by the UC BOE of the voting machines being considered for purchase. The Hart Verity Scan and Verity Touch Writer with Access devices have been certified for use by the State Board of Election in December, 2022. The Hart machines are cost effective. The cost for each machine is \$5,000-\$6,000 including a scanner; whereas the ES&S Express XL machines are about \$9,000-\$10,000 for each of their voting machine, the Ballot Marking device, and the scanner. The Hart machine allows for paper ballot voting, the gold standard for voting. The Hart machines are secure and battery operated.

- Even if the ballot is marked incorrectly, i.e. mark outside the circle, check or X mark, the scanner will still accept the vote.
- The scanner will ask the voter if their selections are correct. If yes their vote will be counted. If no the scanner will spit their ballot out and they can request another ballot.
- Even though our electronic pollbooks prevents voters from voting twice, the scanner also does this.
- The Ballot Marking Device can be used not only by the disabilities community but also other voters who wish to use a touch screen for voting.

In conclusion the Hart machines are cost effective, efficient, safe, and secure.

I am requesting that the UC legislature approve the purchase of the Hart voting machines.

Hi, my name is Rachel Gans. I've owned a home in Bloomington for about 25 years.

My father and grandmother both received reparations as survivors of the holocaust in Hungary. My grandparents on both my father and my mother's sides have had huge impacts on my life. I also knew my great grandparents on my mother's mother's side and they impacted my life directly. I am sure that each of you can directly see impacts of your grandparents and great-grandparents on your own lives.

Why I say this is that sometimes when we speak about slavery in this country it is said that it was a long time ago, ancient history, not related to people alive today. That is unequivocally false and we can see that on a very basic level by looking at our own family history and timelines.

It's been very important to take the first step of remembering the history of this country by recognizing Juneteenth locally and then federally. That was a good step, but not close to the end of the work. We, locally and as a nation, need to reckon with the injustices of the past and need to pay reparations to the descendants of enslaved people here. There is a lot to be figured out and it's important to see California taking initial steps toward this. Let's take action here.

We cannot possibly think that just creating a holiday where some people get a paid day off (and many others don't) and have sales and things to buy will really free us from our terrible history in this country and in this very county where the slaveholders fought hard to keep slavery intact.

And we have to look at what is happening now, NYS has been slow to make progress in voting rights which disproportionately impacts people of color, NYS locked up a huge number of people, disproportionately black people, and the racist system also disproportionately denies parole to black incarcerated people. Monica Goods was an 11 year old black girl who was killed when a state police officer did not hold her life as the precious thing it was when he rammed into the car she was in, killing her. In Buffalo a racist murdered 10 people in a supermarket.

Let's imagine a different world and make real changes. Let's start with paying reparations now.

I am a registered nurse. I did not get the shot. I was infected with the initial strain of covid. I received monoclonal antibodies and faired very well. I have not had another

I am not anti-vax. I attended nursing school when iron lungs were still in use for polio patients. I know the benefits of some vaccines. Unfortunately, we were presented and coerced with an experimental injectable in the midst of a pandemic and fear was the main tool to dispense it regardless of a person's susceptibility, while treatments which showed some value were denied a place to be useful. I hope we have learned from this event, and it never happens again. I worked in infectious disease for 20 years. We knew better than this. So disheartening we didn't do better.

Our health care system was under tremendous strain at the time. Health care workers may have been grateful for the shot but that was then and not now. We are way past that. Thank you for rightly assessing the present conditions. I hope you will advocate for reasonable treatments going forward, if they are needed for any illness and continue to uphold our right to choose good medical care for ourselves.

RESOLUTION OF THE VILLAGE OF NEW PALTZ BOARD OF TRUSTEES MEMORIALIZING JUNE 2023 AS LGBTQIA+ PRIDE MONTH

WHEREAS, in June of 1969, patrons and supporters of the Stonewall Inn in New York City staged an uprising to resist the police harassment and persecution to which LGBTQIA+ Americans were commonly subjected, marking the beginning of a movement to outlaw discriminatory laws and practices against LGBTQIA+ Americans; and that LGBTQIA+ people continue to suffer discrimination, hostility and exclusion at almost every level of society, including in areas of housing, education, employment, healthcare, family law, immigration and marriage equality; and,

WHEREAS, LGBTQIA+ Pride Month has been celebrated each year since in the month of June to honor the commitment of the LGBTQIA+ pioneers who fought for civil rights in the 1969 Stonewall riots in Manhattan, a critical tipping point historically for the LGBTQIA+ community in the United States; and during this month we celebrate the progress we have made in creating a community more inclusive and accepting of LGBTQIA+ people; and,

WHEREAS, throughout much of the history of the United States, same-sex relationships were criminalized in many states and many LGBTQIA+ people in the United States were forced to hide their LGBTQ+ identities while living in secrecy and fear; and,

WHEREAS, on June 26, 2015, the Supreme Court of the United States ruled in Obergefell v. Hodges, 135 S. Ct. 2584, that same-sex couples have a constitutional right to marry and acknowledged that "[n]o union is more profound than marriage, for it embodies the highest ideals of love, fidelity, devotion, sacrifice, and family;" and,

WHEREAS, the Village of New Paltz made history in Peace Park on February 27, 2004, as the location of the first same-sex marriages in the country (outside of San Francisco) under former Mayor Jason West who was subsequently arrested, whose efforts led to widespread national public attention resulting in greater acceptance and enacted laws granting same sex marriages; and,

WHEREAS, New Paltz has been hosting the annual Hudson Valley Pride March & Festival in June for going on two decades; and in continuation of this tradition the Village of New Paltz has served as a leader in the growing Hudson Valley Pride Coalition which has planned the march and festival held in our community last year and this year on Sunday June 4; and,

WHEREAS, LGBTQIA+ people in the United States face disparities in employment, healthcare, education, housing, and many other areas central to the pursuit of happiness in the United States; and,

WHEREAS, many states have no explicit ban on discrimination based on sexual orientation and gender identity in the workplace, housing, or public accommodations, and many states have no explicit ban on discrimination against LGBTQIA+ individuals in education; and,

WHEREAS, LGBTQIA+ people, LGBTQIA+ youth especially, are at increased risk of suicide, homelessness, and being the targets of bullying and violence; and,

WHEREAS, the LGBTQIA+ community has faced discrimination, inequality, and violence throughout the history of the United States; and,

WHEREAS, LGBTQIA+ people in the United States, in particular transgender individuals, face a disproportionately high risk of becoming victims of violent hate crime and higher likelihood of being homicide victims; and,

WHEREAS, in 2009, President Barack Obama signed the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act (division E of Public Law 111–84; 123 Stat. 2835) into law to protect all people in the United States from crimes motivated by the actual or perceived sexual orientation or gender identity of an individual; and,

WHEREAS, despite being marginalized throughout the history of the United States, LGBTQIA+ people in the United States continue to celebrate their identities, love, and contributions to the United States in various expressions of Pride; and,

WHEREAS, the inclusion of LGBTQIA+ people in the United States continues to expand every day and LGBTQIA+ people and their allies in the United States remain determined to pursue equality, respect, and inclusion for all individuals regardless of sexual orientation or gender identity; and,

THEREFORE, BE IT RESOLVED that the Village of New Paltz Board of Trustees declares June 2023 LGBTQIA+ Pride Month and memorializes it as such in this resolution, as a symbol that we stand as allies in an intersectional LGBTQIA+ movement that continues to struggle with ongoing issues of racial and economic justice, and challenges to civil and human rights; and,

BE IT FURTHER RESOLVED that the Village of New Paltz Board of Trustees stands committed and united to help break down the walls of fear and prejudice, and will work to build a bridge to understanding and acceptance until all LGBTQIA+ peoples are afforded the same rights and responsibilities as all Americans; and,

BE IT FURTHER RESOLVED that the Village of New Paltz Board of Trustees hereby calls upon residents, employers, public officials, and all community members to work together to promote equal rights for all, regardless of sexual orientation or gender identity, and does further encourage all to observe the month of June with appropriate programs, ceremonies, and activities that celebrate our diversity and recognize LGBTQ+ Americans whose many and varied contributions have enriched our lives; and,

BE IT FURTHER RESOLVED that the Village of New Paltz Board of Trustees commends the Ulster County Legislature for introducing the Drag is Not a Crime Act which would expand the existing Human Rights Law to include gender expression as a protected category from discrimination; and

RESOLVED, that the Village Clerk is directed to send a copy of this resolution to U.S. Senator Kirsten Gillibrand, U.S. Senator Charles Schumer, U.S. Congressman Pat Ryan, Governor Kathy Hochul, State Senator Michelle Hinchey, State Assemblymember Sarahana Shrestha, NYS Senate Majority Leader Andrea Stewart Cousins, NYS Assembly Speaker Carl Heastie, County Executive Jen Metzger, City of Kingston Mayor Steve Noble, Ulster County Legislative Chair Tracey Bartels, Ulster County Legislator Trici Bowen, and Ulster County Legislator Megan Sperry.
