1. <u>Kathy Germaine, Rupco VP of Housing Services</u>: Ms. Germaine provided a project update of the current CDGB county wide housing rehabilitation program awarded in 2013. Eleven units are completed whereas the full twenty units will be completed by the December 19<sup>th</sup> contract deadline. The County is requesting a contract extension to use the remaining funding to assist additional homeowners which would equate to 20% over their initial goal. Rupco is currently administering a first time homebuyer program through CDBG for \$500,000. Ms. Germaine provided her written comments to the Clerk to be included in the official minutes.

Ulster County Legislature Public Hearing Tuesday November 18, 2014 Community Development Block Grant for Disaster Rehab Given by, Kathy Germain RUPCO Vice President of Housing Services

Good evening, I am Kathy Germain, Vice President of Housing Services at RUPCO and here to provide you with an update on the progress of the current CDBG County-wide housing rehabilitation program awarded in 2013. This program is to complete 20 substantial or moderate rehab projects giving priority to disaster related properties.

We have completed 11 units and will have completed 20 completed units by our December 19th contract deadline. The County is in the process of requesting a contract extension that will allow us to spend the remaining funds to assist other homeowners.

This extension will allow Ulster County complete up to 25 projects, 20% over initial goal. It is also important to note that 60% of all units assisted received energy improvements that will provide ongoing relief in energy and utility costs.

It has been over three years since the county was devastated by Hurricane Irene and Tropical storm Lee, I know all you all have memories of the storm and its lingering effects. This program assisted 11 homeowners that are still living with damage from the storms. Many living in homes with health and safety issues from water damage, mold, flooded utilities, as well as septic's and wells that needed to be replaced.

Although we have lots of experience with housing rehabilitation programs, the Disaster related projects were more complex requiring additional time and contractors in specialized trades to complete. And while we anticipated more oversight and time to complete construction we encountered a higher level of homeowner anxiety and in some cases had to mediate issues with insurance companies.

The benefits of this program go well beyond the homeowners that were assisted. Potential benefits include an increase in property values, ongoing savings from energy improvements and jobs for local contractors. But the people we are able to help are the most important. I wanted to share one profile of a homeowner we assisted through the program.

We are currently administering a first time homebuyer program through CDBG for \$500,000. We have already closed on one home and have a couple of more transactions underway. Please feel free to refer your family, friends or constituents. Thanks for your time and service for Ulster County.

**PUBLIC COMMENT:** There were (10) ten speakers signed up for public comment.

- 1. <u>Elliot Auerbach, UC Comptroller</u>: Mr. Auerbach justified his department spending as an investment not an expense, and respectfully requested the legislature reject Amendment 10 of the 2015 proposed budget.
- 2. <u>Iris Marie Bloom, Rosendale</u>: Asked for the legislature's help to have the Pilgrim Pipeline stopped or be routed elsewhere. Ms. Bloom felt the pipeline has no value to Ulster County only potential harm. The proposed 178-mile Pilgrim Pipeline would run in part along the Thruway corridor carrying Bakken crude, refined gas and diesel from Albany to Linden, N.J.
- 3. <u>Susan H. Gillespie, Rosendale</u>: Ms. Gillespie represents Citizens of Local Power Co. Also spoke against the Pilgrim Pipeline passing through our community. Town of Rosendale has passed a resolution to avert the pipeline.
- 4. <u>James F. Mooney, Saugerties</u>: Mr. Mooney is a teacher and parent of a special needs child who spoke against the Common Core State Standards Initiative – Resolution No. 350. Mr. Mooney thanked Legislator Allen for his support.
- 5. <u>Bernie Ruderman, Tillson:</u> Mr. Ruderman spoke against the Pilgrim Pipeline. Mr. Ruderman received a knock on his door from a pipeline representative who wanted to survey his property and was told he had no say in the matter. The rep tried to intimidate Mr. Ruderman who warned him he would receive a letter from an attorney.
- 6. <u>Karen Markiseuis, Kingston</u>: Ms. Markiseuis signed up for public comment but was not in attendance when her named was called.
- 7. <u>Michele Hirsch, Kingston</u>: Ms. Hirsch also spoke to repeal Common Core Standards.
- 8. <u>Jolyn Safron, Hurley</u>: Ms. Safron also spoke to repeal Common Core Standards. Ms. Safron also spoke about the issue during the October Session public comment period. Tonight Ms. Safron focused on the financing of testing.
- 9. <u>Becky Thompson</u>: Ms. Thompson spoke in support of Resolution No. 407, A Local Law Respecting the Outdoor Restraint of Companion Animals. Ms. Thompson shared her involvement with a previous neighbor expressing strong feelings towards the passage of this local law.

- 10. <u>Elizabeth Broad, Kingston</u>: Ms. Broad works for The Catskill Mountain Keeper. Ms. Broad spoke in opposition to the Pilgrim Pipeline. Ms. Broad asked the legislature to please consider becoming involved by educating their constituents.
- 11. <u>Cory Newton, Wawarsing</u>: Mr. Newton expressed recommendations he would like to see made to the Ulster County Charter. Mr. Newton provided his written comment /recommendations to the Clerk to be added to the official minutes.

Article 1 Chapter 5 of the Ulster County Charter says "any person may make recommendations at any time to the County Legislature for amendments to the Charter."

The changes I am about to propose to the Financial Procedures contained in Article 4 will reduce the amount of political leverage available to the Executive's Office, by requiring it to reveal information.

The use of asymmetric information in the budgeting process, essentially steamrolls the legislature and the people into accepting the executive budget with only slight technical modifications.

Unless these budgetary process issues contained in the charter are fixed, Ulster County will be unable to diversify its growth path from its critically flawed economic development, tourism, recreational trail, and casino gaming anti-strategy .

That being said I propose amendments to Article 4 Chapters 33, 34, and 35 of the Ulster County Charter.

Article 4 Chapter 33 is filled with technical jargon that codifies the outdated line item departmental budgeting method, which began to be phased out in the 1930's. Article 4 Chapter 33 should be amended in order to reject line item departmental budgeting and institute a system of performance measurement and outcome based budgeting established by the legislature, which the County Executive, department and program heads must adhere to. Performance measurement and outcomes should be based on the mission statements and goals of the departments and programs and whether or not these objectives are being met.

Article 4 Chapter 34 concerns the submission of the County Budget. Article 4 Chapter 34 should be amended to require that the proposed executive budget be submitted in an Excel Spread Sheet format and published to the internet. Excel Spreadsheets are a common format utilized by those who have adopted outcome based budgeting.

Article 4 Chapter 35 concerns the Executive's County Budget Message. Article 4 Chapter 35 should be amended to require the Executive to produce a detailed list of all state mandated programs and departments, an accounting of state and federal aid associated with these mandates, and an accounting of the county funds used to supplement these mandates within an established system of performance measurement and outcome based budgeting.
