**PUBLIC COMMENT:** There were five speakers signed up for public comment.

- 1. <u>Hon. Michael F. Conners II, Albany County Comptroller</u>: Mr. Conners spoke in support of UC Comptroller Elliott Auerbach and his office and the importance of not cutting the watch dog's staffing from the 2017 budget. Mr. Conners as a previous Albany county legislator and current comptroller shared some experiences from his area.
- 2. <u>Hon. Robert Antonacci, CPA, Esq. Onondaga Comptroller</u>: Mr. Antonacci also spoke in support of UC Comptroller Elliott Auerbach maintaining funding for his office to perform their oversight duties.
- 3. <u>Hon. Elliott Auerbach, UC Comptroller</u>: Comptroller Auerbach shared some remarks spoken at the Ulster County Chamber of Commerce breakfast in support of his office. Comptroller Auerbach introduced his staff and defended his resolve to maintain his staff of seven.
- 4. Mike Dovich: Mr. Dovich spoke in favor of preserving the Comptrollers staff.
- 5. <u>Howard Baul, Kerhonkson</u>: Mr. Baul is a labor relations specialist for CSEA and an Ulster County resident for most of his life. Mr. Baul expressed his concern eliminating positions in the Comptroller's office noting the need for oversight of county business.
