PUBLIC HEARING ADJOURNED: 6:15 PM

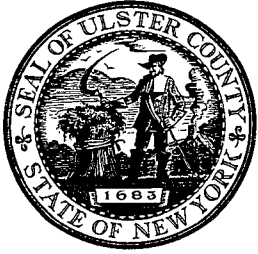
