1. Cory Newton, Wawarsing, NY: Mr. Newton shared his research/fact checking with the State Comptroller and State Finance Office's with regard to the proposed budget loss of \$5.4 million in state sales tax revenues. Mr. Newton stated the budget numbers are inconsistent with his findings. Mr. Newton recommends a fact sheet be integrated as part of the budget documenting everything mandated from the state and federal government.
