Mr. Dener shared the story of Mr. Ron Steinman. After a long search and more than two years on dialysis, the award-winning author and longtime NBC correspondent finally found a living kidney donor. Chairman Donaldson

Any opposed, none, carried. At the same time, there are various communications on file, including detail message of Resolution Number 95. Along with committee reports, and annual reports by the Comptroller, memorializing letters and so on. Make sure you get a chance to read through those if you have not already. Tonight, I am, it's my pleasure to give the privilege of the floor this evening, to a long friend of mine and yours, Butch Dener. As a liver transplant recipient himself, Butch has been joining us for more than a decade to raise awareness and advocate for registering as an organ donor. Because of COVID last year, Butch had to record a video to share with us. But as you can see, he's here with me tonight, in Chambers. I think this is a testament to how far we've come since last year and proof of what Ulster County and the amazing people who live and work here could accomplish when we work together. And I say take it away Butch.

Butch Dener

Thank you, Mr. Chairman. Chairman Donaldson and I go way back to the 70's in our running days in the Ulster County Community College. It's an honor and privilege to be with you again Chairman. I'd also like to thank Victoria Fabella and Jay for their exceptional help and encouragement to getting this done. And live as it, as it may be. I'm used to looking out and seeing my friends out there. I still see my friends but there's just a lot less of it.

April is organ donation Awareness Month. As some of you know, I'm 15 years post liver transplant. I was working with Levon Helm my old boss on a movie in Hazard Kentucky and I was getting sicker and sicker by the day. But I just put mine aside because we were having so much fun making that movie with Steven Seagal in the coal mine hills of Kentucky. But one night in Seagal's house I got so sick I had to go to the emergency room. And the excellent doctors of Hazard Kentucky miss diagnosis me. They thought I had leukemia and they were going to start chemotherapy which would have killed me the very next day in Hazard Kentucky. Can you picture me in Hazard Kentucky? So thankfully, Levon and Seagal Steven, air

lifted me back in New York. And the doctor came in and saw that I wasn't dying of leukemia that I had advanced liver failure with hepatitis C. And Dr. Book, a local gastroenterologist came in and brought me back to stability. I had about seven liters of fluid that was built up from this disease. I was so sick, they put me on antibiotics and blood transfusions for a week. And they brought me back to stability. And then I languished on the list, they call it. A list of people waiting for a transplant. And you have no idea what that's like, eight years just getting sicker and sicker. And if it wasn't my amazing wife, Barrie who kept me going and never gave up. It's a long eight year believe me.

There's 112,000 people in America on that same list right now. 9000 of them are your neighbors here in New York. Many of us know people waiting for a transplant, could be a kidney could be a liver. It could be a cornea transplant like Mandy Patinkin has. Or it could be lungs, it could be a heart it could be almost anything. There is 112,000 people who are languishing on that list. And if you don't know what it's like to wait every day for a miracle of life, it's really heartbreaking. But thankfully, after eight years, I got a miracle. My donor Frank Matera, Frankie, I say his name every day, and I live like he's watching me. Because I live because of his family's generous donation. And there are other donor families who feel that way that their loved ones live on in the people who've been transplanted with their organs. But here in the COVID era, it's so much more difficult, because the hospitals are pretty much closed or elective surgery even though it's lifesaving surgery to get a transplant and living donors pretty much dried up because nobody wanted to go to the hospitals.

My focus has really shifted from signing up to be an organ donor when you pass away, which you can still do. You can still sign up at .org or live onny.org or registerme.org. You can go downstairs to Nina Postupack, our wonderful County Clerk to her DMV, and her proactive staff is signing up organ donors every time they come in whether you get a permit or a change of license plate, they are very proactive. And I thank Nina and your staff for being so helpful. But hopefully when you do sign up it'll be many years before you pass and before we need to get your organ's. So I'm an impatient now I'm getting older of 71 now and I want to see these miracles of life before my eyes. So, living organ donation, the liver and the kidney are two easiest organs to donate while you're alive. Here in Kingston Tara Salerno, her husband Jake you may know as a state trooper. Tara gave a piece of her liver to her sister Tiffany a few years ago. (inaudible) Now they're both wonderful. Her sister Tiffany who received the new liver is now a liver transplantation type nurse who's helping people. So, the circle goes on.

Marianne Kazi of New Paltz gave a kidney to her, her uncle. We have a family in New Paltz, amazing family, the Jamal family. Thank you, Jamal. You may know the mobile stations and their son Camille. 10 years ago, Camille gave his father his kidney and it was part of five families circular transplant when they were five families with donors and five families with recipients and there were 10 transactions of the kidneys and all those families. Ten years later Camille is a convenient deli and Vicki in New Paltz is just thriving and their families they have children. It's just a beautiful thing. And I have a friend really brings it all home.

I've been speaking here before you all for so many years, telling the stories, I've had people here. And then every time you hear the miracle of life, you just get choked up. My friend Ron Steinman, those of you like me, and Dave who lived through the Vietnam era they remember Ron as a reporter embedded in Vietnam. And he's gone on to write books about the women who served in Vietnam. The heroes that

so often their stories don't get told. So I'm telling his stories through his television documentaries and books. He's 86 years old. He's a father and grandfather, great grandfather, he needed a kidney, what are the chances of getting a kidney at 86, slim and none through the program that you (inaudible) being on the list. 86 year-old people don't get those kidneys. We put it out on social media. And if you want to read about COVID and transplantation, go on LinkedIn to Ron Steinman, and read about his dialysis through the COVID era, "Year of Dialysis." It's such a brutal process, but he keeps them alive. It's really a lifesaver when you can get the transplant. And just this past week Ron got an anonymous living donor, he got his kidney. And he's recuperating strongly and healthy in New York City. And we say God bless Ron that we honored you, because you're a living example of how life is so important. It's so fragile. And whoever your donor and donor family is synonymous right now, hopefully, they'll find out but either way. Donor families are truly angels that walk amongst us.

So, my friends you want to do right, you want to give something back, consider helping somebody in your community who's dying, waiting for a transplant. Just call Westchester Medical and speak to the transplant patient unit and they will certainly be talking to you and bringing you in. There's no cost to the donor. You're back and out in public in six to eight weeks, and it's relatively easy procedure to save a life. Wouldn't you like to see the face of the person whose life you saved? Everybody wants to do good. Everybody wants to leave a legacy. Leaving a life is a great legacy.

So, my friends, you can go to donate life New York state.org sign up, you can go to register v.org or you can do it now to be a living donor either way saves lives. Look at me. I felt the September 11 memorial in my town. I did some other things. I certainly the elections for many years. And I'm just overjoyed. A few years ago, my granddaughter was here and she spoke on organ donation because she wouldn't have known me if it wasn't for Frankie Matera.

So, I want to say thank you to the chairman for the privilege of speaking before this (inaudible) body. I have many, many good memories of my friends here through the years and Jay and Vicky thank you very much for all your help. Please when you get back to your districts be a hero. Talk up organ donation - it saves lives. Thank you, and God bless.

Chairman Donaldson

And I make something clear too before you go Butch that everybody, please sign up. It's easy to when you never know you might be in a car accident you may be able to even know your life may end, you may be able to save a number of people - various transplants. Butchie got me quite a while ago. Normally, if this was in, if we were in person here everybody, he would be handing out the forms. And everybody would get a forum. That's how he got me and that's how he got a number of other people. The forum was there and I'm looking at it and I said well, how can I not do this? But anyway, I'd like to present a proclamation to Butch and I'm gonna have before I present the proclamation I'd like to have the Clerk of the Legislature just read the first three paragraphs of it.

Clerk Fabella

Absolutely. Whereas, giving life to another by donating an organ or tissue transplant is one of the most selfless human acts that can provide the donor a quiet inner fulfillment in the knowledge that he or she may one day help save a life bringing joy and hope to another person in their family who depend on the

generosity and sacrifice of others. And Whereas, in Ulster County 51% of all residents 16 and older have joined the New York State donor life registry, statewide 42% and nationally 60% of people are registered organ donors. And Whereas, a person who donates organs can save up to eight lives a tissue donor can improve 12 or more lives by restoring eyesight, fight infection in burn patients and preventing the loss of mobility and disability and it goes on. And in the end, it says Now Therefore, David B. Donaldson, Chairman of the Legislature does hereby proclaim the month of April as "Ulster County Donor Awareness Month."

Chairman Donaldson

Thank you Butch for coming always a privilege buddy, always a pleasure to see you.

Butch Dener

My honor and my privilege. Thank you very much.

Chairman Donaldson

As I said, Butch and I go back actually probably I think it'd be about 1969 or so.

Legislator Bruno

I was nine years old.

Chairman Donaldson

We go back quite a way. I met him in New Paltz.

Legislator Bruno

Heidi, you (inaudible)

Chairman Donaldson

Before we back to the business at hand I also want to take a second to let everyone know that April is also National Autism Awareness Month. Since we're not out of the COVID woods yet, the Annual Greater Hudson Valley Walk usually held in April has been postponed to September. This year's Walk on Wheels is being conducted through an in person interactive car parade as well as a virtual walk. So now into public comment.

Clerk Fabella

We actually have no speakers signed up through call in studio this evening.

Chairman Donaldson

Why those tacos are looking good. I'd be able to get them. Alrighty then with no one signed up, then just start with resolutions. So long Butch.

Legislator Heppner

Thank you, Mr. Chairman. I would like to make a motion with the consent of Leader Ronk to move Resolutions 176, 184, 185, 192, 193, and 194 from non-consent to consent.

The first resolution in non-consent this evening is Resolution 92, Authorizing the Chair of the Ulster County Legislature to Execute an Agreement with Ulster Performing Arts Center for the 2021 Appropriation Legislature.

Chairman Donaldson

On the issue.

Legislator Heppner

On the issue, we are a short yes.

Legislator Parete

I'd like to speak about it, Mr. Chairman.

Chairman Donaldson

Legislator Parete.

Legislator Parete

Yes. I find this, I can't quite figure out the motor for a discharge motion for a seemingly innocuous resolution run to benefit a multi-million dollar facility that has nothing to do with the COVID pandemic. The judicial Christian values of clothing the naked, housing the homeless and feeding the hungry. But I am hearing it has something to do with maybe some distorted definition of fiscal responsibilities. I am going to speak out as loudly as allowed against this resolution, which is subsidizing a \$14 million dollar

net worth tax exempt business that has been shuttered for over a year. The UPAC building is assessed at \$3.3 million and pays no school taxes, no city taxes, no county taxes. They don't pay any sales taxes. As a matter of fact, in the federal 990 form, they don't even contribute to the police and fire in Kingston when they're having a performance. The 990 form also illustrates very interestingly, the Board of Directors and its endowment contributors. The very, very, very definition of success. I'm gonna, I'm gonna embellish this a little bit no not embellish it, but just a stone's throw from the door of UPAC and Broadway, there's Little Italy, a business opened and closed over the last year. There assessed at around \$700,000 and paid \$48,000 in taxes. Just across the creek is a DEP building, assessed at \$3.3 million. They pay over \$120,000 in taxes. You can look up town towards the scholar building your downtown toward the Phone Company building. Something's wrong. What about the beauty shops that are closed, the restaurants, tour guides, people unable to pay their mortgage. The worst part is that these folks, UPAC, the CEOs got to be got to be stone deaf, with all the problems out there. For a CEO to be out shilling for a member item is disgraceful in my in my opinion. Feed the hungry, clothe the naked and house the homeless. This is a building that houses a theater. You know as a side note in December of 2019, because we've been one active, two dinner theaters in this place up here. I contracted to have a show. I had to pay for, the we had to pay for the script and the permission to do it and deal with the director and the actresses and actors and the lights and the props. We haven't been able to do it. I suppose I could come in as a sponsor of the arts and ask you help me pay my electric bill, but you'd throw me out the door. You'd laugh at me. But I'll bet I've done as much for my community as the CEO at UPAC has done. I'm going to say any and obviously, I'm going to vote against this because it's just absurd. But it's going to be interesting to me in the end to see who gets invited and how-who gets invited and why they get invited to the casting party when Chita Rivera and Bruce Springsteen show up. Because many, many are called but free were chosen. I cannot understand the rationale behind this. When so many people suffering that were given money for electric lights? Thank you, Mr. Chairman.

Chairman Donaldson

Legislator Fabiano.

Legislator Fabiano

Thank you, Mr. Chairman. You know, when I first went to the legislature about sixteen, and a half years ago, I met a legislator who was there and at that time, I believe he was the chairman of the Ways and Means Committee. His name was Alan Lomita. And I was unfamiliar with outside agencies funding. Back in those days, there was quite a bit of it. And a lot of these outside agencies, were getting quite a bit of money. So I asked him about it. And he took the time to explain it to me. He said, Dean, I want to tell you, he said these outside agencies were created to get certain things off the ground. But once they were off the ground and became self-sustainable, they were to be removed. For a long time. I didn't see that happen. Over the years, I came to the conclusion, now, you go to UPAC to see a show, you pay anywhere between \$65 and \$120 per ticket. It's a business. And for them maybe not so much now with the pandemic. But prior to the pandemic, they've been a lucrative business. Personally, I think the only outside agencies that we should be funding especially at this time, is outside agencies like People's Place, Ulster County Community Action, Family of Woodstock where there's a direct sending of money and sending of food and clothing to people who are in need. So, we you know, especially now when the money is tight, and so I'm gonna have to be it no i this and then in the future, I think we should just focus on eight outside agencies that are helping the community in need. Thank you.

Chairman Donaldson

They do that on their dime. And they typically do that once or twice a year. So, a really important part of the experience of some inner-city children in the City of Kingston, that, as I said, many of them, you know, children of color, that many of them that within that area would never see a ballet. And some of them take up ballet after that, because they see this. So that's, that's one of the things that we're doing with these types of money. And when it comes to the arts, the arts are essential. Many people work in the arts. Many people are starving in the arts because the money's not there because they can't put on the shows. Just like you know, people that were cutting hair were having trouble. We need to look at everybody and make that consideration when we're looking at funding things. When we fund the arts it's unbelievable what that money goes to when you take a look at it. I've been to a couple of the presentations and what they you know, the people that are so grateful of getting small grants as they you know in other words for instance, the percussion group in Kingston got a small grant from the from the Mid-Hudson Arts that we brought in. So, I understand we have to feed the hungry and clothe the naked. But that's part of feeding the hungry and clothing the naked is the Arts also. So I'm a happy, I'll vote yes.

Thank you. So you know, the reason why we're here tonight doing this is because in Ways and Means I voted no. And then I was reminded afterwards that this was part of a collective agreement with other things that the Legislative Programs funds, and this was a compromise. I struggled again with this. I agree pretty much everything Legislator Parete said. I have a very hard time with voting yes for this. But because we did agree as a package with everything else that got approved with things that I felt that were more important. I guess I have to vote yes. But I'm very, very uneasy about this. It's one of the hardest ones that I'm going to vote for that I really do not stand by. So I will be a yes unfortunately.

Some of that I'm going to be it's going to be used, obviously, for paying off some of the bills that we got because of COVID. But there's going to be significant amounts of money that is left, and it has to be spent, it cannot be used to lower taxes. So what I'm asking every committee chairman, and the vice chair to do is have these discussions to each one of the committees in your jurisdiction, whatever the jurisdiction of your committees sees on how that money might be able to be used there, in some of those. I also want each of the caucuses to do the same. Have these conversations. We need to be able to get on the same page eventually. We are having a discussion with your county executive on Friday - more of a brain storming session very quick though. We're going to put together a task force. The Task Force on our side will be made up of the way the executive's branch wanted it in. I think, you know, as long as we had representation, it would be the chairman, the minority leader and the majority leader, or designees, if they wish. But the point is, every one of you will have a say and I want that discussion to be taken in the committee's, I really want a very healthy discussion on where the monies might be used very effectively, and do something that will last you know, for a very long time. So we know we have some items that we're thinking about, of course, but there are other items that we may not be thinking about. I mean, we have a problem here that is one of the nicer problems I've ever had. But it is a, no we're actually going to figure the best way of doing this and I wanted to do it as a team. Because it really is going to - it's an opportunity that will never I can never see is coming again. Its first time it's ever happened in my lifetime. And I don't see happening too often. So we really want to get this right and spend this money in the best possible way. As I said, each of the committee's, please bring this up. Have a discussion with it. However you wish to go with that. But I really, and come back, make sure that the task force will make sure that you're tied into them the task force members. So that's about all I really want to say with that. And now I will have Legislator Haynes read the memorials.
