- 3. <u>Eli Kassirer, Gardiner</u>: Mr. Kassirer spoke in opposition of any CARES ACT funding budgeted for vaccines or to businesses requiring the general public to show their "vaccine papers" in order to enter the establishment.
- 4. <u>Lauren Piperno, Town of Kingston</u>: Ms. Piperno agreed with the previous speaker and added concern that the pandemic is being used as a stepping stone for government control. First being forced to get a vaccine, then forced to get a passport, then a social credit score will be created forcing you to obey government and ultimately the government can then deny you food, medicine, housing and travel. Democracy is at stake.
- 5. <u>Phil Erner, Kingston</u>: Mr. Erner shared he is a candidate for county legislature. He noted vaccines are saving lives and urged people to remember to take care of each other public health safety.
