**BE IT ENACTED**, by the County Legislature of the County of Ulster, New York, as follows:

#### SECTION 1. LEGISLATIVE INTENT.

The Ulster County Legislature finds that Article XXXIV of the Ulster County Charter, Periodic Compensation Review Committee §C-110 and §A34-3 of the Administrative Code should be amended to provide that any salary modifications for members of the Ulster County Legislature enacted by local law pursuant to those sections be effective only after the commencement of the next ensuing legislative term of office after said local law was enacted.

## **SECTION 2.** §C-110 (Duties) of the Ulster County Charter is hereby amended to read as follows:

At the call of its Chairman, the Committee shall review the salaries of all elected officials of the County of Ulster at least every second year after its first meeting. In the course of its deliberations, the Committee shall hold at least one public hearing and shall otherwise provide ample opportunity for public comment. The Committee shall provide its recommendations and the rationale for them to the County Executive and the County Legislature no later than June 30 of the same year in which it convened, except that the Committee shall not make recommendations concerning compensation of elected officials for whom, by law or judicial determination, the County Legislature does not have the power to fix compensation. Immediately upon their delivery to the County Executive and the County Legislature, the recommendations of the Committee shall be filed with the Clerk of the Ulster County Legislature and posted on the County website. All changes in salaries for elected officials shall be made by local law, provided that any such local law effectuating changes in salaries for members of the Ulster County Legislature shall have an effective date commencing with the next ensuing Legislative term of office.

**SECTION 3.** §A34-3 of the Administrative Code is hereby amended to read as follows:

At the call of its Chair<del>man</del>, the Committee shall review the salaries of all elected officials of the County of Ulster at least every second year after its first meeting. In the course of its deliberations, the Committee shall hold at least one public hearing and shall otherwise provide ample opportunity for public comment. The Committee shall provide its recommendations and the rationale for them to the County Executive and the County Legislature no later than June 30 of the same year in which it convened, except that the Committee shall not make recommendations concerning compensation of elected officials for whom, by law or judicial determination, the County Legislature does not have the power to fix compensation. Immediately upon their delivery to the County Executive and the County Legislature, the recommendations of the Committee shall be filed with the Clerk of the Ulster County Legislature and posted on the County website. All changes in salaries for elected officials shall be made by local law, provided that any such local law effectuating changes in salaries for members of the Ulster County Legislature shall have an effective date commencing with the next ensuing Legislative term of office. The Periodic Compensation Review Committee shall keep minutes of all meetings, including the date and time of meeting and members in attendance. The original of said minutes shall be filed with the Clerk of the Legislature as soon as possible, but not to exceed 10 business days after the next regular Committee meeting at which the minutes were reviewed and accepted. The Clerk of the Legislature or his or her designee shall maintain an official record of the Committee's agenda items. This official record shall include the disposition of each agenda item, including individual votes of each member on each item.

## **SECTION 4. SEVERABILITY.**

In the event that any portion of this local law is found to be invalid, such finding will not have any effect on either the remaining portions or applications of this local law or any provisions of the Ulster County Charter and Ulster County Administrative Code, which shall remain in full force and effect.

#### **SECTION 5. EFFECTIVE DATE.**

This Local Law shall become effective upon its filing with the New York Secretary of State.

## A Local Law To Ensure the Safety of Vulnerable Road Users in Ulster County

**BE IT ENACTED,** by the County Legislature of the County of Ulster, New York, as follows:

## **SECTION 1.** TITLE.

This Local Law shall be known and referred to as the "Ulster County Safe Passing Law".

## **SECTION 2.** LEGISLATIVE INTENT AND FINDINGS.

This Legislature finds and determines that it is the duty of Ulster County to protect the health, safety and welfare of its residents. This Legislature also finds and determines that many Ulster County residents ride bicycles for exercise, recreation, or as a primary mode of transport.

The Ulster County Legislature recognizes that bicyclists, pedestrians, and other vulnerable road users often need to share roadways with motor vehicles out of necessity. The Legislature also acknowledges that in these situations, vulnerable road users are susceptible to the actions of motor vehicle operators who can pose a threat to their health and safety if passing too closely or from the right side of the road.

Therefore, this Legislature finds it necessary to establish a minimum passing distance for motor vehicles approaching or passing vulnerable road users and to penalize those who disregard their safety.

## **SECTION 3. DEFINITIONS.**

As used in this local law the following terms shall have the meanings indicated:

- A. "Vulnerable Road User" ("VRU") shall mean any of the following:
  - 1. A pedestrian
    - a. An individual in a wheelchair or other device driven by muscular or any other kind of power that is designed for and used by a person whose mobility is limited by one or more conditions or functional impairments;
    - b. Persons using service animals, plus the animal itself;

- c. An individual waiting to board, or just having alighted, mass transit including but not limited to a bus, taxicab, shuttle, train, ferry and streetcar;
- d. Any other individuals existing upon a roadway and outside of any vehicles;
- 2. Any rider of a horse, mount or other animal, plus the animal itself;
- 3. An individual who is on the highway because the individual is engaged in construction, maintenance, repair or a similar function while on that part of the highway;
- 4. An individual who
  - a. is an emergency-services personnel, and
  - b. is acting in the course of their duties, and
  - c. is not in or on a motor vehicle, streetcar or other motor vehicle running only upon rails, motorized snow vehicle, traction engine, farm tractor, self-propelled instrument of husbandry or road-building machine;
- 5. An individual on a bicycle or on a motor-assisted bicycle;
- 6. A person who due to race or economic disparity has been excluded from the expectation of safe, accessible transportation.

## <u>SECTION 4.</u> MINIMUM DISTANCE REQUIREMENTS FOR MOTOR VEHICLES PASSING VULNERABLE ROAD USERS.

The operator of a motor vehicle that is approaching or overtaking, from behind, a VRU on the same side of the road shall pass to the left of such VRU at a distance of at least three (3) feet until safely clear thereof. The three-foot distance requirement shall not apply on roads with clearly marked bicycle lanes as defined by New York Vehicle and Traffic Law § 102-a.

A. Any person committing the above-referenced offense shall be guilty of a violation and subject to a fine not to exceed \$225 for a first offense, \$325 for a second offense and \$425 for any third or subsequent offense(s).

B. This section does not preclude a person from being charged with, convicted of, or punished for any other violation of law.

#### **SECTION 6. SEVERABILITY.**

In the event that any portion of this Local Law is found to be preempted by state law, or otherwise invalidated, such finding will not have any effect on either the remaining portions or applications of this Local Law or any provisions of the Ulster County Charter, which shall remain in full force and effect.

## **SECTION 7.** EFFECTIVE DATE.

This Local Law shall take effect upon its filing with the New York State Secretary of State.




Dear Ms. Fabella,

Hello,

I urge the legislature to pass Local Law #3 of 2025, regarding an established safe-passing distance of three feet, providing enforcement and signage for the change.

Too often, a "bike lane" is a shoulder or other non-separated means for bicycles to travel alongside motorized vehicles: due to this, I highly recommend the removal of exceptions for roads with bicycle lanes.


Whenever possible, a motorist should yield an arms width when passing a bicycle; if there's an incoming vehicle, said motorist should wait until it's possible to pass safely with a 3-foot gap.

I've encountered too many close calls and ended up with drivers being upset at me for simply being present. Please continue to push action to protect cyclists, pedestrians, wheelchair users and all vulnerable road users, such as providing an adequate link from the end of the Wallkill Valley Rail Trail

into the City of Kingston; the Town of New Paltz has recently completed a separate bike path for their portion of the Empire State Trail, and completing this corridor is a necessary next step.


Hi Abe (Vicky and Michael cced),



Hello Legislature, my name is Jonquil Mark and I wanted to voice strong support for Resolution No. 143.2 to help protect our Vulnerable Road Users.






