We want to help Ulster County take real ownership of its waste - handling it locally instead of sending it to other communities that end up dealing with the environmental and health impacts. If we're serious about sustainability, that has to include taking responsibility right here at home.

There's a lot we could say about where things stand today, but for tonight, we are focused on one clear point: Ulster County should not support incineration or so-called "waste-to-energy" projects - whether they're proposed here or somewhere else. These facilities pollute the air, harm the communities around them, and get in the way of smarter, long-term waste reduction. They're run by companies that make money by burning more trash - not less - and that works directly against efforts to recycle, compost, and reduce waste at the source.

We don't have to look far to understand the risks. The same facility we believe some of our Ulster County Legislators toured recently - Reworld Hempstead, formerly known as Covanta Hempstead - was ordered by the New York State Department of Environmental Conservation (DEC) to pay nearly \$880,000 in penalties and environmental benefit funds for years of improper ash handling. As the DEC put it, "Reworld's violations underscore the importance of stringent oversight of waste-to-energy facilities and the need for responsible, lawful management of waste byproducts."¹

These violations followed a review of long-standing mismanagement, including issues first raised in a whistleblower lawsuit more than a decade ago. It's a powerful reminder that so-called "waste-to-energy" isn't the clean, safe solution it's often made out to be - and a clear warning about the risks of following that path.

Back in 2020, the County adopted a Solid Waste Management Plan that set out a zero waste vision - and importantly, it didn't include incineration. That plan was a step in the right direction, and it's still the right foundation to build on. We shouldn't lose sight of that now.

Right now, the Ulster County Resource Recovery Agency is working on a Zero Waste Implementation Plan. That's a great step. But for it to make a real difference, the County needs to finalize it, release it to the public, and include a clear, accountable timeline. That way, everyone - residents, legislators, and community groups - can stay informed and engaged.

We also need to focus more on cutting waste before it even gets into the system. According to UCRRA, "It's estimated that as much as 30% of the waste stream is compostable. In Ulster County, that equates to about 30,000 tons of organics that could be diverted through composting." If we're really serious about managing our waste responsibly, we need to move toward mandatory composting. With enough education and public awareness, there's every reason to believe the community will support this. A little effort from residents can make a big dent in both the waste stream and in our wallets. It can also build public confidence in

identifying a suitable site - unlike the currently proposed location in Wawarsing, which should be taken off the table - for a modern landfill that truly serves as a last resort.

We should also consider “pay-as-you-throw” programs - used successfully in many communities - which charge households based on the amount of non-recyclable trash they produce. Much like a utility bill, it rewards people who generate less waste and gives everyone a financial reason to reduce, reuse, and compost more. It’s a practical tool that fits well within a broader zero waste strategy.

If we want to get away from a throwaway culture, it’s going to take some smart planning and a shared commitment - but it’s absolutely within reach. Ulster County has a real opportunity to lead the way, and we can all be part of making that happen.

In 2020, Ulster County adopted a Solid Waste Management Plan with a zero waste vision that didn't include incineration. That's the path forward. We must support it.

The County is developing a Zero Waste Implementation Plan, and it must be finalized and made public with clear timelines. We must also push for mandatory composting, which could divert 30,000 tons of organic waste annually, and explore "pay-as-you-throw" programs to reduce waste at the source.

RE: What we Throw Away

Garbage, waste—what we throw away—is already an undeclared public health problem. There is no “away” in throw-away. The sheer volume of waste is an ever-rising tide washing over us. That’s why we are here tonight. The UCRRA is not our enemy for not cleaning up our mess fast enough and making it disappear; rather, the RRA is our county’s indispensable ally and partner in ameliorating waste.

Incineration is not the solution. It poisons our air with deadly gasses and shovels it toxic ash on landfills. A county-based landfill, which some people still refer to as a “dump,” is not a dump if citizens are willing to take the stink out of garbage by diverting all organics into composting and mulch. That will take a major change in behavior, not all of it voluntary. What if most of us used our 19 transfer stations, going back to dual-stream recycling, so that paper and cardboard (now about 32% of MSW) would not be tainted by food and liquids in metal cans and plastic containers? What if we were able to de-construct C&D, a big part of our waste stream, and re-use the wood and other materials? What if each of us reduced our use of plastic containers by 50% and single-use plastic by 75%?

WHAT IS PRADER-WILLI SYNDROME?

Prader-Willi syndrome (PWS) is a rare genetic disorder affecting approximately 1 in 15,000 births. PWS is a life-threatening medical disorder caused by loss of active genetic material on chromosome 15. Nearly every system in the body is impacted by a PWS diagnosis. Among other things, PWS affects:

- hormones
- cognition and learning
- muscle strength
- temperature regulation
- appetite
- pain tolerance
- behavior
- sleep patterns

Behavior problems are also common and are worsened by an unrelenting, overriding physiological drive to eat. For someone with PWS, the feeling of fullness after eating is absent.

Currently, **there is no cure for Prader-Willi syndrome.** For many individuals affected by the disorder, the elimination of some of the most difficult aspects of the syndrome, such as the insatiable appetite and obesity, would represent a significant improvement in quality of life and the ability to live independently.





Our **research strategy** balances short-term goals of improving treatments for PWS symptoms with long-term goals aimed to develop therapies that address the root causes of the syndrome.
