Hello, my name is Jules Farr and I am from the Farmer Housing Working Group, which is a network of Hudson Valley farmers, affordable housing organizations, community land trusts, cooperative development groups, farm service providers, and members of local government that came together to understand and address the need for affordable housing for workers on small farms.

Hudson Valley growers are the ones behind the scenes who make this area so sought-after, supplying restaurants and farmers markets with fresh local food and stewarding scenic landscapes. Unfortunately, with all of the demand to experience this lifestyle from visitors and newcomers, the very people who make it so special are no longer able to afford to live here.

With workers unable to find housing, and farms unable to find and retain workers, small farms are downsizing, reducing productivity, or shuttering altogether. These extraordinary pressures put the agricultural nature of our region in serious question.

We need to respond now, in time to establish dedicated, affordable farmer housing. We support the recommendation in the Ulster County Agricultural and Farmland Protection Plan under Supportive Infrastructure Recommendations section D: which states:

Pursue the development of farmworker housing. A summary of the bullets that follow are:

1. Evaluate the feasibility of developing a suitable site in Ulster County as a pilot farmworker housing project. Another alternative would be providing development support to these farms.
2. Add farmworker housing to the list of project types eligible for support through Ulster County's existing Housing Action Fund.
3. When the Ulster County Housing Action Plan is updated, include information on farm employment and farmworker housing and provide recommendations to address the affordable housing needs of farm employees and laborers.
4. Educate municipal leaders and planning board members on New York State Agriculture and Markets rules related to farmworker housing and assist communities in updating local zoning to allow for farmworker housing within NYS Agricultural Districts. Manufactured homes, modulares, traditional stick-built and other home types should be allowed for farmworker housing.

The Farmer Housing Working Group recommends that the Ulster County Legislature adopt the Ulster County Agricultural and Farmland Protection Plan so that these recommendations can be implemented.

The Farmer Housing Working Group is interested in participating in the implementation of the farmworker housing goals of this plan.
