A Local Law To Allow Enrolled Volunteer Firefighters And Volunteer Ambulance Workers To Be Eligible For A Real Property Tax Exemption Under Real Property Tax Law (RPTL) § 466-a

BE IT ENACTED, by the Legislature of the County of Ulster, as follows:

SECTION 1. STATUTORY AUTHORITY.

The New York State Legislature has, heretofore, amended the Real Property Tax Law (RPTL) to authorize municipalities to permit enrolled volunteer firefighters and volunteer ambulance workers to be eligible for a real property tax exemption as is more particularly set forth in RPTL § 466-a which State statute was made effective as of December 9, 2022.

SECTION 2. LEGISLATIVE INTENT AND PURPOSE.

The said RPTL § 466-a, among other things, allows for volunteers with two (2) years of qualifying service to apply for the tax exemption which will increase the number of eligible volunteers over existing law. The Legislature recognizes the role of the volunteer firefighters and ambulance workers in securing the safety and well-being of our communities. The Legislature hereby finds that it is in the best social and economic interest of the County of Ulster to encourage volunteerism for said purposes. To that end, by providing the following exemption, and by making it available to a larger pool of volunteers, it is the intent to encourage volunteerism for our various fire and ambulance companies.

SECTION 3. EXEMPTION GRANTED.

A. Real property owned by an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service or such enrolled member and spouse residing in Ulster County shall be exempt from taxation to the extent ten percent (10%) of the assessed value of such property for County purposes, exclusive of special assessments.

- B. Application for such exemption shall be filed with the Assessor having jurisdiction of the real property on or before the taxable status date on a form prescribed by the Commissioner of the New York State Department of Taxation and Finance Office of Real Property Tax Services.
- C. Such exemption shall not be granted to an enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service residing in Ulster County unless:
- 1. The applicant resides in the city, town or village which is served by such incorporated volunteer fire company or fire department or incorporated voluntary ambulance service;
 - 2. The property is the primary residence of the applicant;
- 3. The property is used exclusively for residential purposes; provided however, that in the event any portion of such property is not used exclusively for the applicant's residence but is used for other purposes, such portion shall be subject to taxation and the remaining portion only shall be entitled to the exemption provided by this section;
- 4. The applicant has served as an enrolled member with such volunteer fire company or fire department or incorporated voluntary ambulance service for a minimum of two (2) years; and
- 5. The incorporated volunteer fire company or fire department and incorporated voluntary ambulance service has submitted to the Ulster County Director of Emergency Communication/Emergency Management a complete list of enrolled members, with their respective dates of service for such incorporated voluntary fire company or fire department or incorporated voluntary ambulance service. The Ulster County Director of Emergency Communications/Emergency Management shall then review all potential candidates and certify those that meet the necessary criteria to be eligible for this exemption.

- D. Any enrolled member of an incorporated volunteer fire company, fire department or incorporated voluntary ambulance service who accrues more than twenty years of active service and is so certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service, shall be granted the ten percent exemption as authorized by RPTL § 466-a for the remainder of his or her life as long as his or her primary residence is located within Ulster County.
- E. Un-remarried spouses of volunteer firefighters or volunteer ambulance workers killed in the line of duty: An exemption by an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service, to such deceased enrolled member's un-remarried spouse may be continued or re-instated if such member is killed in the line of duty; provided, however, that:
- 1. Such un-remarried spouse is certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service as an un-remarried spouse of an enrolled member of such incorporated volunteer fire company, fire department or incorporated voluntary ambulance service who was killed in the line of duty; and
- 2. Such deceased volunteer had been an enrolled member for at least five years; and
- 3. Such deceased volunteer had been receiving the exemption prior to his or her death.
- F. Un-remarried spouses of deceased volunteer firefighters or volunteer ambulance workers: An exemption by an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service may be continued or re-instated to such deceased enrolled member's unremarried spouse; provided, however, that:

- 1. Such un-remarried spouse is certified by the authority having jurisdiction for the incorporated volunteer fire company, fire department or incorporated voluntary ambulance service as an un-remarried spouse of a deceased enrolled member of such incorporated volunteer fire company, fire department or incorporated voluntary ambulance service; and
- 2. Such deceased volunteer had been an enrolled member for at least twenty years; and
- 3. Such deceased volunteer and un-remarried spouse had been receiving the exemption for such property prior to the death of such volunteer.

SECTION 4. EXISTING EXEMPTIONS PRESERVED.

No applicant who is a volunteer firefighter or volunteer ambulance worker who by reason of such status is receiving any benefit under the provisions of New York Real Property Tax Law Article 4 as of December 9, 2022 shall suffer any diminution of such benefit because of the provisions of RPTL § 466-a.

SECTION 5. EXISTING LOCAL LAW REPEALED AND REPLACED

Local Law No. 13-2007, adopted on 8-8-2007 and codified as Ulster County Code §§ 312-37, 312-38 and 312-39 is hereby repealed and replaced by the provisions of this local law so as to conform to the terms of RPTL § 466-a.

SECTION 6. EFFECTIVE DATE

This Local Law shall take effect immediately upon filing with the Office of the Secretary of State of the State of New York, and shall apply to taxable status dates occurring on or after January 1, 2024.

Hello All. My name is Marisa McClinton and as a lifelong resident of Ulster County, I have seen the severe decline in not only affordable housing but quality housing. Let us not forget that HOUSING IS A NATURAL RIGHT. A "Natural right" is defined as: "those that are not dependent on the laws or customs of any particular culture or government, and so are universal, fundamental and inalienable (they cannot be repealed by human laws, though one can forfeit their enjoyment through one's actions, such as by violating someone else's rights). Natural law is the law of natural rights." Given that, a county should use any and all resources as well as time and effort to ensure that its residents and voters have their natural rights protected.

I pay \$2,000 a month for an apartment that has mold, rotting wood at every faucet, foul smelling water that makes bathing, drinking, washing dishes, and cooking impossible, rotting wood surrounding all faucets due to leaks, windows with glass missing, and only one electrical outlet in each room which is illegal. All of this to include a landlord that is out of county and owns 400 other properties throughout the state of New York and refuses to fix crucial habitability issues. Sure I can move, but to where when there are on average 10 - 15 families competing for the same listings, small, uninhabitable dwellings being overcharged, and tenant blacklists being distributed publicly online.

The system, the county is working against renters which directly spits in the face of the human right to have **housing** (safe dwelling). I urge this panel to understand that the **housing** crisis/homelessness is not based solely on a stigma of drug use or simple mental illness; but based upon factors that suppress a humans simple right to dwell in a given area. Whether you own a home or are blessed to have stable **housing**, this crisis is all of our issue and is well over due to be addressed and rectified. Putting personal agendas, party affiliations, and private feelings aside, the access to **housing** must be the mandated focus of Ulster County; especially when so many need our votes to stay relevant.

Hi! Thank you for hearing me out. Here is my comment I just shared tonight:

My name is Alex Wojcik, and I am speaking in my elected role as Deputy Mayor of the Village of New Paltz. Thank you so much for taking on the issue of housing in a truly meaningful way, as demonstrated throughout your agenda this evening. As you probably all know, I lost my housing last Fall and did not find a new apartment in the community I call home and was elected to serve until a few weeks ago — so this topic is very personal to me and remains very real for most of us throughout the County. In the Village of New Paltz, our office gets an average of 2 new tenants reaching out for assistance every single week; during peak COVID times, my office along with the mayor's office averaged 10 new tenant assistance cases every week. The issues are varied: habitability, repairs not getting done, exorbitant rent increases, landlords walking in without notice, defacto evictions via lease nonrenewals, all of it. Being rent burdened per the usual definitions isn't even a question, it's literally the warrant of every sentence. Even with the best building department and code enforcement officers on earth, and a longtime rental registry law which mandates annual safety inspections by our building department, the resolution to these issues is never what it should be. The only real "resolution" our community witnesses is the tenant and landlord parting ways, often resulting in the tenant's displacement from the community altogether. Imagine driving over an hour to a job at Mohonk or SUNY New Paltz or one of our many taverns and eateries, imagine driving over an hour to get to class as a college student, all because of local rent being too high and conditions being terrible. It is close to impossible to find a new apartment within one's budget, and to stand up for one's human rights as a tenant in New Paltz is the equivalent of forfeiting one's home.

As Deputy Mayor and On behalf of the Village of New Paltz, I want to express support for Local Law 2. New Paltz needs affordable housing to be a county purpose, just like we need housing affordability to be the main focus of all levels of government right now. However, we want to suggest some edits that will ensure my entire community is not left out of the potential benefits of passing this law. In the current version, the definition of "affordable housing" includes a sentence that reads as means testing. 99% of the individuals I've assisted in my role do not currently receive any sort of state or federal aid that would qualify them as very low, low, or moderate income. It's not because they do not qualify, it is because paperwork is a barrier as is taking a day off from work or school to get to the source of such resources. Working people in my community are rent stressed, rent burdened, across the board. Spending more than 30% of their income spent on housing including utilities has been the norm for many years, and I do not think that the sentence about "persons or families deemed to be of low or moderate income by any state or federal housing program" belongs in the county's definitions, unless a few words were to be added so that the definition would read as follows:

Affordable Housing: shall be generally defined as Housing in which the occupant is paying no more than 30 percent of gross income for housing costs, including utilities, and/or housing in which the occupant is persons or families deemed to be of low or moderate income by any state or federal housing program. Nothing in the definition shall prevent the County from funding housing services either above or below this affordability level when such funding is in keeping with federal or state programs providing housing assistance or where any income

restricted housing whether intended for rental or homeownership is subject to a regulatory agreement with a local, state, or federal governmental entity.

Thank you so much again for all of your hard work on this issue. Special thanks to Legislator Erner and Legislator Uchitelle for being leaders on housing, Legislator Sperry for being a leader on the intersection of housing and food, and very very special thanks to Legislator Walter for teaching my community the meaning of being an accessible and accountable public servant – we love you so much Eve!!

A Local Law Designating <u>Affordable</u> Housing As An Ulster County <u>Public</u> Purpose

BE IT ENACTED, by the Legislature of the County of Ulster, as follows:

SECTION 1. LEGISLATIVE FINDINGS AND INTENT.

The Ulster County Legislature finds that all residents of Ulster County deserve safe housing at an affordable cost. As further articulated in Ulster County's Housing Action Plan for 2021, ("UCHAP"), there is a housing crisis in Ulster County, stemming from an alarming scarcity of affordable housing available to Ulster County residents.

The UCHAP revealed that there is an insufficient inventory of homes at an affordable price point and that 28% of renter households and 14% of owner households in Ulster County spend more than half their income on housing costs, confirming that housing represents a cost burden that is untenable for most many of Ulster County's residents.

The UCHAP further revealed that an Ulster County resident earning an average wage would be required to work sixty-seven (67) hours per week to afford the average Fair Market Rent market rent in Ulster County.

The UCHAP set forth that the median income of renters in Ulster County declined by 1% between the period of 2010 and 2018, while median rent increased by 16% and the median sale price for a home in Ulster County **in 2021** was \$349,900, an increase of nearly \$100,000 from 2019.

Pursuant to Article IX, Section 2(c)(ii) of the New York State Constitution and Municipal Home Rule Law Section 10(1)(ii)(a)(12), Ulster County may exercise its broad police powers to provide comprehensive county housing programs. (NYS A.G. Informal Opinion 92-4, dated February 6, 1992, Pg. 2 and Pg. 7)

Based upon the critical shortage of affordable housing confronting Ulster County residents the Ulster County Legislature finds that county affordable housing programs serve a valid public purpose, (NYS Constitution Article VIII, Section 1), by promoting public health, safety and well-being. New York State Constitution, Article IX, Section 2(c) (ii) and NYS Municipal Home Rule Law, Section 10(1) (ii). See also, AG Informal Opinion 92-4, dated February 6, 1992, Pg. 6-7.

Affordable Housing: shall be generally defined as Housing on which the occupant is paying no more than 30 percent of gross income for housing costs, including utilities for persons or families deemed to be of low or moderate income by any state or federal housing program. Nothing in the definition shall prevent the County from funding housing services either above or below this affordability level when such funding is in keeping with federal or state programs providing housing assistance or where any income restricted housing whether intended for rental or homeownership is subject to a regulatory agreement with a local, state, or federal governmental entity. shall be defined as housing that costs one third or less than the median income of the population of Ulster County.

SECTION 3. DESIGNATING HOUSING AS A COUNTY PURPOSE.

- A. The Ulster County Legislature hereby determines that **the development**, **maintenance**, **management**, **and/or provision of** Affordable Housing as **is** a public purpose in accordance with the New York State Constitution Sections IX and Municipal Home Rule Law Section 10.
- B. This Local Law and the designation set forth herein shall apply to all ${\bf aA}$ ffordable ${\bf hH}$ ousing initiatives within Ulster County.



New ICD code introduced for COVID-19 deaths

This email is to alert you that a newly-introduced ICD code has been implemented to accurately capture mortality data for Coronavirus Disease 2019 (COVID-19) on death certificates.

Please read carefully and forward this email to the state statistical staff in your office who are involved in the preparation of mortality data, as well as others who may receive questions when the data are released.

What is the new code?

The new ICD code for Coronavirus Disease 2019 (COVID-19) is U07.1, and below is how it will appear in formal tabular list format.

U07.1 COVID-19

Excludes:

Coronavirus infection, unspecified site (B34.2)

Severe acute respiratory syndrome [SARS], unspecified (U04.9)

The WHO has provided a second code, **U07.2**, for clinical or epidemiological diagnosis of COVID-19 where a laboratory confirmation is inconclusive or not available. Because laboratory test results are not typically reported on death certificates in the U.S., NCHS is not planning to implement U07.2 for mortality statistics.

When will it be implemented?

Immediately.

Will COVID-19 be the underlying cause?

The underlying cause depends upon what and where conditions are reported on the death certificate. However, the rules for coding and selection of the underlying cause of death are expected to result in COVID-19 being the underlying cause more often than not.

What happens if certifiers report terms other than the suggested terms?

If a death certificate reports coronavirus without identifying a specific strain or explicitly specifying that it is not COVID-19, NCHS will ask the states to follow up to verify whether or not the coronavirus was COVID-19. As long as the phrase used indicates the 2019 coronavirus strain, NCHS expects to assign the new code. However, it is preferable and more straightforward for certifiers to use the standard terminology (COVID-19).

What happens if the terms reported on the death certificate indicate uncertainty?

If the death certificate reports terms such as "probable COVID-19" or "likely COVID-19," these terms would be assigned the new ICD code. It Is not likely that NCHS will follow up on these cases. If "pending COVID-19 testing" is reported on the death certificate, this would be considered a pending record. In this scenario, NCHS would expect to receive an updated record, since the code will likely result in R99. In this case, NCHS will ask the states to follow up to verify if test results confirmed that the decedent had COVID-19.

Do I need to make any changes at the jurisdictional level to accommodate the new ICD code?

Not necessarily, but you will want to confirm that your systems and programs do not behave as if U07.1 is an unknown code.

Should "COVID-19" be reported on the death certificate only with a confirmed test?

COVID-19 should be reported on the death certificate for all decedents where the disease caused or is assumed to have caused or contributed to death. Certifiers should include as much detail as possible based on their knowledge of the case, medical records, laboratory testing, etc. If the decedent had other chronic conditions such as COPD or asthma that may have also contributed, these conditions can be reported in Part II. (See attached Guidance for Certifying COVID-19 Deaths)


