Good evening:

My name is Peter Criswell and I'm the Ulster County Legislator-Elect for District 7 in the City Of Kingston.

Tarana Burke, founder of the MeToo movement, says "we need a shift in culture so that every single instance of sexual harassment is investigated and dealt with. That's just basic common sense."

I agree with her statement and I want to commend this body for investigating this situation and taking this issue seriously.

I believe that now is the moment for us, here in the legislature, to be part of a positive cultural shift that is ensuring that all people are treated equally and with respect.

I believe this is a crucial time for us to take action - to fundamentally transform things that are broken in our own system.

I believe it's imperative that this governing body, which represents and serves the residents of this county, have a zero-tolerance policy when it comes to sexual harassment and the abuse of power. To NOT do that - to look the other way - means we are complicit and that's unacceptable.

This is our chance to learn, and to do our best, for the sake of our residents and the future of our county.

I support the passing of Resolution 443, and I look forward to serving the citizens of Ulster County.

Thank you.

My name is Andrea Shaut, and I live in the City of Kingston. I currently serve on the city's Common Council representing ward 9 and was recently elected to serve as Council President starting January 1. And I'm here to speak in favor of Resolution # 443

I really don't want to be up here, but I know I have a needed voice in this issue, being a woman in the political world. Serving as a public official is no easy task. You cultivate relationships with your colleagues as you battle together to do what you think is best for your community to thrive, and I know it is difficult to stand up against one of your colleagues. I'm here to ask you to do it anyway. Because even though I recognize the difficulty of this decision, I know firsthand how it feels and what it means to be a woman not believed, not supported.

I am a victim of sexual abuse. I was a teenager, still a child. I spoke out, and I was told to keep quiet because nobody would believe me – he was the authority figure and I was just a teenage girl. He went on to find another teenage girl, and nearly 20 years later I live with the guilt that I wasn't forceful enough to end it after me. Rationally I understand this guilt is not mine. It goes to the abuser. It goes to the people in authority roles who did not speak up for me when I needed them the most. But my guilt is sadly normal, and this won't change until we as a society force it to change. We need to pivot our norm to say that any type of sexual abuse and sexual harassment is unacceptable. You, as a body, can take a step into this change tonight. Inaction will only allow this type of behavior to continue, and it will allow our society's normal to remain stagnant.

I understand what you have to decide on, from an elected official's perspective and from a victim's. And I'm asking you to do what's right. Stand up for the victims. Stand up for women. Please. How many times do we need to hear it. Enough is enough.

Jennifer Schwartz Berky Testimony 11.19.19

[READ INTO THE RECORD ON BEHALF OF JENNIFER SCHWARTZ BERKY BY ORIANA MAYORGA]

Greetings to my former colleagues, thank you Chairwoman Bartels for this opportunity to speak.

You know me as Jennifer Schwartz Berky. I was a county legislator.

I am here to speak about censure. But it comes down to this: we live in a culture that has permitted this kind of behavior for a long time. And it isn't just one person who is guilty of this. This in no way forgives what has specifically led to this moment.

I made a commitment to this place when I moved here 16 years ago. It has never wavered. I was dedicated to our community and the work were doing and led plans that catalyzed our countywide trail system, our new economy, our focus on value-added agriculture, our creative economy, and our embrace of green technologies.

Nothing could have prepared the routine harassment I witnessed all around me at the county government. At first, I saw other people suffering: mostly women who were routinely berated and bullied. I reported it.

Several capable women were fired for political reasons and marched out of their offices like criminals. I never heard of a man who went through that. And then it turned on me.

[READ INTO THE RECORD ON BEHALF OF JENNIFER SCHWARTZ BERKY BY TANYA GARMENT]

A man repeatedly cornered me, often tried to open my door as I was expressing milk, and raised his arm to strike me. I reported it. Nothing was done. Even after he left, the culture that permitted it continued. I was harassed and bullied in the office: comments about my ethnicity, about my body. A department head (not my own) frequently said anti-Semitic things about me and defamed me professionally on a routine basis. Make no mistake: I am a very capable, hard working person and I always produce results. Having committed my life and family's future to this community that I so obviously love, this was difficult. I was disempowered. I was told it wasn't real and not to complain. It was "gas lighting" — plain and simple.

[READ BY JENNIFER SCHWARTZ BERKY:]

On behalf of Jennifer Schwartz Berky:

I thought I could help my community as a legislator. I represented some of the poorest census tracts in Kingston and Ulster County, and the majority of public housing in the city and county. I was invited into the homes and lives of hundreds of people, and am humbled by this. Many of them had suffered from a culture of crime, drugs, poverty, neglect, and discrimination.

My life was forever changed when – after being pulled over several times for no reason ONLY during my time as a legislator and <u>never before and never since</u> – my rights were violated by the Town of Ulster board in their decision to release a videotape before a trial (which I was then denied). And no one spoke up. In the weeks and months that followed, I was harassed and threated by thousands of neo-Nazis following the Daily Stormer (America's largest neo-Nazi group). They doxed and trolled me. Calls in the middle of the night, calls saying I should be hung, raped, and burned. The video retweeted and shared tens of thousands of times. I still receive regular messages from them.

I look back to my time dedicated to Ulster County see a culture that is willing to tolerate actions that are intended to disempower others. Often women, children, and immigrants: the most vulnerable. While I was here, I represented them: sanctuary, human rights, protections for transgender communities, anti-bullying education. I paid a very dear price.

But I keep moving forward. I focus on giving back.

Tolerance of harassment is very, very destructive. Think about how much stronger our community would be, how much more successful we <u>all</u> would be if this would stop. If we would truly use Restorative Justice to address it. All of it.

If you censure your colleague tonight, or if you don't, I ask you to consider whether you forgive and tolerate abuse elsewhere. I ask to you be honest about the culture of discrimination and unkindness wherever it may be and stop it.

I lost my life to this. I ask you to do more than censure. I ask to you take a very careful look at how we can stop this all around us.

Thank you for this opportunity to speak.

Based on his repeated sexual harassment of colleagues and constituents, Ulster County residents demand that the Ulster County Legislature:

- 1. Censure Legislator Hector Rodriguez, and
- 2. Request his resignation

In early 2019, several sexual harassment complaints were filed against Ulster County Legislator Hector Rodriguez. They included forcible kissing, relentless messaging, and retaliation when women declined his advances.

Ulster County hired an independent firm to investigate the allegations. In summarizing the testimony of the women, the investigators found that "Mr. Rodriguez exploited his position as a legislator to gain access to multiple women in an effort to proposition them and 'hit on them.'" The investigators recommended "corrective action, including and up to requesting resignation."

While individual legislators have condemned his behavior, the legislature itself has not responded as a body to the findings of the report or the infraction of the County's sexual harassment policy. The continued lack of consequence sets a harmful and dangerous precedent and sends the wrong message to both legislators and Ulster County constituents.

At the next full Ulster County Legislature meeting, on Tuesday November 19th, we demand that the Ulster County Legislature vote to censure Mr. Rodriguez as well as publicly request his resignation, thereby communicating to constituents that his behavior is unacceptable and will not be tolerated.

Dear Editor:

A great cornerstone of a democracy is that of public trust. Any free society relies heavily upon it. But what is public trust? It's when members of a community have faith in the honor of their elected officials. It's when constituents can talk candidly, freely and truthfully about their concerns with someone who has been chosen to represent them. It's when an official puts his or her constituents' interests at the forefront of their own.

How is public trust violated and broken? There are many ways, but I would like to put one at the very top and that would be sexual harassment.

Sexual harassment is a grotesque corruption of trust and faith between an elected official and a vulnerable constituent who sees the representative as powerful and influential.

Today Ulster County Legislator Hector Rodriguez is without his constituents' full faith and trust. He certainly has lost mine. The results of a recent independent investigation into the many credible accounts of sexual misconduct by Mr. Rodriguez have eroded public trust in this elected official. These charges are not isolated, not minor, and his actions are not flippant social faux pas, and are not to be disregarded. The charges reveal a pattern of sexual corruption over a period of years. We know that a small percentage of women will bravely come forward to report harassment. We cannot discount the possibility that more women in our community are too hurt or intimidated to speak out.

What does this mean? I think it means this: any Legislator not willing to censure Mr. Rodriguez is a partner in his misdeeds, an enabler, a bystander unwilling to help those who are deeply wronged. Don't be that, Legislators. Be better. Much better.

I urge you to censure Mr. Rodriguez or, Mr. Rodriquez, you can do the right thing and resign immediately.
