PRIVILEGE OF THE FLOOR:

As millions of Americans are recovering from Hurricanes Harvey and Irma and in recognition of September as National Preparedness Month, Chairman Kenneth J. Ronk, Jr. granted Privilege of the Floor to Captain Brett M. White, Division of Military & Naval Affairs, Citizens Preparedness Corps, Lower Hudson Valley Area. Captain White discussed the importance of planning ahead and being prepared for natural and man-made disasters.

The Citizen Preparedness Corps gives residents the tools and resources to prepare for any type of disaster; respond accordingly and recover as quickly as possible to pre-disaster conditions. Citizen Preparedness Corps training began in February 2014 and are held in communities throughout the state. Trainings are led by the New York State National Guard, working with experts from the Division of Homeland Security and Emergency Services' Office of Emergency Management and Office of Fire Prevention and Control.

PUBLIC COMMENT:

There were (5) speakers signed up for public comment.

- 1. <u>Thomas Wanning</u>, <u>New Paltz</u>: Mr. Wanning discussed the distribution of income within the United States and the need for campaign finance reform.
- 2. <u>Carol Meyer, High Falls/Marbletown</u>: Ms. Meyer opposed having the Ulster County Fire Training Center built in her residential neighborhood. Ms. Meyer submitted for the record additional signatures opposing the center, bringing the total to 1,201.

- 3. <u>Paul Fowler, Saugerties</u>: Mr. Fowler of Fowler Advocacy spoke regarding the drug epidemic in the community and shared concern if patients like him are cut off from prescription narcotics they may resort to street drugs laced with the deadly drug Fentanyl. Mr. Pete Nekos a local pharmacist was introduced as was Mr. Gary Rose, father of Fireman Captain Jack Rose, who lost his son while responding to a fire call. The Ulster County Sheriff's Office named their newest canine recruit "Jack" in honor and memory of his son.
- 4. <u>Laura Cunningham, Stone Ridge</u>: Ms. Cunningham spoke out opposing the Ulster County Fire Training Center being built in her residential neighborhood.
- 5. <u>Lou Cariola, New Paltz</u>: Mr. Cariola thanked County Executive Hein for the installation of a four way stop sign at Rte. 299 and Butterville/Albany Post Road. Mr. Carioca would still like to see a reduction in the speed limit on this road located in New Paltz.
