### Ladies and Gentlemen and Ken Ronk

I compliment the chair in getting many needed changes to the charter as expressed by the a charter Revision Commission in this legislation. The commission gave this body a redline copy or complete side by side comparison of changes.

My problem as a commission member, like that of the towns and planning board is the non transparent changes snuck in that the commission, towns and planning board were opposed to and not having the side by side comparisons.

Doing that while rank & file legislators were distracted with the budget might actually be down right sneaky.

There is no need to change the way our county chooses the planning director. I know this was amended since I last spoke but that change was putting lipstick on a pig, it doesn't return it to the original intent of small d democracy that has worked very well for over ½ a century. Amend this to return it to its original form other than the mundane gender neutral language changes recommended.

I also have serious concerns with the idea that a person cannot serve as Executive unless they have been a qualified voter in County for 4 years. I can't see it holding up in court once challenged. This could be burdensome to renters that may want to run as well as veterans. Despite what some say, many veterans register to vote where they are stationed. This also seems sort of xenophobic.

In regard to the planner, Don't insult our local municipalities and the planing board members you appointed by weaken their position in regard to planning and don't insult the Charter Revision Commission who's members spent upwards of 100 hours of time on this issue.

On another issue, I say it's absurd that our comptroller, the elected watchdog had to go to court to get the findings of an executive investigation that cost upwards of \$50,000 and the idea that only one county legislator Joe Maloney stood up to demand the same. You are the appropriating body and should know how money is spent. That is your number one job.
