#### Clerk Fabella

Tonight's public hearing is on the proposed 2021 Ulster County Budget and the proposed 2021 through 2026 Capital Program. For those guests that are joining us tonight, we'll be calling on you one by one to ask if you'd like to speak. And then the Chairman will give you two minutes to speak. And we'll go from there.

Clerk Fabella

Go ahead, Jay.

#### Deputy Clerk Mahler

We have a caller from 845-399-0992. If you could first give us your name. And I believe \*6 to unmute yourself.

#### Karen Schaffel

Hi, thank you for allowing me to speak. My name is Karen Schaffel. I live in the Town of Rosendale. And I have worked in this community for many years in Children's Services. And I understand that there are budget cuts and there's lots of constraints. And I want to talk about how Ulster County has been a leader in serving our youth with significant family and or behavioral struggles. And that resulted in Ulster County's relatively low rate of youth placement. And this is in part because we believe that keeping children out of the juvenile justice system is an advantage to everyone.

#### Karen Schaffel

One thing I want to make everyone aware though there are many social reasons for doing this. It is also a financial gain. Each placement can run upward from \$80,000 a year. The ability to minimize placement, also defers the negative outcomes that you often demonstrate after being in placement as they transition to adulthood. And these involve often in becoming offenders and incarcerated. This would be an additional cost to the county.

#### Karen Schaffel

So, right now the county is proposing to cut programs that serve these youth, in particular, through the preventive [inaudible]. These programs such as YAP, Youth Advocate Program, and or Families Now or MST are programs that prevent these youth from going to residential placements. So, therefore would prevent the expenditure of those dollars.

#### Karen Schaffel

These programs are currently up for a 50% cut, which would drastically reduce the number of children and family served. There are no other programs in the county that provide the kind of wraparound services and additional 24/7 crisis hotlines that these programs provide.

#### Karen Schaffel

It is imperative that the Legislature considers the outcomes of cutting these programs that uniquely assist the youth that cannot be served. Is it important to remember that with the minimum investment in these programs, even if just such as three youths would be prevented from placement, that would save an overall \$240,000 a year, and probably more costs in the future.

#### Karen Schaffel

So, the three programs are MST, YAP, and Family Now.

#### Karen Schaffel

I'm sorry, I'm a little nervous. I'm not speaking that well. Does anybody have any questions?

#### Legislator Petit

Chair, are we allowed to ask questions at this point?

#### Chairman Donaldson

Normally, we are not, we don't ask questions. But I believe that, you know, we need to look into that. So, I think that would be a follow up. Not during the public comment.

#### Karen Schaffel

Okay, can I just, you know, I just want to say that I understand that there are budget cuts, and there's going to be budget cuts. And I'm not naive to that. But I just want to make aware that when you cut the programs that prevent these kinds of placements, that work with these families, you're preventing the crisis calls, the hospitalizations, the police having to come out to 911. Your preventing these kids going into a placement, or a system, that is more costly than the preventive programs. So, though it looks good initially that you're saving money, in the end, I think a lot more dollars will be spent.
