Discussion:

This resolution sponsored by Legislator John Parete and Legislator Jonathan Heppner spoke passionately before the committee supporting the effort to combat substance abuse with the vision to dedicate all revenue received as the result of the NYSDOT approved medical marijuana dispensary in Ulster County be used for the prevention and treatment of narcotics dispensary in Ulster County - to be used for the prevention and treatment of narcotics addiction.

Legislator Belfiglio asked Ken Crannell if the county would realize a 7% percent sales tax for the sale of medical marijuana. Ken Crannell followed up the next day with an outline showing the allocation summary:

- There is a State 7% excise tax on every sale of medical marijuana. Proceeds from the excise tax will be allocated to counties in the following manner: 22.5% to the county where the medical marijuana was manufactured and 22.5% to the county in the State where the medical marijuana was dispensed. The balance is for State purposes.

Ken Crannell provided the committee with a history – rendition starting from late last year leading up to today. When pressed for an estimate, tax revenue, Ken guesstimated \$20K-30K/year – eventually \$100K/year.

The final resolved, was amended to state: RESOLVED, that the funds shall be used to support programming consistent with NYS regulation and such other programs approved by the Ulster County Legislature.

Comprehensive discussions ensued and can be heard on the audio tape.

As per our county website, our medical examiner investigates deaths of persons dying from criminal violence accidents, suicide, sudden death without a physician present, in prison or in any suspicious or unusual manner. A medical examiner is also responsible for certifying and determining the cause of death. The Medical Examiner must be a resident of Ulster County and licensed to practice in the New York State.

A coroner performs the autopsy at a hospital such as Health Alliance. Ulster

County does not appoint a coroner.
