Okay. All right very good. We got a full house with everybody then. All right. Um, we will start with 424. Now this is: Establishing a policy requiring the county stabilization center, requiring a county stabilization center requesting that the initiation of procurement process for people experiencing mental health and or

substance abuse crisis. Now, this is a this was recommended from the Criminal Justice Reform Task Force.

#### Dr. Carol Smith

No, it's from the Behavioral Health Task Force.

#### **Chairman Lopez**

Oh this was behavioral, oh okay. I don't know where I

# **Legislator Criswell**

I can, I can speak to this also.

### **Chairman Lopez**

Okay.

#### **Legislator Criswell**

If you want to, because this is a what Eve and I have been working on for quite some time now. So this initiated with the, you know, the call for the ways to spend the American rescue plan funds. And so Eve and I went down and we visited the Crisis Stabilization Center in Dutchess County, had good conversations there, we did a lot of back and forth with them in terms of what it takes to build up a center what the finances would be, and then ultimately, you know, my initial impression of how we were supposed to spend this money was to, to give seed money to something that could then become self-sustaining. And so that's what we asked a lot of questions about that about how would you do future billing? How would this work? So I felt very satisfied that this would be a one-time large investment on the stabilization Center, which would then be able to sustain itself through billing to the state. And so, we went back and forth, created the budget, submitted that in with the other proposals. John, you can speak to this, but the executive's office saw that I think they were very happy with a lot of a lot of the pieces of that. And so that's why we're you see these resolutions before you today.

#### **Legislator Uchitelle**

I'd like to move to discuss Resolution 424.

#### **Legislator Bruno**

I'll second that if it wasn't already.

# **Legislator Uchitelle**

I figured I get that formality done.

### **Legislator Criswell**

Thank you. Sorry about that.

#### **Deputy Executive Milgrim**

Somebody second that.

### **Nettie Tomshaw**

Yep, Al.

# **Chairman Lopez**

Al you got it.

### **Deputy Executive Milgrim**

Super. Craig can I get

# **Chairman Lopez**

Sure.

# **Deputy Executive Milgrim**

A little (inaudible). The mindset this is one of several resolutions that were postponed last month that were originally proposed by Eve. Under the premise it was postponed on the premise, we will see what's in the budget. We've since presented the budget, Pat presented it late last week. This is the centerpiece of the mental health part of the budget. It does include a capital project for a mental health and addiction recovery center, which I think as Peter kind of rightfully said, the idea is to create through capital, a center, a brick and mortar facility that can contain all the services that the county is looking for on a sustaining, revenue sustaining basis. So this is in the budget, it is a capital project, it is hoped to be funded through the ARP program. And I'm not sure how the resolution fits in now if it's still postponed pending how the budget turns out or, or what but that's that was just some of the context from the last meeting and where we stand.

# **Chairman Lopez**

And this is just the begin the process - the procurement process. So and do you do you know what those numbers look like?

### **Deputy Executive Milgrim**

A, Carol if you know offhand, I think it was three something million for the center that I shouldn't be speaking.

#### **Legislator Criswell**

That's correct, actually, that's stated in the resolution.

# **Legislator Lopez**

All right. Any other questions, Comments?

#### **Legislator Bruno**

Yeah, I got a question about this. So, in Executive Ryan's budget release, he revealed the other day in New Paltz. He brought this up as well, part of the budget process. My question is, is there a specific location plan, and it's a brick and mortar building, I liken this to the head trauma center only in a different way. And I mean, no pun and with that, but a location like that, is there something or are we going to end up hooking up with another local facility and using them - I'm being as political correct with this as I can.

#### **Nettie Tomshaw**

Chairman, John Milgrim has his hand up?

# **Chairman Lopez**

Yeah, I don't see it. Yeah, if you can just give me a heads up when somebody's hand up. Yeah. Everybody at once you actually have to - yeah, let me know how you get everybody into the same screen. But um, anyway, yeah. If you could, if you see somebody with their hand, they'll just give me a heads up.

# **Legislator Bruno**

Craig, if I can just for a second look to the upper right corner of your screen with your thing, and it will say gallery view.

# **Chairman Lopez**

Okay.

### **Legislator Bruno**

Click on that and you'll see everybody.

### **Chairman Lopez**

Okay. Thank you.

# **Deputy Executive Milgrim**

If you want to see everybody Craig. (inaudible)

# **Legislator Lopez**

Yeah, Go ahead John,

### **Deputy Executive Milgrim**

Now there's the - to answer or through the chair to answer Legislator Bruno's question. We've been considering some sites, I don't think one has been solidified at his point. The intent is to have a central main site for these, these services, however, so nothing is - no site has been selected ready for build out.

# **Legislator Criswell**

And if I could just add on, I know that we'll talk about this in the next resolution. But the concept is to have the central site in Kingston or close to probably in Kingston itself, and then the respite houses farther afield so that we can be really servicing as much of the county as possible.

### **Legislator Bruno**

That makes sense. I just wasn't sure because a lot of times he sees come up. There's always a plan in the background, but we don't hear about it until after it's already happened. So I'm being blunt about this, I kind of brought this idea up in meetings previously, when we had Dr. Doyle on here, I said well, why don't we build our own place. I said that many times and now I'm just curious is if this is part of that now, if we're going to we had a specific place in mind, whether it be Tech City, whether it be Health Alliance

or Ellenville Hospital. I mean, is there something - is there a plan that we're not all seeing it? That's what I want to know.

# **Chairman Lopez**

But I yeah, in other words, are there discussions? Or is the executive's office having discussions or have an idea?

# **Deputy Executive Milgrim**

We, we are absolutely, we're absolutely having discussions - we don't have anything finalized by any stretch. Legislator Bruno we did look at - we have looked at as a potential concept, the Broadway corridor concept, because there is some space being vacated by Health Alliance. And we're looking at some other medical facilities, other facilities that are on the market, but nothing has been finalized yet. So yes, there are discussions but nothing. No Deal has been locked in.

### **Legislator Bruno**

Okay.

### **Deputy Executive Milgrim**

But just in terms of the resolution, since it was postponed, pending the submission of the budget, I would ask that this resolution is carefully reviewed, so that it doesn't create a non-intended redundancy with what's in the budget. So I haven't looked at it that closely in the last few days, but I think it's aligned with what we had in the budget presentation. I just don't want it to conflict in any way.

### **Legislator Bruno**

Understood.

#### **Legislator Lopez**

Is this going to another committee?

#### **Legislator Uchitelle**

It'll go to Ways and Means. It's got financial impact.

#### **Legislator Lopez**

Well it's yeah, it's from Ways okay.

#### **Nettie Tomshaw**

Legislator Petit joined us, Chairman.

#### Chairman Lopez

Okay.

# **Legislator Criswell**

If I may, so I read it pretty carefully. John, and I don't think it has any conflict with where you're headed. I think it's actually very much in a dovetail.

#### **Nettie Tomshaw**

Um, it's going to Law Enforcement and Public Safety and Ways and Means.

# **Legislator Lopez**

Okay, yeah. All right. Well, so that gives a little bit of time if there are potentially any conflicts, but yeah, Pete I trust that considering you work closely with this. Yeah, that if you're comfortable with it, then I'm comfortable with it. And yeah, if the rest of the committee is as well then yeah, I think we should vote.

### **Legislator Bruno**

Yeah, if I can, can we like to make a motion that we block resolution 424 and 425, because he essentially are the same thing, or similar to it.

# **Legislator Lopez**

Is, yeah, and if you want to do that, and then we can have a discussion. Well, we can vote on it right now just go right into it - that way everybody has an opportunity to speak.

### **Legislator Criswell**

I'd actually prefer to not block them personally because I just think they should stand on their own.

# **Legislator Lopez**

Okay. Do you want to withdraw your motion?

#### **Legislator Bruno**

I'll withdraw the motion.

#### **Chairman Lopez**

Okay. All right. Well, then, if there's no further discussion on 424, then all in favor?

#### **Committee Members**

Aye. Aye. Aye.

### **Chairman Lopez**

Okay.

# **Nettie Tomshaw**

Laura are you in favor?

### **Legislator Bruno**

Laura, are you here?

### **Legislator Petit**

I'm here. What was the title on the resolution?

# **Legislator Lopez**

This was for 424. It's establishing a policy or requiring a county stabilization center?

# **Legislator Petit**

Oh, absolutely. Yes, yeah. Thank you.

# **Legislator Lopez**

Via the recommendation of the behavioral taskforce, and not the law enforcement, got it. So okay, so we will go into 425. Establishing a policy requiring people requiring respite house's in Ulster County requesting the initiation procurement process to secure services for individuals in need of substance use recovery assistance.

### **Legislator Criswell**

Move this for discussion.

# **Legislator Bruno**

Second it.

## **Legislator Lopez**

Second, discussion.

# **Legislator Criswell**

So if I may, as I mentioned, before, we really looked at the model in Dutchess and, you know, the whole concept of this is that there's a central location that can then funnel people to where they need to go, whether they need to actually go to an emergency room, whether they just need a couple hours to kind of cool out and have a little bit of support, and then they can go back home. Or they might need actually a respite house where they can spend a few days up to I think we said up to seven days, I can't remember exactly. But, um, you know, the concept, I think, is a really, really strong concept. And it's important, again, that we have these locations, and as wide as possible in the county, so we, you know, kind of talked about Ellenville kind of talked about somewhere, you know, kind of up in the northern section of the county, so that we're really able to serve as many people as possible with these. And they've done it really successfully. In Dutchess, we heard a lot of amazing tales, you know, conversations about people who, who had, you know, they were really seriously in crisis. And then just after a few days having the support around them, they were able to kind of go back into their lives and create a game plan about how they were going to kind of move back into it. And, and so really successful. And I don't know if Dr. Smith or Mike, if you have any stories about how respite houses work, but everything I heard was very positive about them.

### **Legislator Bruno**

I got a question.

### **Nettie Tomshaw**

Chairman, Legislator, Bruno has a question. You can just speak up.

# **Legislator Lopez**

Yeah, yeah no - right go ahead. That's ok.

# **Legislator Bruno**

So through the chair to Legislator Criswell. My question is, the respite house's aren't the triage center, that would be 424 would become like a triage center. Is that right? And I'm a little confused of the way you.

### **Legislator Criswell**

So what happens is somebody presents with a with a problem, right? So they show up at the crisis stabilization center. The center then acts as a hub, to help them get to the place they need to get to. So either they go to an emergency room, or the stabilization center itself will have kind of a cool out area for a certain amount of time. I believe it's up to 23 hours at that point. And then

# **Legislator Bruno**

That's where I was confused.

#### **Legislator Criswell**

If it's deemed necessary, then they can get funneled to one of these respite houses for a longer stay to kind of stabilize and figure out then what the next step would be.

# **Legislator Bruno**

My follow up question to that and because I know you, me, Legislator Eve, have done an incredible amount of work with this thing. First of all, thank you. That being said, if somebody let's say, for example, say in Ellenville shows up at a respite house because that's the closest place that they get when they're in crisis. Will that respite house act as like a satellite to the stabilization center as well? I mean, that's what I'm kind of getting at. Because it's something that people who can't travel to go to get back. You know what I mean?

#### **Legislator Criswell**

Yeah, that's not the function of the respite house. And I have not heard respite houses used as stabilization centers. I think they're two really different things. I'd have to look into that further. That's a really great question. But that, to my knowledge, a respite house is not used as a stabilization center.

#### Legislator Bruno

I just curious if there would be some kind of an arm of that either somehow or other like a local

### **Legislator Criswell**

That wasn't what was presented to us at any of the locations that we looked at. It was strictly a respite house that was a second location to after going to a stabilization center.

### **Legislator Bruno**

Gotcha. Thank you.

# **Legislator Criswell**

You're welcome.

# **Commissioner Iapoce**

I would just (inaudible). Good evening, everyone. And thanks for the invitation to join the meeting. I think both of the proposals in each resolution are really vital components of trying to restore responsive mental health services. It was mentioned that it's part of the county's larger budgetary proposals. I mean, I can't speak enough to the need for a crisis stabilization center. We often have clients that arrive at our building on a daily basis, that are not able to meet the thresholds for mental health intervention in order to get admitted into a psychiatric facility for involuntary observation. They are frequently assessed by our mobile mental health and deemed to have capacity, but they still present with behaviors that don't make them appropriate to place in a hotel or motel, or shelter. We also have clients that don't have acute medical needs that fall into that same category. And I think Peter indicated, you know, accurately that to have a location that we could refer those individuals to for 23 hours to assess their needs, stabilize their circumstances, and then they may end up in a more traditional placement or respite placement, while some of their more involved needs are being addressed. But I would just, you know, saying very significantly, and very gratefully, I think that both of those proposals are going to better equip us to be able to, you know, meet needs of individuals in crisis, who present and have to have somewhere to actually physically go. So I'm very encouraged that these are part of the proposals that have been arrived at by the various task force and committees who are addressing these issues.

# **Legislator Bruno**

Thank you.

# **Chairman Lopez**

Anything else? Anyone else? All right, hear none all in favor?

#### **Committee Members**

Aye. Aye. Aye.

### **Chairman Lopez**

Okay, we'll move on to 433. Confirming appointment to the community service board, this is the substance abuse subcommittee. Move for discussion.

# **Legislator Bruno**

I'll make that motion for discussion.

#### **Chairman Lopez**

Second.

### **Legislator Uchitelle**

I'll second that.

#### **Nettie Tomshaw**

Laura did.

### **Chairman Lopez**

Okay. Any discussion for John Brown one year appointment? Would assume the resume is attached as it usually is.

# **Legislator Uchitelle**

Yeah, it is.

# **Chairman Lopez**

Any discussion? Okay, hearing none all in favor?

#### **Committee Members**

Aye. Aye, Aye.

### **Chairman Lopez**

Okay, we have 476 477 and 485 through 490 are all increase in state funding. if everybody's agreeable, we can block them.

### **Legislator Bruno**

I'll make a motion we block resolutions 476 through 490.

# **Legislator Uchitelle**

I'll second that motion.

# **Chairman Lopez**

Discussion on the block? On the block all in favor.

### **Committee Members**

Aye. Aye. Aye.

### **Chairman Lopez**

Okay, on the resolutions?

### **Legislator Uchitelle**

It's passed - it's a kind of a mandatory increase that's funded from the from the funding entity. So I don't know what else there is to say about it.

### **Chairman Lopez**

Yep. Well we need a motion on the resolutions then right.

No, no, I know. I just was I'll make I was trying to encapsulate all the discussion I could have in one pithy statement.

# **Legislator Bruno**

I'll make that resolution - that motion sorry.

# **Chairman Lopez**

Okay. a second.

# **Legislator Uchitelle**

Second.

# **Chairman Lopez**

All right discussion. Hearing none all in favor.

### **Committee Members**

Aye. Aye. Aye.

# **Chairman Lopez**

All right. Very good. 491, Approving contract amendment for \$65,340 with Cornerstone Family Health Care.

# **Legislator Bruno**

Move for discussion.

# **Legislator Petit**

I'll second.

### **Chairman Lopez**

These, this is 100% federal substance abuse services. Any questions? Hearing none all in favor?

# **Chairman Lopez**

Aye. Aye. Aye.

# **Chairman Lopez**

492, Approving contract amendment for \$249,589 with Family Services.

# **Legislator Uchitelle**

I'll move it.

# **Chairman Lopez**

Alright.

# **Legislator Bruno**

Second it.

# **Chairman Lopez**

Second, same as well, similar 491 100% federal substance abuse services. Alright any, discussion? All in favor?

### **Committee Members**

Aye. Aye. Aye.

# **Chairman Lopez**

493, Approving a contract for \$1.4 million with Health Research.

# **Legislator Bruno**

You got that backwards Chairman?

# **Chairman Lopez**

I'm sorry.

# **Legislator Bruno**

Not 1.4

### **Nettie Tomshaw**

4.1

# **Chairman Lopez**

4.1

# **Legislator Bruno**

You said 1.4

### **Chairman Lopez**

Oh I did. All right. Well, yeah if it wasn't 100% federal, then yeah, the 1.4 would have been better. But no, we're good. 4.1, approving a contract \$4.1 million with Health Research. A move for discussion.

# **Legislator Bruno**

I'll move.

# **Chairman Lopez**

Second.

# **Legislator Petit**

I'll second.

# **Chairman Lopez**

All right.

# **Legislator Bruno**

So a what um health -what exactly are we. I don't have the whole resolution in front of me.

# **Chairman Lopez**

This is (PHEP). What is that, Public Health Emergency Preparedness I think, if I remember correctly.

#### **Dr. Carol Smith**

Yeah, it's funding that's coming from the state to support school reopening. And Health Research Incorporated is actually the funding arm of the New York State Department of Health. And that's why those two terms or names are in the resolution. But it is money that's coming to us to support school reopening, to support the testing and whatnot, that we're doing across the county, for the various school districts. And basically, that's about it. And no county dollars are involved. It's literally grant funding through the state.

# **Legislator Bruno**

Thank you, Dr. Smith.

### **Chairman Lopez**

Great, any other questions? All in favor?

#### **Committee Members**

Aye. Aye. Aye.

#### **Chairman Lopez**

494, Approving contract for \$170,000 with Health Research for overdose data election action plan.

#### **Chairman Lopez**

Well, no plan. Is that right? Or is that a mistake on my part?

#### Dr. Carol Smith

It is against the funding from originally I believe from SAMSA through the state OD2A, it's the overdose to action funding line.

# **Legislator Lopez**

Oh to action. That's what it was. Gotcha.

#### Dr. Carol Smith

And yup \$72,000 of that. That's why it speaks to the next two resolutions. \$72,000 of that money is going to PEOPLe Inc. in order to support their peer to peer activity. \$100,000 is being kept as restricted in reserve. So that \$100,000 isn't going to be spent outright, but so that funding has been divided into two. The \$72,000 portion of it will go to PEOPLe Inc.

# **Chairman Lopez**

Got it. And again, that's 100% federal.

### Dr. Carol Smith

Yeah, and Peer to Peer for opioid dependent individuals and substance abuse disorder recovery.

# **Legislator Lopez**

Okay. Sounds like a no brainer right Al?

# **Legislator Bruno**

Pretty much. That's my line yup.

# **Chairman Lopez**

All in favor.

### **Nettie Tomshaw**

Somebody has to move it.

# **Chairman Lopez**

Oh we missed the move.

# **Legislator Bruno**

I'll move it.

# **Legislator Uchitelle**

I'll second it.

# **Chairman Lopez**

Second all right. All right. All in favor.

#### **Committee Members**

Aye. Aye. Aye.

### **Chairman Lopez**

Okay. 495, Approving contract amendment for \$72,000 with PEOPLe projects.

#### Dr. Carol Smith

That's just what I referred to prior.

# **Legislator Bruno**

I'd say move it for discussion but we already had the discussion. So

### **Nettie Tomshaw**

Al motion to adopt.

### **Chairman Lopez**

We got a second?

### **Chairman Lopez**

496, Approving contract for \$112,500 with Samadi Center to increase hours operation for the recovery outreach program to 24 hours seven days a week for residents with opioid use disorder. A move for discussion?

# **Legislator Criswell**

I'll second that.

### **Chairman Lopez**

All right, all in favor.

### **Committee Members**

Aye. Aye. Aye.

### **Legislator Criswell**

I'll move that.

#### **Legislator Bruno**

Yup.

# **Chairman Lopez**

Yeah there was a question in chairs committee meeting prior to this, and what is the operational hours now? If anybody may know Dr. Smith, or

### **Deputy Executive Milgrim**

No sorry. Yeah, I got it here if you want, both of us do. Tara says they operate now 8am to 9pm I believe they're closed on Sundays.

### **Chairman Lopez**

Okay.

# **Legislator Criswell**

If I can just mention Legislator Uchitelle and I and Legislator Walter took a tour of their new facility and it's pretty, it's impressive. And the advancements that they want to make from where they currently are, it's going to really serve our community well.

### **Chairman Lopez**

Where are they located?

### **Legislator Criswell**

Right now they're on Clinton Street, but they've got a space on Broadway that is probably at this point now almost finished with their rehab. And Abe do you remember what their intended opening date was? I can't remember now.

# **Legislator Uchitelle**

Sometime later this year they were making fast progress.

# **Legislator Criswell**

Right I remember it was fall I think it was fall. Yeah so

### **Legislator Petit**

Legislator Criswell were they also planning on having respite housing there as well?

### **Legislator Criswell**

There, there's I can't remember now, how many units that are short term housing for folks. Three or four? I can't remember Abe can you remember?

### **Legislator Uchitelle**

Something in that ballpark? Yeah.

# **Legislator Criswell**

Yeah.

#### **Legislator Uchitelle**

But they were like very, they were somewhat one of the apartments, basically that apartment and you can you can see when you walk in, and you can kind of see where they have the support facilities, the the kind of medical side, and then you go upstairs, there's the residential side. It made a lot of sense.

#### Legislator Criswell

The other piece of this that I think you want to keep in mind is that this is specifically for substance abuse, whereas we're talking when we're talking the crisis stabilization center, that's the broader mental health community. Although, obviously, there's often lots of overlap, but the Samadhi work is really specific.

# **Chairman Lopez**

Okay. All right. Anything else? All in favor?

#### **Committee Members**

Aye. Aye. Aye.

### **Chairman Lopez**

497, Approving a contract for \$71,000 with Berkshire Farm. And this is for residential foster care assessment. Moved, motions? Yeah.

### **Legislator Bruno**

Move it.

# **Chairman Lopez**

Second?

# **Legislator Petit**

Second.

# **Chairman Lopez**

Discussion? Questions? All in favor?

### **Committee Members**

Aye. Aye. Aye.

# **Chairman Lopez**

Alright, so on 498 through 504. are all 100% state funded contract amendments for foster care. I don't know if the committee want to block those together?

# **Legislator Uchitelle**

I moved to block 498 to 504. Since they all come actually from the same statute anyway, like, yeah,

# **Legislator Bruno**

I'll second that.

### **Chairman Lopez**

All right. Discussion on block. All in favor.

### **Committee Members**

Aye. Aye. Aye.

### **Chairman Lopez**

On the resolutions move for discussion.

# **Legislator Bruno**

Move it.

# **Legislator Petit**

I'll second.

### **Legislator Lopez**

Discussion. Hearing none. Oh,

# **Legislator Bruno**

No, Legislator Uchitelle just said they're all the same. It's all good. I'm good.

### **Chairman Lopez**

Alright. Well, hearing none all in favor.

#### **Committee Members**

Aye. Aye. Aye.

# **Chairman Lopez**

All right very good. Now, we had and was that new business? Nettie? I don't have that in front of me. I'm missing that. The new business. Let me see.

### **Legislator Uchitelle**

Want me to bring it up Craig?

# **Chairman Lopez**

Yeah, if you could, yeah I

# **Legislator Uchitelle**

Yep. Yep. New Business 2022 noncounty contract agency funding. Consider preparing a list of recommendations based on community needs.

# **Chairman Lopez**

Okay. Nettie you had a lengthy discussion, right with who was it, Amber?

# **Nettie Tomshaw**

Right? She said that this year's budget has a lump sum in it, and then we don't have to address individual needs until next year.

#### **Nettie Tomshaw**

But the chairman of the Ways and Means, John said, Gavaris wanted the committee's to - if you have something in mind to create a list and share it with Amber.

# **Chairman Lopez**

Yeah. So basically, if there's anything that's important to you, you got you want to make sure that, yeah, it gets out there, you know, potentially and into the budget. So create a list and share it.

# **Legislator Criswell**

I may, is this the resolution that we passed that what came out of the Legislative Programs committee asking for the lump sum? Yeah, I just wanted to make sure we were clear on that. And it was actually above what we had requested, if I'm remembering this correctly. Is that right Nettie?

#### **Nettie Tomshaw**

That's what I'm told. I don't know if we know though.

### **Chairman Lopez**

That's yeah, that's what this is in reference to.

# **Legislator Criswell**

Yep. Okay. Thank you.

### **Chairman Lopez**

Okay.

# **Legislator Petit**

So you want us to forward names or is there a proposal that should be attached to that?

#### **Nettie Tomshaw**

I believe John had on like, a list. Like he wanted more, more than just a name, but some information about them?

# **Legislator Lopez**

No, I think a proposal would be helpful. No, definitely more than a name. At least they have something to reference.

#### **Nettie Tomshaw**

If it's somebody that you've already some

#### **Legislator Petit**

Somebody for previous years.

#### **Nettie Tomshaw**

Yeah, they have it on file, but just let them know that you're still interested in those people receiving funds, and trying to find his wording. I can't find it.

### **Chairman Lopez**

I think that's pretty that's explained well. Okay. (inaudible) Very good. Does anybody have anything else to bring?

#### **Nettie Tomshaw**

Craig on the old business, um, Laws and Rules amended, Proposed Local Law No. 6 of 2021.

### **Chairman Lopez**

That's right. That was mostly clerical. There was some language that was clarified. So they had amended it, we had passed it out of our committee, with the idea that it would go through Laws and Rules and that they would adjust whatever had to be done in order to be acceptable. So that was done and they just wanted to let us know, and report back to Health committee that it was taken care of.

#### **Nettie Tomshaw**

You already voted on this last month, but they just wanted heads up that they changed. You know, it's not just school resource officers, they added staff, psychiatrists, clinicians, counselors, mental health, nurse practitioners, to the list. That's all that I

# **Chairman Lopez**

It was just specifics. So yeah. Was there anything else? Anyone else?

# **Legislator Bruno**

I'd like to make a motion for adjournment?

### **Legislator Uchitelle**

I'll second that.

# **Chairman Lopez**

All right very good. Well, it was good seeing everybody. Hope everyone stays healthy. Thank you, Dr. Smith and Commissioner lapoce for joining us.

# **Legislator Uchitelle**

Thank you for being here.

# **Legislator Bruno**

Thank you both.

### **Chairman Lopez**

Of course yeah. All right, Deputy Executive as well. So everybody be well, have a great night.

### **Legislator Uchitelle**

We see Milgrim all the time. But yes, we don't see Mike Iapoce (inaudible)
