Resolution No. 418: Supporting The Requirement Of Certification Or Training And Programs Targeted To Better Serve Individuals With Dyslexia

Resolution Summary: This memorializing resolution sponsored by Legislator Belfiglio supports the Commissioner of Education to prescribe the necessary regulation and establish programs and training related to the needs of children with Dyslexia. Assembly Bill 4330-A and Senate Bill S5439 supports these programs.

The rationale being, minimize employee absenteeism, instill good health practices and onsite convenience for all employees. \$8,997.00 100% County

Resolution No. 430: Approving The Execution Of A Contract In Excess Of \$50,000.00 Entered Into By The County – North American Family Institute Inc. – Department Of Social Services

Resolution Summary: This resolution approves a contract with North American Family Institute Inc., a voluntary foster care agency authorized by the NYS Office of Children and Family Services to provide foster care services. This contract for professional services may not exceed \$3 million dollars. Contract dates 9/1/16 through 6/30/18. 36% Federal, 29% State, 35% County

New Business

Legislator Belfiglio shared with the committee his friend's experience requiring rehab upon release from Vassar Brothers hospital. The man requested his rehab be completed at the Northeast Center in Lake Katrine. He was told his request was denied as there wasn't a bed available and would instead be transferred to Golden Hill. Legislator Belfiglio confirmed the Northeast Center had a room ready and waiting. Legislator Belfiglio wonders how many other families are being misled – expressing patients are just a commodity being cherry picked. Legislator Belfiglio reminded the committee when Golden Hill was sold, the county was assured there would not be cherry picking.

Legislator Allen shared a similar experience with a different hospital, however came away with the impression social worker's try to locate a rehab facility close to the patients home. Legislator Allen expressed uncertainty for their motivation, however noting for-profit facilities try to maximize profits and minimize their liabilities. Legislator Belfiglio plans to research further.
