Resolutions for the November 22, 2016 Session of the Legislature

**Resolution No. 455**: Calling On Governor Andrew M. Cuomo And The State Legislature To Promote And Support Health And Safety Standards In Sober Homes And/Or Addiction Recovery Residences Consistent With National Association Of Recovery Residences (NARR) Standards

**Resolution Summary:** This memorializing resolution sponsored by Legislator Belfiglio calls upon state officials to approve at least one NARR affiliated credentialing entity for the purpose of developing and administering a voluntary certification program for addiction recovery residences in NYS. Also to enact rules and regulations that stipulate that any service provider licensed in NYS shall not refer a current or discharged patient to a recovery residence unless the recovery residence holds a valid certificate of compliance. The resolution also supports the empowerment of the Commissioner of the Office of Alcoholism and Substance Abuse Services to create programs and training necessary in all sober homes and recovery residences.

Also, does his office request information on drug related deaths from medical examiners, coroners, hospitals or other medical professionals, noting our local law enforcement agencies have a database in place gathering information at the suggestion of the Ulster County DA.
