Mr. Crannell noted the program is experimental and this being the second year of the two year grant is still being evaluated. Only a few counties were selected for the program.

Chairman Lopez,

Given the large volume of foster care agency contracts on the agenda for next weeks meeting, I thought I would provide background on these contracts to assist the Committee's discussions. I would appreciate it if you would forward this information to the members of the Committee or any other Legislator that may be interested.

On 12/31/15, we contracted for 112 Ulster County children in foster care. This is down from 131 children contracted for on 12/31/14. This is just a snapshot of that day, but demonstrates an accurate average and trend of this type of placement for the year.

Placement at any foster care facility is based on what program would be the best match for the child (based on therapeutic approach, any diagnoses or special needs of the child, security of the child (24-hour stay-awake staff, etc), and if the facility has any open spots for the child in the specific program. All facilities are non-sectarian regardless of the name of the facility.

The New York State Office of Children and Family Services (NYSOCFS) sets the per diem rate for the various programs provided by the facility and the New York State Education Department sets the tuition rate if the child attends an on-campus school or special school.

NYSOCFS issues the standard contract for all counties to utilize and the Agencies provide the scopes of services to incorporate. The term of the contract is for 2 years. This allows all foster care contracts to be renewed mid-year, spreading out the large contract renewal volume over the year instead of processing these with the year-end renewals. By having the end date in June 2018, foster care renewals are processed in even years, opposite the odd-year, mid-year renewals of Preschool contracts, where there are approximately 100 contracts.

As I mentioned, this is a particular snapshot of placement on 12/31/15. At that time, we had no children at 3 of the listed facilities, including Access, Devereux, and Green Chimneys. However, since January we have placed children at both Devereux and Green Chimneys under their current contracts. While we currently have no children placed at Access, we have advanced the contract at this time because (a) we incur no costs if we are not using the facility, (b) with the contract in place, we maintain contract continuity & maintain their appropriate insurance documents on file, and (c) we are ready to quickly move with a placement if appropriate, avoiding the "place and chase" of trying to contract after the child is already placed.
