Guest Speakers: Three (3) guests were in attendance at the meeting.

1.) Kayse Diamond, ProAct Inc. Communications Coordinator

Ms. Diamond provided a brief program update as well as an overview of the history of ProAct, whereas the county implemented the program in 2010. Kayse provided literature and asked the committee to spread the word about the program to their constituents.

- Program is administered by ProAct, Inc. a Pharmacy Benefit Mgmt. Co.
- ➤ ProAct is a prescription discount card program whereas anyone can participate when their prescriptions are not covered by insurance.

- The program is free of charge to the county and residents.
- ➤ No restrictions or limitations on frequency of use.
- ➤ All medications are covered.
- Completely anonymous
- ➤ Discount Cards are pre-activated and ready to use.
- Average savings on brand name medications is 10-20% & 20-70% generic medications.

2.) Justin Sparks, Pride Of Ulster County Award Recipient

Chairman Lopez presented a Pride of Ulster County Award to Justin Sparks, an eleven year old student from Walker Valley who saved the life of a classmate by performing the Heimlich maneuver. Justin shared with the committee how he helped his classmate dislodge the food from his throat. Justin learned the Heimlich procedure by viewing posters in school and the community. Justin was accompanied by his family and friends.

3.) Linda Rozzi & Ruth Lewis, (CMA) Certified Medical Assistant, (AAMA) American Association of Medical Assistants

Chairman Lopez welcomed both guests who presented a power point with facts about the in and out of state laws that govern their field of employment. Although they are trained and certified to perform a higher level expertise of care, New York State does not recognize some aspects of their formal training, thus minimizing their range of duties and scope to perform certain tasks. Their examination testing covers three major areas, General Medical, Administrative, and Clinical Knowledge. They also noted the need for CMA's are expected to increase 35 percent by 2016 - which is much faster that the average for all occupations in the field of medicine. Linda and Ruth are asking for direction and support on the state and county levels for their scope of practice and certification be fully recognized in the state of New York.

Conversation ensued. Legislators thanked them for their presentation and time however felt it would be best to lobby their local representatives in Albany on the state level. Chairman Lopez and Leg. Belfiglio also referred them to our Health Department – Commissioner Carol Smith, MD. Linda and Ruth also plan to send the bill number along with additional information to Chairman Lopez and Chairman John Parete after further research.

Hi! I have updated the slide show with more information pertinent to our discussion including this information. In most states, medical assisting derives its authority to practice from the state Medical Practice Act and the regulations, policies, and decisions of the state Board of Medical Examiners. Generally, medical assisting is not under the jurisdiction of the state Board of Nursing and the state Nurse Practice Act. Medical assistants are not delegated nursing tasks by RNs and LPNs. They are delegated clinical and administrative tasks by physicians, nurse practitioners, and physician assistants. Also there are about 24,000 medical N.Y.
