## **Motion / Discussion:**

Motion made to open discussion by Legislator Belfiglio, 2<sup>nd</sup> Legislator Litts.

**Discussion:** This contract is for a food stamp employment and training program,

for recipients of supplemental nutritional assistance benefits (food stamps), in accordance with the Food Stamp Act of 1977 and 1985

as amended. This contract services approximately 200 clients.

Chairman Lopez along with Counsel Erica Guerin inquired as to the success rate of the program? Ken Crannell stated the contract measures two levels of employment success, whereas both levels have been met. Ken will see that the report on file with the county

will be made available for committee review.

Chairman Lopez would like to reach out to CEO Francoise Dunefsky, of the Gateway Community to meet with the Health Committee to understand the whole spectrum of the organization. Ken also suggested taking a tour of Gateways facility, either in

Kingston or New Paltz.

Note: Ken Crannell emailed the following additional information. Per Ken, the contract goal is to have 20% of the enrolled participants enter the workforce. For 2013, 119 participants were enrolled in the program, and 32 were employed, which is approximately 28%. Another goal in the contract is to have 40% of participants who are employed to gain more hours or a higher paying position. This is not something that has been tracked, as those referred to the program have typically been unemployed (not

simply under-employed).

**Discussion:** 

Chairman Lopez gave an overview - whereas this contract is per diem foster care & related professional services. The services provided are mandated by New York State and are paid through its Welfare Management System at New York State set rates.

The Jewish Board of Family and Children's Services is a nonprofit corporation who provides residential care and a wide range of treatment services for children in foster care programs. This corporation operates a residential treatment center, group residences and a rapid intervention center. Services include but are not limited to foster care for children with special needs, treatment and programs, professional services, life skills.

Counsel Erica Guerin along with committee members asked Ken Crannell numerous contractual related questions.

- The County currently has no children placed at this facility last time was 2008.
- Contract time frame is on a cycle the county uses this company's service as needed.
- The resolution / contract will provide services for two special need clients for 30 months whereas relocating the children to this facility and provide stability.
- The State "Connections Program" tracks and reports data throughout the entire welfare system utilized as far back as 1997 -1998.
- Extremely regulated reporting- licensed through the State Office of Children's Family Services

• DSS reviews contract for conformance

 State mandate – projecting future funds from the state will most likely be reduced.
