<u>Resolution No. 384</u>: Amending The 2019 – 2024 Capital Improvement Program To Establish Capital Project No. 548 – Department Of Social Services Basement Restoration, And Amending The 2019 Capital Fund Budget – Department Of Public Works

Resolution No. 386: Approving The Execution Of A Contract In Excess Of \$50,000.00 Entered Into By The County – Catholic Charities Of Orange, Sullivan & Ulster – Department Of Social Services

Resolution Summary: This resolution approves the execution of a contract in excess of \$50,000.00 with Catholic Charities of Orange, Sullivan & Ulster Counties to operate a warming center providing warm shelter, meals, and related services for individuals during winter weather emergencies. 100% State \$1,622,000.00, Effective 10/1/2019 - 9/30/2022.

Deputy County Executive Rider provided an overview of the county having a warming shelter for the past handful of years even before the governor created Code Blue (below 32 degree). This contract went out to RFP. Catholic Charities provided the service last winter and did a good job. Catholic Charities is the only agency that provided a proposal this year out of two other agencies that showed interest. This shelter is for individuals that are homeless that won't present for any other social services – however we have an obligation to offer the service. Legislator Petit confirmed the county is currently looking for a preferred location for 2019 offering up to three meals a day, depending on weather/operating hours. Legislator Maloney confirmed the average stay per night last year was between 15-25 individuals and county emergency and law enforcement departments put out announcements when the warming shelter is open.
