Resolution No. 518: Calling Upon The Governor To Sign Legislation Regulating Toxic Chemicals In Children's Products, Protecting Children's Health

Resolution Summary: This memorializing resolution calls upon the Governor to sign legislation regulating toxic chemicals in children's products to protect their health. Assembly Bill A6296A and Senate Bill 501B passed with bipartisan support in the 2019-2020 Legislative Session to amend the Environmental Conservation Law, in relation to the regulation of toxic chemicals in children's products and prohibiting the sale of children's products containing certain dangerous chemicals. No financial impact.

This group incorporates DBT skills into coping with emotional eating or overeating. Participants may be seeking support for Binge Eating Disorder, may struggle with obesity, and/or may be considering bariatric surgery.

Eating Disorder Family Support Group, Wednesdays 6:30 - 8:00pm This professionally led group is for friends and family members of persons with diagnosed eating disorders or persons engaging in disordered eating behaviors.

Facilitators are paid \$50 per hour; approximately \$11,700 per year is allocated as support group funds.

Social workers licensed in New York received 4 free continuing education units (CEUs) for attendance at the 2019 events.




February 25th and March 1st - spoke with 65 students at SUNY New Paltz at a tabling event for Eating Disorder Awareness Week.
