#### New/Old Business

- Legislator Roberts made the request that the record reflect he is a yes on Resolution Nos. 191 and 199.
- Legislator Belfiglio expressed he has been researching what has happened with the Affordable Care Act is that Medicaid has really become managed care. And what used to be determined by the government is now determined by insurance companies. Private health care facilities today are being nickeled and dimed by the managed care programs in New York State. The facilities accept the patient only to be declined payment later for rehab services rendered. The government used to pay the difference and now the managed care insurance companies decide what they will or won't cover based on the federal government's reimbursement to the managed care companies, thus the facilities are stuck with the costs and the patient is denied rehab treatment previously covered.
