Chairman Craig Lopez called the meeting to order at 6:05 PM.

Chairman Lopez thanked Dr. Smith, Ken Crannell and associates for inviting the committee to visit the Mental Health facility to update the committee on current events and county programs.

Northeast Center for Rehabilitation and Brain Injury in Lake Katrine

Legislator Belfiglio introduced JoAnne Liguori and Annmarie Belfiglio with the Northeast Center for Rehabilitation and Brain Injury who provided an update regarding the center's ongoing struggles with Medicaid/Medicare re-imbursements, educating insurance carriers to better understand the needs of their specialized young population and providing a safe environment and safe discharges back into the community. Committee discussion ensued.

<u>Commissioner Dr. Carol Smith, MD, MPH – UC Health and Mental Health Department</u> Dr. Smith thanked the committee for meeting with her staff and proceeded to introduce her mental health leadership team.

The Ulster County Mobile Mental Health Team is operated by <u>Access</u>. Trish Tuber is the Director for Access Supports For Living whose company leases office space at the UC Mental Health Building in Kingston, and is fully integrated with county staff. There is also a second team in Ellenville. Ms. Tuber provided an overview of their mobile mental health team who respond and counsel urgent issues in the community, home and school. They cover suicidal thoughts, emotional trauma, serious mental illness, anxiety, depression and family crisis. Their service includes people who can relate through their own experiences and together make sure plans are carried out.

Amy McCracken, Deputy Commissioner of Mental Health after 28 years of service with the county Amy will be retiring at the end of the month. Dr. Smith thanked Amy for her invaluable service. Tara McDonald will be Amy's successor as Deputy Commissioner of Mental Health.

Kristin Carney Deputy Director for Administration Health/Mental Health is the chief financial officer who manages the department budget including \$7.6 million worth of state contracts under Article 6 qualifications.

Judith Dagirmanjian Local Governmental Unit (LGU) Program Supervisor Children's Services handles the mental health needs of children and adolescents of Ulster County. Ms. Dagirmanjian discussed the SPOA children's program, health homes and Medicaid redesign for children 0-21.

Dr. Smith and Ken Crannell commended the work of the mental health department, depth of experience, credentials and collaboration of the leadership team. Dr. Smith noted each team meets monthly with their contract service providers. Dr. Smith spoke of the challenges they face and greater need for services in our community due to the closure in state health psychiatric facility beds and the stigma associated with mental health people face. The Mental Health division holds presentations throughout the county addressing the opioid crisis, along with the program in its 10th year, the Ulster County SPEAK Coalition - Suicide, Prevention, Education, Awareness, Knowledge. Committee discussion ensued.
