# **Guest Speakers:**

- Richard Engnath, Founder HTLV/XMRV National Registry Mr. Engnath came before the committee requesting a memorializing resolution supporting the publication, testing and education of HTLV viruses, state and nationwide, as both the public and medical community are unaware of this virus as a result patient testing is ordered for the Aids virus and the HTLV virus goes untested and undetected. Mr. Engnath provided a poster covering these types of STD Retroviruses which can lead to Leukemia/Lymphoma. Mr. Engnath has submitted multiple bills to Assemblyman Peter Lopez for his consideration along with Congressman Gibson, and Senator Tkaczyk. Legislator Belfiglio suggested the committee clerk request a copy of the bills sent to state officials. Chairman Craig Lopez thanked Mr. Engnath for his presentation and devotion to this cause, however declined to support a memorializing resolution at this time pending possible bill passage already presented on the state level.
- <u>Ida Gage, Senior Advocate</u> Mrs. Gage wanted to share with the committee her experience with volunteer ambulance corps vs. (ALS) Advanced Life Support Ambulances, and the ongoing double billing seniors are battling statewide. Whereas, unless volunteer ambulances contract to work together with advanced life support companies such as Mobile Life, Medicare will not reimburse a patient when a staffer from Mobile Life with advanced life support capabilities hops aboard a volunteer ambulance vehicle. Mrs. Gage provided the committee with copies of correspondence from US Senator Kirsten E. Gillibrand, Medicare, Ambulance Corps, and articles published in local newspapers. Mrs. Gage went on to say she and many other senior citizens will now only call ALS ambulances and not 911 in an emergency. The alert monitor she wears contacts 911! Chairman Lopez recommended once the EMS Advisory Board is created, to have Mrs. Gage go before that committee as well.
- Thomas Kagen, Concerned Citizen for Safe Talk Tip Line Mr. Kagen returned for a follow up visit with the committee in support of implementing a countywide safe talk tip line for students. Mr. Kagen provided statistics showing (3) years of alcohol, tobacco and other drug use among 11<sup>th</sup> and 12<sup>th</sup> graders. He noted the UC Mental Health Association is willing to take on such a program, whereas they may be able to include other counties in the area. Legislator Belfiglio suggested Mr. Kagen approach school district superintendents with the concept and the creation of the program. Chairman Lopez offered both he and the Chair of the Public Safety Advisory Committee, Legislator Mary Wawro, will have further discussions with Mr. Kagen as to possible program specifics and avenues to implement a tip line.
