Resolution No. 196: Amending The 2019 Ulster County Budget - CHIPS / PAVE NY Funding Adjustment - Department Of Public Works (Highways And Bridges)

Resolution Summary: This resolution amends the 2019 UC Budget for funding adjustments for both the CHIPS and PAVE NY funding decrease, and a 2018 CHIPS budget balance of \$536,669.00 to be rolled over into the 2019 Budget. Funding decrease -\$4700.00

<u>Resolution No. 203</u>: Amending Capital Project No. 519 Ulster County Law Enforcement Center (UCLEC) Energy Upgrades – Amending The 2019 Capital Fund Budget – Department Of Public Works

Resolution Summary: This resolution amends Capital Project No. 519 UCLEC for energy upgrades and professional services for the installation of a natural gas line. 100% County \$242K. A Bond Resolution will be required.

Discussion:

Chair Petit called upon Amanda LaValle to provide an overview of the natural gas line installation.

- The LEC is responsible for 40% of the energy footprint of the County operation.
- The single largest County building 277,000 SF
- 6" gas main to be installed from existing main along Rt. 32 aka Boulevard.
- The County can opt to discontinue gas service with 24hr. notice no commitment.
- Energy master plan for the jail is funded through NYSERTA Clean Energy Communities.
- Immediate need to replace (3) failing boilers, in service since 2006, run 24/7, at end of life.
- Chair Petit confirmed the boiler replacements are under a separate capital project.
- The contractor will conduct a maintenance analysis as to why the boilers useful life was cut in half.
- Consideration how we can meet our emission reduction goal and energy cost savings.
- Expected payback to replace existing fuel oil boiler with a condensing natural gas boiler and adding on the \$220,000 interconnection line cost would be four years, thereby reducing the emissions by 38-40% using the same BTU's produced.

- Legislator Nolan feels it will be at best 3-5 years to implement renewable alternatives including solar thermal for the hot water.
- The County is also pursuing a program "New York Prize" for larger buildings, to assess with the NY Power Authority for geothermal systems. The County has made it through two levels for a conceptual feasibility study for ground source heating systems. A ballpark figure right now to replace boilers for the size of the jail would be \$5 million. Payback is negligible not practical.
- Legislator Greene expressed condensing boilers are the most efficient heating systems now.

• Legislator Nolan for the record stated methane burns cleaner at the source than propane.

Resolution Summary: This resolution authorizes land acquisitions for the River Road drainage project in the Town of Esopus. Although \$431K funding was included in the 2019-2024 Capital Improvement Program, a Capital Project has not been established yet. This project is for the replacement of a deteriorated storm water drainage system. \$26K of design services were paid out of the 2018 operating budget. It is necessary to perform the land acquisitions prior to the construction bidding process. The design has identified the need for (1) temporary easement and (1) permanent easement to construct the project. No financial impact.

Commissioner Jackson explained DPW has high hopes for this Fiber-reinforced, bituminous-membrane surface treatment known as "Fibermat" - a treatment/preventative maintenance product. The county used it once before on New Paltz Rd. and it held up well. This is a spray on application of asphalt emulsion, aggregate and in-place chopped fibers are combined to form a versatile treatment giving the surface an improved tensile strength and resilience. Comm. Jackson anticipates/hopes the product will last seven years, whereas chip seal lasts three to four years. Legislator Fabiano noted in his vast experience, today's products are of poor/inferior quality in comparison to similar products of years past. Legislator Fabiano welcomes trying this new product. Legislator Nolan questioned the safety of using fiberglass in the environment once the particle's start to breakdown/decompose. Comm. Jackson to look into the environmental aspects. Legislator Greene speculated as to the feasibility utilizing crumb rubberized asphalt (used tires). Committee discussion ensued.
