### **Discussion:**

Legislator Nolan noted the community expressed concern about losing the bridge and access to both sides of the bridge and would like to see it preserved, however the NYS Office of Parks, Recreation Historic Preservation has signed off on its removal due to being cost prohibitive – no feasible alternative. Committee discussion ensued. Ulster County owns the bridge, Town of Shandaken owns the road. The Pony Truss bridge built in 1934 has been closed for over 30 years. Catskill Watershed Corp. (CWC) is paying for the removal of the bridge/bridge abutments for safety purposes and to reduce flood heights relative to the community. The town plans on meeting with involved parties in the coming weeks in the hopes a park can be created to connect with the bridge.

#### **Discussion:**

Legislator Greene expressed projects like this should be reviewed by the Trail and Rail Advisory Committee (TRAC). Committee discussion ensued. Deputy Planning Director Chris White shared the project timeline noting the project is already out to bid. The trail will be completed in these sections by July/Aug. the latest, then trail heads will finish up by October. Some of the DEP designs were eliminated such as picnic benches and bike racks to stay within budget. No bonding required. The Woodstock Dike will remain crushed stone, (70) parking spaces, (14) of them dedicated for anglers and hunters. The Shokan Station will be paved, (62) parking spaces, with dedicated spaces for those with permits. The Shokan Station will be more fully developed including future hookups for a sewer line/comfort stations.

Chair Petit confirmed the third trail head will be paved and completed after the DEP replaces the five-arch bridge in Boiceville and railroad bridge that will realign Rt. 28A at the end of November. A dedicated bicycle/pedestrian path will then be linked to Rt. 28. Plans will be made available to the committee over the next 2 weeks.
