## Resolutions for the July 20, 2021 Session of the Legislature

<u>Resolution No. 300</u> - Approving The Work Order With The Dormitory Authority Of The State Of New York (DASNY) For Design And Construction Phase Services For Dewitt Library Emergency Façade Renovations And Senate Gymnasium Roof Feasibility Study Related To The Campus Roofs Capital Project No. 489 – Campus Roofs – Ulster County Community College

Resolution Summary: This resolution approves a work order with (DASNY) for the design and construction phase services for the Dewitt Library emergency façade renovations and Senate Gymnasium roof feasibility study at SUNY Ulster Stone Ridge campus, Capital Project No. 489. \$1,535,000.00 - 50% reimbursable from the NYS dormitory authority.

Resolution Summary: This resolution establishes Capital Project No. 595 for the UC courthouse fascia, exterior repairs and roof replacement. \$200K, A Bond Resolution Will Be Required.

Resolution Summary: This resolution approves the execution of a contract with Lothrop Associates LLP for architectural and engineering design services for the exterior envelope of the Ulster County court house project.

<u>Resolution No. 317</u> - Amending The 2021 Ulster County Budget- CHIPS / PAVE NY/ EWR Funding Adjustment - Department Of Public Works (Highways And Bridges)

Resolution Summary: This resolution amends the 2021 Ulster County budget to include – CHIPS \$720K/ PAVE NY \$137K/ EWR \$80K funding adjustment increase from the state for fiscal year 2021-2022.

Discussion: Don Quesnell provided an overview of funding. The committee asked for a list of roads included in the approximately 8 miles of road to be paved. (Robert Parete forward the information the next day – Hurley Mtn. Rd. (3 miles) and Ulster Landing Rd. (5 miles)

<u>Resolution No. 318</u> - Approving The Execution Of A Contract Amendment For \$85,000.00 Entered Into By The County – Town & Country Bridge And Rail, Inc. – Department Of Public Works

Resolution Summary: This resolution approves the execution of a contract amendment #4 with Town & Country Bridge and Rail, Inc. for increase funding for shotcrete repair services for bridges and culverts.

Motion No. 6: Motion to Discuss & Adopt Resolution No. 318

Discussion: Deputy Exec. Rider and Don Quesnell noted this \$85K is for shotcrete repair on bridges that are red flagged in our capital project for maybe 2-3 bridges this year.

#### New Business –

Deputy County Executive Rider announced the retirement of DPW Commissioner Tom Jackson at the end of this month. The committee thanked Tom and wished him well in retirement. Chairman Fabiano will also be retiring in September after 42 years with the NYS retirement system.

Deputy County Executive Rider also advised there will be a late resolution contract this month with the Coordinated Children's Services for a 1-year extension for janitorial services.

### Old Business -

American Rescue Plan Funding – The committee discussed the UCTC survey of municipality needs. Legislator Litts expressed the CARES ACT - \$34 million does apply to a few infrastructure items on the list such as water and sewer funding and pedestrian infrastructure. Marc Rider noted an infrastructure bill will be coming down with federal funds that may potentially be more appropriate in an infrastructure bill.

Legislator Heppner added the American Rescue Plan Task Force members, David Donaldson, Jonathan Heppner, Ken Ronk, Pat Ryan, Evelyn Wright and Burt Gulnick have discussed the option to have municipalities apply for competitive grant matching funds.

Legislator Greene spoke to four basic principles designed for business that she learned years ago at Kingston hospital called, "The Natural Step For Businesses" that can be applied to help facilitate/consider any business and life issues and would like to make that training available. Committee discussion ensued.
