Dear Mr. White,

We respectfully request a supplemental agreement for out-of-scope work for the above referenced project. Throughout the preliminary design, environmental coordination and right-of-way incidental process, additional information and/or procedures were deemed necessary.

A breakdown for each additional task is below:

Additional Right-of-Way Incidental work:

Our contract with the County included the preparation of taking maps, appraisals and appraisal reviews for 8 parcels that would need to be acquired as part of this project. During the preliminary design phase, it became clear that 12 takings were necessary to progress the preferred alternative. The increase in necessary right-of-way resulted in additional mapping and property owner coordination/meetings. The expanded scope amounts to an additional \$8,550.00 of out-of-pocket costs and approximately \$6,000 of direct costs.

Preparation of and Revisions to the SEQR Long EAF

Our contract with the County assumed that this project would be processed as a SEQR Unlisted Action with Short EAF to be prepared at most. Since that time, the County has reclassified the project to a Type I Action and requiring a Long EAF which required unforeseen coordination with interested agencies. This additional work and coordination amounted to approximately \$4,000.

Additional Record Plan Research and Coordination with Agencies

Our contract assumes revisions to the Design Report from one round of comments from the DOT. The DOT supplied several incomplete reviews, resulting in multiple revisions and submissions of the Design Report. Further, one comment necessitated a level of research on the

ownership of the Albany Avenue and Elmendorf bridges beyond the scope of the project. This additional work and coordination amounted to approximately \$3,000.

Additional Design Features

During the public involvement process, it became clear that the City Officials and members of the public desired the trail to be lit with decorative lighting and stairwells be provided at the Albany Avenue and Elmendorf Bridges. These design features are beyond the scope of the shared-use trail and required additional design time amounting to approximately \$3,000.

Cornell Rail Yard Cleanup

During contract negotiations it was unclear what the long term plan was for the former Cornell Rail Yard. After thorough consideration and discussions with the NYSDEC, the County has elected to remediate the soil at the former Cornell Rail Yard. The additional design work and coordination with our environmental subconsultant will result in approximately \$8,000 of out-of-scope work.

We respectfully request a supplemental agreement for \$32,767.00 to cover the additional services performed and requested. We understand that the County is contemplating leaving an additional 300 feet +/- of railroad tracks in place near I-587 (Colonel Chandler Drive). We consider this change to be minor in nature and will update the project plans accordingly at no additional cost to the County. Further, none of the work to date will be impacted by this change.

RE: Ulster County Midtown Linear Park Resolutions No. 390 and 391

Dear Chair Petit:

I am writing to follow-up questions raised at the Public Works Committee meeting yesterday evening. The Committee questioned the proposed removal of approximately three-hundred (300) feet of existing railroad track located immediately westward of the I-587 Underpass in the City of Kingston for the Midtown Linear Park project (the "subject track"). Currently, the preferred design calls for the removal of the subject track to address public safety concerns in the immediate vicinity of this underpass, which has experienced criminal activities, illegal drug use, trespassing and nuisance activities in recent years.

Removing the subject track with the large railroad box cars and other equipment currently parked on it would eliminate a potential area for people to conceal themselves to trail users, improve visibility for trail users at night, and allow better maintenance and lighting of this sensitive location along the proposed trail. This proposed design is consistent with the Legislature's Rail and Trail Policy pursuant to Resolution No. 488 of 2015. The subject track is also not included in the Permit issued to the Catskill Mountain Railroad, which has used the subject track for equipment storage since at least February 2018 in violation of its Tourist Railroad Permit.

In the interest of moving this project forward in a timely manner, I offered verbally-- and hereby document-- my commitment that if the Legislature as a full body determines that the subject track should be left in place, the Planning Department's engineer will make this minor alteration to the plans for the Midtown Linear Park project. Construction cannot begin until at least spring 2020 and will require additional votes of the Legislature to authorize, so the Legislature would have ample opportunity to examine this matter in more detail and make its determination. I have confirmed with our project engineer that if the Legislature requests this revision from the current proposed design, the effort to complete is minor and would not cost the County any additional funds (please see attached letter from HVEA Engineers).

In light of these concerns being addressed, I would respectfully request that the Public Works Committee reconvene to pass Resolutions No. 390 and 391 so that they may progress to the full Legislature for a vote. As I highlighted, the delay of these resolutions will push back the planned bidding and construction of the Midtown Linear Park project next year, which is under aggressive time deadlines linked to the \$1.5 million federal Transportation Alternatives Program grant funding awarded to the County.

Thank you for your consideration of this matter.

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Planning; and

WHEREAS, pursuant to Resolution No. 503 of 2017, the Ulster County Legislature established Capital Project No. 479 to authorize and fund engineering work for the Ulster County Midtown Linear Park- PIN 8761.82 (the "Project"), and further, the Ulster County Legislature declared its intent to act as Lead Agency for a coordinated review as provided by 6 NYCRR Part 617 of the **New York State Rules and** Regulations, **the regulations** pertaining to Article 8 of the Environmental Conservation Law of New York State ("SEQRA"), **and** determineding that the Project was an Unlisted Action; and

WHEREAS, pursuant to Resolution No. 362 of 2018, the Ulster County Legislature, after conducting a lawfully segmented review under SEQRA for the removal of railroad track from I-587 to Downs Street along the future Midtown Linear Park for purposes of the Interim Public Safety Improvement Project, adopted and issued a Negative Declaration for this action; and

WHEREAS, pursuant to Resolution No. 244 of 2019, the Ulster County Legislature reclassified the Project as a Type 1 Action due to the proximity of several historic properties and again declared its intent to act as Lead Agency for a coordinated review under SEQRA; and

WHEREAS, a full environmental assessment form was completed on June 8, 2019, Ulster County circulated the full Environmental Assessment Form and necessary notifications on July 9, 2019, and, receiving no objections, became Lead Agency 30 days after this date; and

WHEREAS, the Project will provide environmental benefits by removing contaminated soil, debris and hazardous materials from portions of the corridor, improving drainage to avoid erosion and stormwater impacts, providing a much-needed linear park and recreational facility that will primarily benefit low- and moderate- income neighborhoods in an area of the City of Kingston where no parkland or public recreation opportunities exist, providing a valuable expansion of bicycle and pedestrian transportation and access by creating a connection between residential neighborhoods in the City of Kingston and everyday needed services, and increasing public safety by providing a lighted, well used corridor compared to the existing conditions; and

WHEREAS, pursuant to SEQRA, the Ulster County Legislature has considered the significance of the potential environmental impacts of the Project by (a) using the criteria specified in Section 617.7 of the Regulations to identify relevant areas of environmental concern; (b) examining the EAF for the Project, including the facts and conclusions in Parts 1, 2 and 3 of the EAF, together with other available supporting information from its project consultants, interested and involved agencies, and the public, to identify the relevant areas of environmental concern; and (c) thoroughly analyzing the areas of relevant environmental concern; and
