We have a very serious leaking issue in our Vanderlyn Student Life Center, which is leaking into the cafeteria. So our patchwork has met the end of its useful life. So we're working to get DASNY and for an emergency repair. So we're moving this up in the plan.

# **Legislator Cahill**

And so the original estimate was a million dollars less than this now is that why we have to increase it or is this just part of the overall roof replacement capital project?

# **Jamie Capuano**

This is part of the overall five-year Roof Replacement Capital.

Gotcha.

We just need to move this one kind of offense to the agenda at this point.

# **Jamie Capuano**

Yep, so I can guess on this roof, we have not done the feasibility study on yet - we will be doing a feasibility study. This is to really fix an emergency leak situation that's going on. When we do the full roof - this is one of our longest buildings. This is one that we have identified as very, very solar friendly. And we will be doing the feasibility study when we're at the point of complete roof repair. This, again, is an emergency repair for part of the roof that's failed at this point.

# **Legislator Greene**

Thank you for that clarification and also for taking seriously the opportunity to put solar on our roofs. As much as is feasible. I appreciate it.

# Legislator Brian Cahill

Now I got another question. I thought we were done with that. Go ahead.

# Legislator Fabiano

No, my feeling on this is that and I felt this way for quite some time. I'm not against appropriating funds to non-county organizations. But my personal feeling is I don't feel that we should be contributing funds to nonprofit organizations that are already receiving tax dollars or that are in a business, already self-sustaining their finances on their own. I feel that we should only be given these monies to organizations that after they receive this money, it goes directly to people who need it, that are in need like places like Ulster County Community Action, People's Place where directly help people with this money, Family of Woodstock, and like a new thing that we just got here in a town of Saugerties - this nonprofit, it's called the Ryan House. It's a facility we're after your rehab, for alcoholism or drug addiction, you go to this place, it's like a halfway house, you'll stay a period of time from six to 18 months to get your feet on the ground and get yourself a vehicle and maybe a job and find your own apartment. So I really think that, you know, that's where this money should go and know where, where they're already receiving profit of as a business or from tax dollars. That's my view on that. Any old business?

# **Legislator Greene**

I have old business, but I like to just come in on that.

## **Chairman Fabiano**

Okay go ahead Manna.

# **Legislator Greene**

Thank you, that it seems to me this is worth a more in depth discussion. And who did the request come from again?

#### Chairman Fabiano

The Chairman of the Ways and Means Committee for input from us.

#### **Legislator Greene**

So we're already going to be scheduling a joint meeting, and I know that it's gonna be

Probably come up.

#### **Nettie Tomshaw**

That's for the capital projects.

#### **Chairman Fabiano**

Oh, I'm sorry. Yes Nettie yep. Manna Jo I guess he put this request not only to our committee, he sent this request for input from all the committees in the county.

# **Legislator Greene**

Got it. Okay, so if we have a, I would like to know when the meeting that full discussion is. I'd like to hear that discussion and perhaps participate. So I'll just be on the lookout for it. Thank you,

#### Chairman Fabiano

Or check with the chairman and see when he plans on discussing it or at his meeting.

## **Legislator Greene**

Okay, thank you. And, um, I do have a one piece of old business I guess. If you remember, we brought up the issue when we're talking about solar feasibility studies, that we can't do both. We can't put solar on a roof and be part of a community solar project. The community solar project, offsets 100% of the buildings that are participating, but it rules out actual infrastructure being installed on those buildings, and I did ask the legislative attorney to draft either a memorializing resolution or a letter to the appropriate whether it's the Public Service Commission, NYSERDA, etc. And that research is underway. We're trying to figure out exactly what rule it violates where that rests so that we can send it to the appropriate agency. But there was a lot of support from this committee, and I just wanted to update you, it hasn't gone away, it's just taking a little more research. And, you know, we thought it would. And I also want to say that I think we have 15 municipalities in the seven-county region that are undergoing be solar mapping project that is being coordinated with Scenic Hudson, who develop the project, but it wasn't being very well utilized. And it occurred to me that if we could do it as a group, we could learn even more by sharing information and learning from each other. So that is, I think, a really important step to get from planning and calling for, you know, scaling up solar and other renewable infrastructure, to having municipalities really understand where there are opportunities, where those opportunities could be enhanced if there was better grid interconnection, and what areas need to be protected or avoided. And then also how to work with the community to ensure community acceptance. And I want to say that, in Ulster County, Saugerties, has really done a great job. And I remember some of the public sessions before their solar, larger solar projects were approved, there was real opportunity for public input. But I think every municipality can benefit. We'll do this again in the winter, spring and next summer. But it's, it's we're making really good progress. And I just wanted to make folks aware, and there's still room starting October 14th. So if there is a municipality that wants to be part of this first cohort, they're welcome to participate. No resolution, it's informal. But I think it'll be very valuable. And I'll keep you guys posted about our progress.

# **Legislator Cahill**

Thanks. Yeah. So I know that we have a meeting scheduled on October 26th, to go over the capital projects, a joint meeting with Ways and Means and Public Works. But on September 22nd, the chairman of the committee Ways and Means Committee, Chairman Gavaris has also sent a note requesting all the departments review the budgets. And so aside from the capital projects, there is a Public Works budget to review and I was wondering what the plan is to do that outside of the capital projects, we do have one scheduled for that. But I know that for our you know, for Economic Development, we're going to probably have a separate meeting to review the budget for the multiple departments. I was wondering, Dean, if you had a plan to do that for this committee?

#### Chairman Fabiano

I did not. But if you think that that's a good idea. We could schedule a meeting and have hard copies made of the of the budget.

# **Legislator Cahill**

I don't think I need a hard copy. I mean, Amber's sent us everything we needed, right? And all I'm suggesting is that, you know, I think that we should maybe what I'm going to suggest to my committee anyways, to make sure that everybody reviews the budgets for the committee's departments that report through their committee. And if there's anything raised on your personal level to bring it up to the committee, and then maybe go to the department head or to the executive staff and see if they can get it explained, right. So that's what I plan on doing on my committee rather than have seven departments come in and go over every line. Because Yeah, a little bit hairy there. But, but this, this committee has one department. Right. So I didn't know how you wanted to handle that.

## Legislator Fabiano

So we could probably do that on our own. And if they had questions.

# **Legislator Cahill**

I mean, I've just refer everybody to the letter that came from Chairman Gavaris Ways and Means from September 22, and review that, right.

# **Nettie Tomshaw**

May I say something Dean?

## Chairman Fabiano

Excuse me?

# **Nettie Tomshaw**

You do have a meeting on November 3, and that's still before the budget. So if you want to put it as an agenda item.

#### Chairman Fabiano

Yes.

#### **Nettie Tomshaw**

We have all the Public Works directors and everybody here at that meeting, so they can bring up, give an overview.

#### Chairman Fabiano

And the committee members will have an opportunity to look through the budget for that meeting. And that would be like Brian said, the perfect time to ask questions. Have your questions prepared? Right, ready to go. And we could do it under new business or old business, or whatever? That's a good idea Nettie. That's what we'll do.

And any changes in their budget was really valuable. So I appreciate the fact that we'll have an opportunity before we have to vote on the overall budget.

And I just have one more question for Brian. Brian, I need you gonna be around tomorrow. Could I give you a call? I need to discuss a matter with you if it's okay.

That's no problem. Well, you can call me during the day if I if I can't answer I won't. I have meetings but you know if you call Yep. But I'll pick up if you call Dean that's for sure.
