Chairman Fabiano welcomed Legislator Jennifer Schwartz Berky who came before the committee to peak interest and dialogue regarding the creation of an "Open Government Policy", whereas creating a clearer flow of information to decision makers on both sides of the aisle as well as the general public. Legislator Berky expressed her caucus has voiced an interest however, she feels a bi-partisan support is essential. Legislator Berky noted the NYS Governor's office is touting the efforts of Steuben County, NY who has adopted a special initiative for open data, and there are counties all over the country who have implemented open data initiatives. Legislator Berky provided a two page handout with ideas how to get started, and reached out to committee members asking if anyone would like to meet with her offline, working across the aisle to create a transparent, informed and procurement decision-making policy to better measure performance.
