<u>Resolution No. 374</u>: Amending Resolution No. 319 Of 2001, Amending The Policy Of The County Of Ulster With Regard To Project Labor Agreements

Resolution Summary: This resolution amends Resolution No. 319 of 2001 increasing the threshold for an estimated individual construction project from \$1,000,000.00 to \$3,500,000.00 to initiate a Due Diligence Study for Project Labor Agreements (PLA).

Legislator Greene noted the Government Efficiency & Review Committee discussed project labor agreements at their monthly meeting where Marc Rider provided a written summary as to the history and added savings project labor agreements may offer. Legislator Greene also confirmed Mike Ham from IUOE Local 825 was amenable to the increased threshold of \$3,500,000.00.

Marc Rider proposed similar language to be put back in the resolution noting Resolution No. 319, October 11, 2001 stated in the first resolve the department head "shall explore and consider using project labor agreements." Resolution No. 374 would mandate a study be done for every project over \$3,500,000.00 including bridge and road paving projects that only have one or two prime contractors. Each analysis study cost between \$18,000.00 and \$22,000.00. Marc Rider will forward his Project Labor Agreement memo to this committee. The committee postponed the resolution pending additional information.

<u>Resolution No. 348</u>: Approving The Execution Of A Contract Amendment In Excess Of \$50,000.00 Entered Into By The County – C&S Engineers – Department Of Public Works

Resolution Summary: This resolution approves a third contract amendment with C&S Engineers extending the terms of agreement and increasing funds for inspection services related to the replacement of the Bailey Bridge over the east branch of the Neversink. This extension covers the project closeout. 80% Federal, 15% State, 5% County - \$119.8K for a total of \$561.5K 5/1/17-12/31/18

<u>Resolution No. 349</u>: Approving The Execution Of A Contract Amendment In Excess Of \$50,000.00 Entered Into By The County – Complete Building Solutions, Inc. – Department Of Public Works

Resolution Summary: This resolution approves a third contract amendment with Complete Building Solutions, Inc., exercising the first of two one year options extending the terms of the agreement and increasing funding for janitorial services in various County buildings. 100% County \$154.4K for a total of \$593K

Resolution No. 364: Authorizing The Chairman Of The Ulster County Legislature To Execute A Claim For Payment And Any Additional Documents Necessary To Secure Payment From New York State For The Appropriation Of County Property Located In Town Of Wawarsing – New York State Acquisition Map No. 53 Parcel No. 7 – Department Of Public Works

Resolution Summary: This resolution authorizes the Chairman of the UC Legislature to secure a claim for payment on behalf of Ulster County from NYSDOT for the appropriation of county property .234+/- acres in the Town of Wawarsing as part of a statewide program for strengthening the highway network. State Route 55 Bridge crossing the Rondout Creek has been identified as needing extensive repair or replacement in order to protect the bridge from future storms. County Revenue Dollars \$2,350.00

Resolution No. 365: Amending Capital Project No. 260 – Bailey Bridge (BIN 3347090), A Project For The Bridge Replacement On Denning Road Over The East Branch Of The Neversink Creek – Transportation Improvement Project (TIP) Not On The State Highway System – Amending The 2017-2022 Capital Improvement Program – Department Of Public Works (Highways And Bridges)

Resolution Summary: This resolution amends Capital Project No. 260 for increased funding to relocate the existing temporary bridge in order for the project to progress and construction delays due to difficulties in drilling for pile installation resulting in the shut-down of the project during the winter months. Increase in cost \$119K which may be reimbursable up to 80% bringing the total project cost to \$4.2 million. A bond resolution will be required.

<u>Resolution No. 367</u>: Amending Capital Project No. 345-351 – Building Accessibility Upgrade And Renovations (ADA Compliance) – And Amending The 2017-2022 Capital Program – Department Of Public Works (Buildings And Grounds)

Resolution Summary: This resolution amends Capital Project Nos. 345-351 providing ADA compliant building accessibility at various Ulster County buildings making mandated restorations, replacements, and upgrades improving accessibility for disabled persons. A bond resolution will be required.

Old Business

Legislator Greene reminded the committee back in July she expressed the need to better understand the county's compliance with various sustainability policy / initiatives currently in place, such as green storm water infrastructure, pervious paving, green building initiatives, solar, etc. to better evaluate capital projects, their progress and bench marks. Legislator Greene would like to work together to create a check list that goes along with each project to ensure compliance, to be proactive and not allow missed opportunities. Marc Rider noted it's a priority of the administration to support sustainability initiatives and building green practices when possible.

Marc Rider provided a brief update on the two county solar projects. Construction for the land fill project in the Town of Ulster will start in October with operation start up March 2018. The college and Central Hudson are working through some issues with Tesla – previously Solar City and is still in the interconnection study process.

At the request of Legislator Litts Marc Rider provided a brief update on the Solar PV cost benefit feasibility analysis study for the Family Court Facility which was provided to the full legislature; whereas all existing beams would require reinforcement to support an additional 4 psi ballasted solar panel system at a cost of \$80K-\$90K. If implemented concerns were raised regarding schedule delays, temporary relocation of the veterans office and the current lease runs out August 31, 2018. After that the lease agreement would be month to month. The cost savings projected are \$10K over the course of twenty years.

Legislator Greene feels steadfast the county should reconsider strengthening the beams of the new family court facility. Committee discussion ensued.
