Ulster County Legislature to Hold Budget Vote and Five Public Hearings December 10, 2024, Three More on December 17, 2024

(*Kingston, NY*) – The Ulster County Legislature will be holding a Special Legislative Session to vote on the Proposed 2025 Budget and 2025-2030 Capital Improvement Program on December 10, 2024 at 6:00 PM in Legislative Chambers, 6th Floor, County Office Building, 244 Fair Street Kingston. Immediately prior, the Legislature will also be holding five public hearings on a number of topics related to salaries for county workers and consolidating certain departments beginning at 6:00 PM.
